### A BILL FOR AN ACT

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Section 200-9, Hawaii Revised Statutes, is 2 amended by amending subsection (d) to read as follows: 3 "(d) Notwithstanding any limitations on commercial permits 4 for Maui county small boat facilities, vessels engaging in 5 inter-island ferry service within Maui county shall be afforded 6 preferential consideration for ferry landings, including the 7 issuance of a commercial operating permit and the waiver of any 8 applicable fees, at Maui county small boat facilities; provided 9 that: 10 (1)The vessel operator has been issued a certificate of 11 public convenience and necessity for the purpose of 12 engaging in inter-island ferry service that includes a route within Maui county; 13 14 The design and performance characteristics of the (2) 15 vessel will permit safe navigation within the harbor 16 entrance channel and safe docking within Maui county 17 small boat facilities:
