[+(c)] (e) The department may adopt rules or policies 1 2 governing the collection of funds for student meal accounts with 3 a negative fund balance; provided that no rule or policy shall 4 prohibit feeding a student as required pursuant to subsection 5 (b). 6 (f) It is the intent of this section not to jeopardize the 7 receipt of any federal aid and to the extent, and only to the extent necessary to effectuate this intent, the governor may 8 modify the strict provisions of this section, but shall promptly 9 report any such modification with the governor's reasons 10 11 therefor to the next succeeding session of the legislature for 12 review." SECTION 2. Section 302A-405, Hawaii Revised Statutes, is 13 14 amended by amending subsection (a) to read as follows: "(a) [The] Except as provided in section 302A-404(b) and 15 16 (c), the price for school meals shall be set by the department 17 to ensure that moneys received from the sale of the meals shall 18 be [not] no less than one-half of the cost of preparing the 19 meals. The prices for school meals may be adjusted annually based on the previous year's costs rounded to the nearest five 20 cents; provided that the department by rule shall provide a 21

1 lower rate or free meals to children based on their economic

SECTION 3. There is appropriated out of the general 3 revenues of the State of Hawaii the sum of \$ or so 4 5 much thereof as may be necessary for fiscal year 2025-2026 and the same sum or so much thereof as may be necessary for fiscal 6 year 2026-2027 for the total plate costs associated with 7 providing free school breakfasts and lunches in department of 8 education schools as required by this Act after federal funding 9 10 has been accounted.

11 The sums appropriated shall be expended by the department 12 of education for the purposes of this Act.

13 SECTION 4. Statutory material to be repealed is bracketed14 and stricken. New statutory material is underscored.

15 SECTION 5. This Act shall take effect on July 1, 2025.
