RELATING TO DANGEROUS DRUGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 712-1241, Hawaii Revised Statutes, is 2 amended by amending subsection (1) to read as follows: 3 "(1) A person commits the offense of promoting a dangerous 4 drug in the first degree if the person knowingly: 5 Possesses one or more preparations, compounds, mixtures, or substances of an aggregate weight of: 6 (i) One ounce or more, containing methamphetamine, 7 8 heroin, morphine, fentanyl, or cocaine or any of 9 their respective salts, isomers, and salts of 10 isomers; or 11 (ii) One and one-half ounce or more, containing one or 12 more of any of the other dangerous drugs; (b) Distributes: 13 14 Twenty-five or more capsules, tablets, ampules, (i) 15 dosage units, or syrettes containing one or more 16 dangerous drugs; or

6	isomers, and salts of isomers; or	
7	(ii) One-fourth ounce or more, containing any	
8	dangerous drug; or	
9	(c) Distributes any dangerous drug in any amount."	
10	SECTION 3. This Act does not affect rights and duties that	
11	matured, penalties that were incurred, and proceedings that were	
12	begun before its effective date.	
13	SECTION 4. If any provision of this Act, or the	
14	application thereof to any person or circumstance, is held	
15	invalid, the invalidity does not affect other provisions or	
16	applications of the Act that can be given effect without the	
17	invalid provision or application, and to this end the provisions	
18	of this Act are severable.	
19	SECTION 5. New statutory material is underscored.	

1 SECTION 6. This Act shall take effect upon its approval.
