# A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Section 286-26, Hawaii Revised Statutes, is  
2 amended by amending subsection (e) to read as follows:  
3           "(e) Upon application for a certificate of inspection to  
4 be issued for a vehicle or moped, an inspection as prescribed by  
5 the director under subsection (g) shall be conducted on the  
6 vehicle or moped, and if the vehicle or moped is found to be in  
7 a safe operating condition, including adhering to head lamp  
8 requirements and specifications pursuant to section 291-25(a),  
9 as applicable, a certificate of inspection shall be issued upon  
10 payment of a fee to be determined by the director~~[-]~~; provided  
11 that no certificate of inspection shall be issued if the vehicle  
12 or moped is found to have a muffler that has been altered,  
13 installed, or otherwise modified in any way which will  
14 noticeably increase the noise emitted by the motor vehicle or  
15 moped above that emitted by the motor vehicle or moped as  
16 equipped from the factory. The certificate shall state the  
17 effective date, the termination date, the name of the issuing



1 insurance carrier, the policy number of the motor vehicle  
2 insurance identification card for the inspected motor vehicle as  
3 specified by section 431:10C-107 or state the information  
4 contained in the proof of insurance card as specified by section  
5 431:10G-106, and the odometer reading of the vehicle on the date  
6 of inspection. A sticker, authorized by the director, shall be  
7 affixed to the vehicle or moped at the time a certificate of  
8 inspection is issued. An inspection sticker that has been lost,  
9 stolen, or destroyed shall be replaced without reinspection by  
10 the inspection station that issued the original inspection  
11 sticker upon presentation of the current certificate of  
12 inspection; provided that the current certificate of inspection  
13 and inspection sticker shall not have expired at the time the  
14 replacement is requested. The director shall adopt rules to  
15 determine the fee for replacement of lost, stolen, or destroyed  
16 inspection stickers. "

17 SECTION 2. Statutory material to be repealed is bracketed  
18 and stricken. New statutory material is underscored.

19 SECTION 3. This Act shall take effect on July 1, 2025.

**Report Title:**

Mopeds; Motor Vehicles; Mufflers; Certificate of Inspection

**Description:**

Prohibits the issuance of a certificate of inspection for a moped or motor vehicle that has been altered, installed, or otherwise modified in any way which will noticeably increase the noise emitted by the motor vehicle or moped above that emitted by the motor vehicle or moped as equipped from the factory.
