#### A BILL FOR AN ACT

RELATING TO TREATMENT FOR MENTAL ILLNESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) There is established an intensive mobile
- 2 team pilot program within the adult mental health division of
- 3 the department of health to provide intensive mobile team
- 4 services to chronically houseless adult individuals suffering
- 5 from serious brain disorders, including but not limited to
- 6 schizophrenia and schizoaffective disorder.
- 7 (b) The pilot program shall establish one intensive mobile
- 8 team in the community mental health center system.
- 9 (c) The intensive mobile team established for the purposes
- 10 of the pilot program shall:
- 11 (1) Establish criteria for pilot program participation,
- which shall include being houseless and suffering from
- a serious brain disorder, prioritizing individuals
- with schizophrenia or schizoaffective disorder;
- 15 (2) Manage not more than forty participants who shall be
- 16 vetted and enrolled by the intensive mobile team;

1	(3)	Offer after-hours availability for existing
2		participants, including:
3		(A) Responding to crises;
4		(B) Visiting emergency rooms; and
5		(C) If and when participants are arrested, meeting
6		with law enforcement and participants at the
7		receiving desk or similar place where the
8		participant is being held in custody to share
9		information of the participant's participation in
10		the pilot program;
11	(4)	Determine, in collaboration with area hospitals and
12		the behavioral health crisis center, appropriate
13		hospitalizations or behavioral health crisis center
14		admissions;
15	(5)	Prioritize housing placements for participants;
16	(6)	Begin participant treatment on psychiatric medications
17		when appropriate;
18	(7)	Actively pursue assisted community treatment orders
19		when appropriate;
20	(8)	Continue services if a participant is admitted to the
21		Hawaii state hospital;

1	(9)	Engage social work interns and advanced practice
2		registered nurse students to expand service capacity
3		for the target population; and
4	(10)	Bill third-party payors, medicare, or medicaid, as
5		appropriate for services.
6	(d)	The department of health shall collaborate with law
7	enforceme	nt agencies, courts, hospitals, providers who serve
8	houseless	individuals, mental health providers, and community
9	stakehold	ers for the implementation of the pilot program.
10	(e)	The adult mental health division of the department of
11	health sh	all submit a report on the intensive mobile team pilot
12	program t	o the legislature no later than forty days prior to the
13	convening	of the regular sessions of 2026 and 2027. Each report
14	shall inc	lude any proposed legislation and progress updates on
15	the aggre	gate:
16	(1)	Number of participant arrests;

- (2) Number of participants requiring an emergency 17 examination and hospitalization; 18
- Number of participants placed into housing; (3) 19
- Number of participants started on medications; 20 (4)

1	(5)	Number of participants hospitalized at the Hawaii
2		state hospital;
3	(6)	Number of participants reconnected with family; and
4	(7)	Number of assisted community treatment orders pursued
5		and granted.
6	(f)	The intensive mobile team pilot program shall be
7	dissolved	on June 30, 2028.
8	SECT	ION 2. There is appropriated out of the general
9	revenues	of the State of Hawaii the sum of \$1,300,000 or so much
10	thereof as	s may be necessary for fiscal year 2025-2026 and the
11	same sum o	or so much thereof as may be necessary for fiscal year
12	2026-2027	for operating costs and equipment for the intensive
13	mobile tea	am pilot program and the establishment of eight and
14	one-tenth	full-time equivalent (8.1 FTE) positions, including:
15	(1)	One full-time equivalent (1.0 FTE) human services
16		professional V who shall serve as the clinical
17		supervisor;
18	(2)	One-half full-time equivalent (0.5 FTE) psychiatrist;
19	(3)	Five full-time equivalent (5.0 FTE) human services
20		professionals or social workers;

1	(4)	One-half full-time equivalent (0.5 FTE) registered
2		nurse;
3	(5)	One-tenth full-time equivalent (0.1 FTE)
4		epidemiologist, epidemiology specialist, or research
5		statistician; and
6	(6)	One full-time equivalent (1.0 FTE) program specialist.
7	The	sums appropriated shall be expended by the department
8	of health	for the purposes of this Act.
