Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1291, H.D. 2, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO AGRICULTURE,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to expand the offense of false labeling of Hawaii-grown coffee to include roasted coffee.

Your Committee on Conference has amended this measure by:

- (1) Inserting language that imposes a mandatory minimum fine of \$7,500 for each separate offense of false labeling of Hawaii-grown coffee;
- (2) Changing the effective date to July 1, 2025; and

- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.






