Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1391, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO TRADE,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to establish the Hawaii-Ireland Trade Commission within the Department of Business, Economic Development, and Tourism.

Your Committee on Conference has amended this measure by:

- (1) Inserting a general fund appropriation of \$75,000 for the Department of Business, Economic Development, and Tourism to fund out-of-state relations activities; and
- (2) Changing the effective date to July 1, 2025.






