The purpose of this measure is to:

- Establish maximum payment rates for medical care for patients of the Hawaii State Hospital or in the custody of the Director of Health at another psychiatric facility;
- (2) Authorize the Department of Health to establish payment rates for long-term care services for certain types of patients; and
- (3) Exempt the Department of Health's procurement of medical care for certain types of patients from laws regarding contracts to provide health and human services to residents.
