<u>SB 1396, SD3, HD1</u> (HSCR1252) <u>Status</u>

RELATING TO ECONOMIC DEVELOPMENT.

Amends the transient accommodations tax rate beginning on 1/1/2027. Beginning 1/1/2027, requires a \$20 transient accommodation tax to be levied per night for each furnishing of transient accommodations in exchange for points, miles, or other amounts provided through a membership, loyalty, or rewards program. Appropriates funds to DLNR for protection, management, and restoration of the State's natural resources. Effective 7/1/3000. (HD1) EEP, TOU/WAL, FIN
