SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE
NATURAL AREA RESERVES SYSTEM COMMISSION, GUBERNATORIAL NOMINEE,
JAY PENNIMAN, FOR A TERM TO EXPIRE JUNE 30, 2028

The Department of Land and Natural Resources (Department) strongly supports Governor's Message 582 and Mr. Penniman's appointment to continue serving on the Natural Area Reserves System Commission (Commission). Mr. Penniman possesses scientific qualifications, as evidenced by an academic degree, thus fulfilling the Commission membership requirements of Chapter 195-6, Hawai'i Revised Statutes.

Mr. Penniman currently serves as Chair of the Commission. In this governor-appointed role, he also serves as an ex-officio to the Legacy Land Conservation Commission, making valuable contributions to that commission's review and recommendation of grant applications for land acquisitions that would protect resources for public benefit.

Mr. Penniman is a research biologist, an accomplished field scientist, and a skilled communicator. Mr. Penniman has done a lot of work with the Natural Area Reserves System, including surveys for nēnē, research and surveys for Blackburn's sphinx moth, seabird work on O'ahu, Kaho'olawe, Moloka'i, Maui and Lāna'i, and Hawaiian Petrel work. Mr. Penniman is considered an expert on several scientific topics and is an articulate, science-based, respected, knowledgeable, and committed communicator on conservation, Hawaiian biota, and management needs in Hawai'i. He holds a B.S. from Portland State University in Natural Sciences, emphasizing Wildlife Biology and Native American Studies, thus

fulfilling the Commission membership requirements of Section 195-6, Hawai'i Revised Statutes, as an expert in a relevant field.

The Department recommends that the Senate confirm the appointment of Mr. Penniman. Mahalo for the opportunity to testify in support of this nominee.
