Dear Senator Keohokalole and Committee Members:

The purpose of this letter is to recommend Mr. Gary Belcher for reappointment to the position as Public Member of the Hawaii Medical Board. Mr. Belcher has my strongest personal and professional recommendation for reappointment.

I note that I previously recommended Mr. Belcher for his initial appointment in 2021. By all accounts he has served with distinction as a Public Member and in my opinion should be reappointed. His expertise, judgment, and commitment are simply invaluable to the Hawaii Medical Board.

Until December, 2020, I was the Chief Executive Officer and General Counsel of Hawaii Residency Programs, Inc. HRP has employed and trained more than 60% of the resident trainees who have gone on to practice medicine in Hawaii. Every year, HRP sponsored more that 200 MDR or DOSR license applications/renewals before the HMB. I am therefore well acquainted with the requirements for medical licensure in Hawaii and the role of the Hawaii Medical Board in that regard.

I have known Mr. Belcher for more than 27 years. For 17 years of those years, and until his retirement in2020 as the General and Orthopedic Surgery Residency Training Programs

Program Administrator, and Surgical Critical Care Fellowship Program Administrator, I was his senior supervisor.

Mr. Belcher's qualifications are well beyond the ordinary or expected:

<u>Integrity</u>: Mr. Belcher will advocate for, and do, the "right thing" without regard to personal consequences. He listens to others and considers their opinions, but ultimately he will stand firm in matters of accountability to the public as a Board Member.

<u>Good Judgment</u>: During the 17 years that I supervised Mr. Belcher, he was presented with numerous challenges that required him to balance the interests of the Surgery Programs, the individual residents/fellows, the academic and professional concerns, and the employer's concerns. His judgment was flawless. He never compromised, but neither did he insist on an outcome in which he was personally invested. "Do the right thing" were his watchwords.

<u>Expertise</u>: During his tenure as Program Administrator, Mr. Belcher was responsible for overseeing the education of more than 25 residents & fellows each year - most of whom are now practicing in Hawaii. He knew the academic requirements, the accreditation requirements, the interests of the residents, and the interests of the Programs. He was a virtual encyclopedia in that regard. He was our resident expert.

<u>Professional Respect</u>: I employed the Program Administrators for our 17 Resident and Fellows training programs. Most of them were with us for many years because they were prestigious positions that rarely became vacant. Mr. Belcher was the "Senior Statesman" of this elite group of professionals. When a difficult question arose for the group, or for the supervising executives, all eyes turned to Gary to ask "what do you recommend?" And the problem was rarely resolved until he responded.

Above all, Mr. Belcher is simply a gentleman who respects others, listens to others, and decides important questions based on expertise and fundamental fairness. What more could the public desire in its representative to the HMB?
