House Bill 1334, House Draft 1 proposes to exempt the donation of wild game meat, including axis deer, to a charitable, religious, or nonprofit organization to needy persons from specific laws regarding the inspection and transportation of meat. **The Department of Land and Natural Resources (Department) supports this bill and offers the following comments.**

The disposition of game species as regulated by the Department's hunting rules, Hawai'i Administrative Rules Chapters 122 and 123, and the Hawai'i Revised Statutes, only restricts the sale or the offer for sale of any game animal or parts of the carcass of any game animal taken from any public hunting area. The Department supports allowing licensed public hunters the discretion to donate their quarry to charitable, religious, or nonprofit organizations.

While the Department regulates the taking of game animals, it does not oversee the processing or food safety aspects of meat donation. The Department defers to the Department of Health regarding health and safety requirements for donated wild game meat.

Thank you for the opportunity to testify on House Bill 1334 HD1. HB1334 HD1 exempts the donation of wild game meat or meat products, including axis deer, to a charitable, religious, or nonprofit organization to needy people from certain laws regarding the inspection and transportation of meat. The Department supports this measure.

This measure will exempt meat from inspection if the meat is exclusively donated by a hunter for the use or distribution by a charitable, religious, or nonprofit organization to needy people pursuant to Chapter 145 (HRS). The Department supports this measure and will defer to the Hawaii Department of Health as it relates to food.

My name is Robin Kean, and I am the founder of Maui Wild Game Management, an organization dedicated to sustainable wildlife population management and ethical hunting practices in Hawaii. Our mission is to promote responsible wildlife conservation while providing communities with access to high-quality, locally sourced meat. Through humane harvesting methods, we work to balance ecological health with food security, ensuring that Hawaii's natural resources are utilized efficiently and ethically.

Additionally, I have had the privilege of serving as a past director on the Board of Directors for the Maui Food Bank, where I worked to expand food access for vulnerable populations. My experience in both wildlife management and food distribution has provided me with a comprehensive understanding of the challenges we face in feeding our communities while maintaining environmental balance.

I am writing today in strong support of House Bill 1334, which seeks to exempt the donation of wild game meat, including axis deer, to charitable, religious, or nonprofit organizations from

certain inspection and transportation regulations. This legislation provides a practical and necessary solution to two of Hawaii's most pressing issues: environmental degradation and food insecurity.

### Addressing Environmental Challenges

The overpopulation of axis deer has led to devastating ecological damage in Hawaii, including:

Habitat destruction and deforestation

Soil erosion and water contamination

Severe agricultural losses for local farmers

At Maui Wild Game Management, we work with landowners, conservation groups, and local hunters to responsibly harvest axis deer, reducing their negative impact on Hawaii's fragile ecosystems. However, too much of this harvested meat goes to waste due to outdated and unnecessary regulatory barriers. HB 1334 will allow for responsible game management to benefit both our environment and our communities.

By removing unnecessary barriers to donation, HB 1334 will help food banks, shelters, and community programs provide fresh, healthy, and locally sourced meat to those in need. Having worked with Maui Food Bank, I have witnessed firsthand the growing demand for nutritious food options. This bill represents a common-sense solution to help address hunger while supporting sustainable land management.

## Federal Exemptions for Wild Game Donations

Under the Federal Meat Inspection Act (FMIA), wild game meats including venison is already exempt from mandatory federal inspection when donated to charitable organizations. Many states have successfully implemented wild game donation programs under these federal exemptions, demonstrating that these donations can be safely handled and distributed.

HB 1334 would bring Hawaii's policies in line with established federal guidelines, ensuring that much-needed food resources are not discarded due to outdated restrictions.

## Conclusion

House Bill 1334 presents a balanced, sustainable, and community-driven solution to two major issues affecting Hawaii: environmental conservation and food insecurity. This bill allows for the safe, responsible donation of wild game meat, ensuring that our conservation efforts benefit those most in need.

Aloha Chair Takayama, Vice-Chair Keohokapu Lee-Loy, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai'i Farm Bureau supports HB 1334, HD1**, which provides an exemption under Chapter 159, Hawai'i Revised Statutes (HRS), to facilitate the donation of wild game meat—such as axis deer—to charitable, religious, and nonprofit organizations serving those in need.

Across the state, invasive species are wreaking havoc on agriculture and ecosystems. Maui County's axis deer population has grown uncontrollably, fueled by abundant forage after rainfall events. These deer destroy crops and pastures, consuming any available vegetation. Similarly, feral pigs pose a serious threat—not only eating crops but also uprooting and trampling farmland, damaging pasture grasses, and promoting the spread of invasive weeds. They devastate orchards by consuming fruit, citrus, and nuts, while their rooting can kill young trees, shrubs, and vines or spread soil-based fungal diseases. Additionally, feral pigs break irrigation lines, tear agricultural nets, and damage other essential farming equipment.

Beyond agricultural destruction, unchecked feral animal populations create serious risks to livestock, public health, and the environment. As their numbers grow and food sources dwindle, malnutrition weakens them, making them more susceptible to disease. This raises concerns about the spread of livestock diseases, such as bovine tuberculosis, which has already been documented in Moloka'i due to feral pig transmission.

Hawai'i's farmers and ranchers are dedicated to increasing local food production and self-sufficiency, but they cannot succeed if feral animals continue to consume or destroy their crops and livestock. These invasive species cause widespread economic, environmental, and public health damage—threatening native ecosystems, cultural and historic resources, and even the safety of people, pets, and wildlife. Without effective solutions, the costs and consequences will only escalate.

HRS §145D-2 (ACT 54, 2023) already establishes liability protections for individuals and entities donating food in good faith, including wild game meat, ensuring such donations can be made without fear of legal repercussions. However, despite these protections, existing meat inspection and transportation requirements under Chapter 159 have remained a significant barrier to the donation and distribution of wild game. HB 1334 resolves this issue by explicitly exempting the processing, transportation, and donation of wild game meat from these inspection requirements, provided the meat is not mixed with federally regulated meat products and is transported only between approved locations.

This bill increases access to high-quality protein sources for food-insecure individuals and families by enabling more wild game donations. Without this exemption, much of the wild game harvested by hunters goes to waste due to legal restrictions. HB 1334 allows this resource to be put to good use in feeding our community. While HRS §145D-2 provides liability protections, HB 1334 further clarifies the legal framework surrounding wild game donations, eliminating uncertainties that may currently discourage hunters and organizations from participating.

The Hawai'i Farm Bureau urges support of HB 1334 to help mitigate the impact of invasive species while simultaneously addressing food insecurity.

Aloha Chair Takayama, Vice Chair Keohokapu-Lee Soy, and Members of the Committee,

My name is Jackie Keefe and I am a resident of Lahaina. I am testifying **in support of HB1334**.

Currently, there is a grey area when it comes to goodwill meat donation. Hunters are only supposed to donate to "friends and family," and this prevents larger organizations like food banks and churches from receiving these donations as a part of their work to combat food security.

We need HB1334 to pass to protect hunters from liabilities, allow for expanded meat donation, reduce food waste, and protect our 'aina. Food insecurity in Hawaii is significant, especially in Maui and since the August 2023 wildfires. We need to do everything that we can to make venison donation easier. *I also ask everyone to remember that this bill is strictly about meat donation, while expanded meat slaughtering capacity is an entirely seperate issue.*

My one hesitation is that all ungulates are covered under this bill, and there are a couple problems with that. For one, the Federal Meat Inspection Act states that venison *does not* need to be inspected by the USDA for food donation, but that is what the Hawaii DOH currently requires. Second, axis deer do not have the diseases that pigs, sheep, and goats carry.

This bill will also take great strides in addressing the ecological disaster caused by axis deer. They affect ranchers, farmers, and therefore our entire community. The erosion of the 'aina caused by axis deer migration had led to damage to our reefs, as you cannot protect the kai without protecting the 'aina. The way that the DOH currently regulates venison donation limits the ability of hunters who do not have access to a USDA slaughter facility, as the cost burden of having the meat inspected falls on them. Many Maui residents did not realize that the axis deer are truly everywhere now... I've spoken with the Malama Pu'u Kukui crew about the presence of them even on the mauna. Fences don't work. Addressing this crisis is a kako'o thing and the State needs to make the process as simple as possible.

More widespread access to axis deer presents a food security solution in that it is a local, sustainable, healthy source of protein. This bill would allow for Maui to reduce our dependence on imports, which the COVID-19 pandemic made clear is a much greater problem than it is being addressed as. Our people cannot afford to depend on imports any longer.

We need to pass HB1334 to protect the 'aina and feed our people. **Please pass HB1334** through committee and onto the committee on Judiciary & Hawaiian Affairs.

## SUPPORT HB1334 HD1 RELATING TO MEAT DONATION

The Maui Chamber of Commerce **SUPPORTS HB1334 HD1** which exempts the donation of wild game meat, including axis deer, to a charitable, religious, or nonprofit organization to needy persons from certain laws regarding the inspection and transportation of meat.

The Chamber would like to point out that axis deer, an invasive species that poses a continuing threat to Hawaii's environment, could provide significant quantities of meat as a protein source for nonprofit food distribution services, such as the State's network of food banks and Feed My Sheep, Inc. of Maui County. However, there is a gap between the hunters and the retailers and nonprofit services because the meat requires processing prior to distribution. For meat donation, other states such as Wisconsin and Michigan offer models that Hawaii can assess to develop processes for plan implementation and program funding, including licensing fees and other funding sources managed by wildlife agencies or nonprofits.

This bill will be one of a few major tools in controlling the over-population of Axis deer on all islands.

For these reasons we **SUPPORT HB1334 HD1** and respectfully request its passage.
