## In consideration of HOUSE BILL 1427, HOUSE DRAFT 1, SENATE DRAFT 1 RELATING TO AVIAN INFLUENZA

House Bill 1427, House Draft 1, Senate Draft 1 proposes allocating funds to the Departments of Health and Agriculture to prevent, monitor, and respond to avian influenza in Hawai'i. The Department of Land and Natural Resources (Department) supports this measure, provided that its passage does not replace or adversely impact priorities indicated in the Executive Budget request.

Pathogenic avian influenza (HPAI), caused by the H5N1 virus, is a highly contagious disease mainly affecting birds. In November 2024, Hawai'i recorded its first HPAI case in a backyard flock on O'ahu, making it the last state to detect the virus. A migratory bird likely introduced the disease, with the first wild bird case confirmed in a hybrid mallard duck on the North Shore of O'ahu. No additional detections in birds have been reported since these initial cases.

HPAI poses significant risks to poultry and dairy farmers, public health, and Hawai'i's native bird species—many already threatened or endangered. Large-scale die-offs of wild birds, as seen on the mainland, could have serious ecological consequences. The Department supports this measure to ensure necessary funding for monitoring and response efforts that will help mitigate the virus's impact on public health, agriculture, and native wildlife.

**Fiscal Implications:** A proposed budget of approximately \$3,300,000 to \$4,700,000, depending 1 2 upon availability of federal funds, will support the Department of Health's monitoring and response for avian influenza, both in current state and in the event of a larger outbreak in 3 animals or humans. This amount is not inclusive of funding for activities to be carried out by 4 other agencies, but will position the Department of Health for effective collaboration with 5 other state agencies to respond to avian influenza both in animals and in humans. 6 Department Position: The Department of Health ("Department") supports this measure 7 8 offering comments. 9 **Department Testimony:** The Disease Outbreak Control Division (DOCD) provides the following 10 testimony on behalf of the Department of Health in support of the proposed Act which appropriates funds for preventing, monitoring, and responding to avian influenza in Hawaii. The 11 12 recent global health challenges presented by avian influenza underscore the importance of

robust monitoring and surveillance measures to protect Hawaii's public health, industry, unique

14 wildlife, and our agricultural economy.

Avian influenza poses significant risks not only to our bird populations but also to the broader
 agricultural and food industries that contribute to the livelihood of many residents. Hawaii is

particularly vulnerable to the spread of infectious diseases due to its geographic isolation and
unique ecosystems. While current overall risk to humans is low, the potential for the virus to
mutate and cause more severe disease and/or more widespread human-to-human transmission
is a real and present threat.

5 The cost estimate for the response to bird flu detection in November 2024 for DOH was 6 approximately \$190,000. This covered laboratory supplies, personal protective equipment for response staff, staff overtime and the purchase of a small stockpile of oseltamivir to offer to ill 7 8 or exposed persons. These costs were absorbed by budget lines in existing federal awards and 9 program general funds available through salary savings, however, a more sustained response would exceed these budgetary sources. The response also involved staff time during regular 10 business hours with 59 DOH personnel working a total of 4,236 hours to conduct investigations, 11 perform testing, provide communications support and public outreach, and to activate the 12 13 Departmental Emergency Operations Center for incident response and multi-agency 14 coordination.

This Act will ensure that Hawaii has the resources necessary to quickly respond to any 15 outbreaks, animal or human, and minimize the potential for widespread transmission. The 16 17 Department has already taken a One Health Approach (the recognition that the areas of 18 human, animal and environmental health intersect) to this issue, by convening representatives from stakeholders in a weekly status call updating partners on surveillance testing, sharing 19 20 resources, planning response activities, and discussing scenarios where an enhanced response 21 is needed. Heightened awareness of biosecurity and occupational health and safety protocols, 22 along with a robust wastewater and animal surveillance testing program, will protect local 23 farms, safeguard our food production systems, and reduce the risk of the virus spreading within 24 Hawaii. Enhanced monitoring for novel influenza variants in humans will enable early 25 identification and response to cases should they occur in Hawaii, and monitoring of contacts. Timely investigations of cases and clusters of morbidity and mortality events support early 26

- 1 detection goals. In addition, the educational efforts outlined in this Act are essential to
- 2 informing the public about the risks associated with bird flu and the necessary precautions they
- 3 can take to stay safe.
- 4 This Act represents a crucial investment in the health and safety of Hawaii's residents and
- 5 agricultural industry. This legislation will enable proactive steps to prevent, monitor, and
- 6 respond to avian influenza, ultimately safeguarding our state's economy and public health.

Aloha Chair Dela Cruz, Vice-Chair Moriwaki, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai `i Farm Bureau supports HB 1427, HD1, SD1**, which appropriates funds to the Department of Health and the Department of Agriculture to prevent, monitor, and respond to avian influenza in Hawai'i. Given the significant threat that avian influenza poses to Hawai'i's poultry industry, food security, and broader agricultural sector, proactive measures are critical to safeguarding the state's economy and public health.

Avian influenza outbreaks have devastated poultry industries worldwide, leading to the culling of millions of birds, supply chain disruptions, and severe economic losses for farmers. Hawai'i's poultry farms, egg producers, and backyard flocks are vulnerable to the disease, which can spread rapidly and result in severe production declines. Any outbreak in Hawai'i could lead to shortages of locally produced eggs, increased reliance on imported products, and higher prices for consumers.

Beyond poultry production, the spread of avian influenza could have far-reaching effects on Hawai'i's agricultural industry. The disease could impact feed suppliers, processing facilities, and other agricultural operations that rely on poultry production. Additionally, if an outbreak were to occur, strict quarantine measures and trade restrictions could disrupt the movement of agricultural goods, harming farmers and ranchers across the state.

Avian influenza also presents serious public health concerns. While transmission to humans is rare, highly pathogenic strains have the potential to cross species barriers, posing risks to farm workers, veterinarians, and those in close contact with infected birds. Early detection and containment efforts are essential to prevent any potential public

health crisis. The World Health Organization and Centers for Disease Control and Prevention emphasize the importance of monitoring avian influenza strains for potential mutations that could lead to human-to-human transmission. Strengthening surveillance and biosecurity measures will help protect both animal and human health in Hawai<sup>6</sup>.

Funding for prevention, monitoring, and response efforts will help minimize the risk of an outbreak and ensure rapid containment if avian influenza is detected.

We urge the committee to advance HB 1427, HD1, SD1 to protect Hawai'i's poultry industry, maintain food security, safeguard public health, and preserve the state's agricultural economy from the devastating effects of avian influenza.

Chairs Dela Cruz, Vice Chair Moriwaki, and Members of the Committee:

Thank you for the opportunity to testify on House Bill 1427, HD1, SD1. The Hawaii Department of Agriculture (Department) supports the measure. The purpose of HB1427, HD1, SD1 is to appropriate funds to the Department of Health (DOH) and the Department of Agriculture to prevent, monitor, and respond to avian influenza in Hawaii. The Department is collaborating with DOH on avian influenza and additional funds are needed to support ongoing activities. The Department requests that \$293,000 be appropriated to the Department for the purpose of this act including prevention, monitoring, and response to avian influenza. Two (2) of the largest categories of proposed use of funds by the Department are for public outreach through radio and TV and Personal Protective Equipment (PPE) for producers. Those amounts are estimated at \$100,000 and \$150,000 respectively. Enhanced media outreach improves public information and PPE for producers supports increased biosecurity measures on production sites necessary for Highly Pathogenic Avian Influenza. The remainder of \$43,000 is targeted for equipment, supplies, sample shipping, contracts, and other



related expenditures. The department defers to DOH for an appropriation that addresses their needs.

I strongly oppose HB1427 HD1 SD1 relating to the Avian Influenza for the following reasons:

- The Department of Health's testimony has a proposed budget request of \$3,300,000 to \$4,700,000. This appropriation is questionable as the DOH website shares that the risk of avian flu in Hawaii remains low for the general public with the main symptoms of fever, cough, sore throat and conjunctivitis (pink eye).
- The DOH website links to CDC's website for prevention and antiviral treatment of Avian Influenza A viruses in people, including vaccines. It also states that the U.S. government is developing vaccines against avian flu viruses in case they are needed.
- It is noted that an International Bird Flu Summit is scheduled for October 2025 in Vegas with sessions on vaccine development strategies and optimizing vaccine access.

Comments:

I respectfully submit my testimony in opposition to HB1427, which proposes appropriating funds to the Department of Health and Department of Agriculture to address avian influenza in Hawaii. While I recognize the importance of safeguarding public health and agriculture, I have concerns about the bill's financial implications and its potential overlap with existing programs.

First, the proposed funding allocation lacks detailed accountability measures to ensure efficient use of resources. Without clear benchmarks or oversight mechanisms, there is a risk of mismanagement or redundancy with current initiatives already addressing avian influenza.

Second, the bill does not adequately address the economic burden it places on taxpayers. At a time when Hawaii faces pressing issues such as affordable housing, education, and infrastructure, allocating significant funds to this initiative may divert resources from other critical areas.

Lastly, the bill's scope appears overly broad, potentially leading to unnecessary expenditures on low-risk scenarios. A more targeted approach, focusing on high-risk areas and leveraging federal resources, could achieve the same objectives with less financial strain.

I urge the committee to reconsider the bill in its current form and explore alternative strategies that balance public health priorities with fiscal responsibility.

There is NO objective evidence to support the funding of this bill. In fact, there is evidence to defer or return this bill to the committee for the following reasons:

- 1. <u>Low Risk</u>: According to the DOH, Disease Outbreak Control Division, "the current risk to the general public in Hawaii remains low." \*Noted three times on the DOH-DOCD website.
- 2. <u>Burden on Hawaii Taxpayers and no accountability</u>: According to HB1437, it proposes to appropriate funds out of the general revenues of the State of Hawaii the sum of \$ [BLANK] or so much thereof as may be necessary for fiscal year 2025-2026 to carry out the purposes of this Act, including to prevent, monitor, and respond to avian influenza.

While HB1427\_HD1\_SD1 appropriates an unspecified amount of funds to be used, on March 12, 2025, the DOH submitted testimony to the HHS/AEN committee hearing a proposed budget of approximately \$3,300,000 to \$4,700,000, depending upon availability of federal funds.

3. <u>Low Public Health Risk</u>: According to the DOH-DOCD website, there has been one case in Hawaii in November 2024 and one death reported on the continent in January 2025.

According to the DOH-DOCD website, The risk of avian influenza in Hawaii remains <u>low</u> for the general public. Human avian influenza symptoms are similar to those of seasonal flu. Symptoms may vary from mild to severe, and may begin with flu-like symptoms, including fever, cough, and/or sore throat. Recent human H5N1 influenza infections reported in the U.S. have been mild and included conjunctivitis.

# Strongly OPPOSE HB1427, Relating to Avian Influenza

Aloha! My name is Margaret Mejia, and I represent Hawai'i Christian Coalition who has approximately 35,000 members on all Islands and in all districts. When you include spouses and children, Hawai'i Christian Coalition represents about 130,000 people.

We OPPOSE HB1427. Currently, the legislators from the last joint committee hearing (HHS/AEN) are asking for up to 4.7 Million dollars to fund this bill. The committee reported that there was one (1) case of Avian Flu in Central Oahu. Others who testified said that it was one (1) wild bird found in the backyard of a North Shore Resident.

Legislators should ask themselves, "What are the chances that the bird flu came from the U.S. Mainland through a 'wild bird' that landed on the North Shore of Oahu in the backyard of someone who owns birds (chickens)?"

The current federal policy states that when one bird (chicken) contracts bird flu that all the birds in that flock are to be killed. This is the reason that we had an egg shortage, since thousands and even millions of birds were destroyed because of one (1) bird diagnosed with the bird flu. We find this killing of birds through foam depopulation a horrific practice and an extreme measure to take. We find that bird flu is NOT a threat to Hawai'i residents, since bird flu cannot be contracted from human to human. Also, the Department of Health website says that the bird flu in Hawai'i "remains low risk."

Although this bill does not mention vaccines, we can follow the money to discover that the end of passing of this bill may result in our taxpayer dollars going towards vaccines since some people believe that vaccines are a **preventive** measure or a **response** to Avian Influenza. The DOH also confirmed that they stockpiled some Oseltamivir vaccines (normally used for humans with Influenza A and Influenza B) for those who were exposed to the "bird flu detection" in Central Oahu.

During the Biden Administration, we find the U.S. government spent billions on stockpiling pre-pandemic avian flu vaccines and millions have been spent on research and development for mRNA shots. The current shots contain dangerous additives (squalene) and have questionable efficacy.

The five (5) companies that are currently developing Avian Flu Vaccines (Bird Flu Vaccines), all contain mRNA in their vaccines. mRNA is known to cause changes in people's DNA, according to Dr. Robert Malone, M.D., M.S. We are against any taxpayer dollars going towards Bird Flu "preventative measures" and we can't imagine why it would take \$190,000 dollars to respond to one "bird flu detection" in Hawai'i since the current federal policy is to kill the bird and its entire flock. That's some expensive PPE!

Per Jack Lewin's (Governor Green's personal advisor) testimony, it looks as if they are planning another plandemic. They even have a Bird Flu Summit scheduled for October 2025.

We live in Hawai'i. And because we are away from the U.S. Mainland, like Canada and Mexico, we don't have to be a part of the next plandemic.

Regarding liability, the PREP Act protects manufacturers and public health officials (Jack Lewin, Dr. Fink, etc.) from liability for injuries and deaths from the "pandemic" products. Without liability, we should not give the Department of Health, including Dr. Fink, as well as Jack Lewin and his organization any authority. No liability, no authority. In addition, the USDA is using the widely discredited PCR Test to determine which animals have H5N1. The PCR Test frequently gives false positives. Therefore, the numbers, even the small number one (1) in Hawai'i infected with Avian Flu may or may not be accurate.

What are practical solutions? Support the people to make informed decisions. Support the farmers to care for their livestock. Support doctorpatient and farmer-veterinary relationships, as well as **Informed Consent**. Stop the PCR fraud. Since PCR Tests result in too many false positives, and the amplification cycles greatly affect reporting, thereby altering the entire pandemic response.
