Chair Takayama, Marten, Vice Chair Keohokapu-Lee Loy, Olds, and members of the Committee:

The Department of Law Enforcement (DLE) strongly supports House Bill 1462, which expands the Crisis Intervention and Diversion Services Program to include at least two sites on the island of Oahu, including one program in west Oahu.

The establishment of additional crisis intervention sites, particularly in west Oahu, directly aligns with law enforcement goals of providing appropriate responses to individuals experiencing mental health crises. This expansion will create vital access points for diverting individuals with mental health and substance use disorders away from the criminal justice system and toward appropriate healthcare services.

Law enforcement officers frequently encounter individuals in crisis, and having dedicated facilities in strategic locations will significantly enhance our ability to respond effectively to these situations. The addition of a site in west Oahu (96792 postal code)

addresses a critical gap in services for this growing community and provides law enforcement officers with much-needed alternatives to arrest and incarceration when dealing with individuals in crisis.

This program expansion strengthens the collaborative relationship between law enforcement, mental health providers, and the courts, creating a more comprehensive and effective response system for our communities. It supports our ongoing efforts in crisis intervention training and provides our officers with additional resources to fulfill their community-oriented policing responsibilities.

- 1 **Fiscal Implications:** The Department of Health ("Department") respectfully requests the
- 2 addition of an appropriation in this bill to fund a second site.
- 3 **Department Position:** The Department supports the intent of this bill.
- 4 **Department Testimony:** The Adult Mental Health Division (AMHD) provides the following
- 5 testimony on behalf of the Department.
- 6 The Department supports the intent of this measure that seeks to expand Behavioral
- 7 Health Crisis Center (BHCC) services on the island of Oahu.
- 8 BHCCs are an effective response to crisis as they expediently address behavioral or
- 9 substance use disorder crisis in the most trauma-informed and cost-effective way. The
- 10 Department has opened one BHCC to date in Iwilei and is currently considering expansion
- 11 based on community need.

To determine best utilization and cost effectiveness, the Department has engaged with a consultant to assess the current state and provide recommendations for a future state. This includes where and in what configuration BHCCs should be expanded across the State. This assessment is ongoing and the Department anticipates a final report at the end of June 2025. Our consultant, Recovery Innovations, is a national leader in this field and has done work in numerous states, including Alaska, where there are numerous rural and remote areas with geographic challenges.

8 The Department is appreciative of the Legislature's support of BHCCs and looks forward 9 to continuing to work with the Legislature and our community to expand services statewide. 10 The Department notes, however, that additional funds would need to be added to the 11 Department's operating budget to enable continued implementation.

Offered Amendments: The Department respectfully requests the inclusion of an appropriation to support the opening of the second site. The current Iwilei site has a budgeted cost of \$4,288,000 for Fiscal Year 2025 for operations (not inclusive of startup costs) and anticipate an increase in operating costs for Fiscal Year 2026. The Department notes, however, that this site does not include any rental of space costs. Additionally, the configuration of the second site based on location and community need may not be the same as the Iwilei site, and therefore cost may vary significantly.

ALOHA CHAIRs, VICE CHAIRs, AND DISTINGUISHED COMMITTEE MEMBERS. My name is Alan Johnson. I am the current chair of the Hawaii Substance Abuse Coalition (HSAC), a statewide organization for substance use disorder and co-occurring mental health disorder treatment and prevention agencies and recovery-oriented services.

### HSAC Supports HB1462

HSAC agrees that many people who suffer from drugs, alcohol or mental illness and are unstable need **crisis services for stabilization and then, if amendable, refer to treatment** such as "co-occurring" substance abuse and mental health treatment so they can recover from their illness.

HSAC applauds that DOH start two more behavioral crisis centers on Oahu, with one located in Waianae.

- 1. Stabilization is a good first step to then refer to housing with "support services" and/or an evidence-based treatment program.
- 2. To screen, assess, admit for stabilization, and redirect a person to the most appropriate and least restrictive setting available regardless of the person's ability to pay.
- 3. Meet all the criteria for a crisis drop off center.

This idea has strong evidential support across the nation.

The Waianae Coast Comprehensive Health Center (WCCHC) **supports HB 1462**, which expands the Crisis Intervention and Diversion Services Program to establish additional sites on O'ahu, including one in West O'ahu.

Waianae Coast Comprehensive Health Center (WCCHC) is Federally Qualified Health Center dedicated to improving the health and well-being of the West O'ahu community through accessible and affordable medical and traditional healing services, including outreach to people experiencing homelessness, crucial for our community's wellbeing. With 52 years of service, WCCHC remains committed to providing comprehensive healthcare by addressing social determinants of health.

We thank Representative Darius Kila for introducing this bill and the House Committees on Health and Human Services & Homelessness for hearing it. Addressing the ongoing mental health and substance use crisis in our communities requires new approaches, and this measure is an important step in ensuring that crisis services are available where they are needed most.

West O'ahu faces significant challenges, with a disproportionate number of individuals struggling with mental health conditions, substance use disorders, and homelessness. The need for crisis intervention services is urgent, particularly in the Wai'anae Coast, where unsheltered individuals often have access to limited resources. By establishing crisis intervention and diversion site in the 96792 zip code, this bill would create an essential access point for individuals in crisis, reducing unnecessary interactions with law enforcement and emergency rooms while directing individuals toward appropriate care.

We recommend the passage of HB 1462 to expand these critical services and improve outcomes for individuals in need.

Comments:

I stand in strong support of HB1462, I wanted to help develop the City and County's CORE program, but at the time they only serviced Chinatown & Makiki areas with about 130 individuals under Ian Santee. But since then, I have seen the CORE ambulence had reached Ewa that will really need their services in West Oahu.

I had applied for HPD 911 Operator, but their training session was poorly organized, since it set up in September on Aloha Festivals Parade day, and the pre-test was too antiquated or showed utilities repair which Hawaii didn't have at the time using models from the continent. HPD trainers didn't realize that in Hawaii being a multicultural nation from both East and Western civilizations, we have far better talents with lived experiences than states that have only 2 main cultures. Besides I had passed the 911 exam about 2010, when I wanted to volunteer under my Professor/Doctor/HPD Chief Louis Kealoha! He improved the system with his 10-year plan when he applied as Police Chief, which no one had ever done before and is not widely publicized! If it wasn't for Chief Kealoha, the best professor I had at Chaminade University, I wouldn't have dropped all my advocating for behavioral health and concentrated on getting my Masters of Criminal Justice Administration. His staff also had to do my lifetime of issues dealing with any criminal activity because of the erroneous diagnosis placed on me by the medical profession since 1986, after I left my employment at nonunion Robert's Hawaii Tours, paying all their 6 company bills under comptroller, now President Roy Pfund. From 2000-2010, as a SAMHSA Consultant in Washington DC, a national and state Consumer Executive Council Committee member of NAMI, Hawaii Chapter President of USPRA (U.S. Psychiatric Rehabilitation Association, now called PRA), and state trainer/coordinator for the Hawaii Certified Peer Specialists trained in Hawaii, Georgia, and Michigan for the Veterans of the Pacific under Tom Hester, MD, Chief of Adult Mental Health Division/DOH.

Some of you may recall how Dr. Hester turned our state from the worst (51st Best) in the nation under federal mandate improved our Hawaii State Hospital with the Community Plan and Judge Ezra and created great programs working with the University of Hawaii's RCUH Mental Health Services, Research, Evaluation, & Training (MHSRET), which brought in an \$11.2 million under the Mental Health Transformation State Infrastructure Grant (MHTSIG) 1 of 9 in the nation, after I testified in 2005 at Rockville, MD in front of SAMHSA CMHS National Advisory Council on my experiences here in Hawaii. They didn't realize that Hawaii was so advanced as an island state. Last year's January visit by NAMI National's Executive Director, Daniel Gillison showed how the organizations such as Mental Health America-Hawaii and NAMI-Hawaii can work together being in so close proximity. This month NAMI Hawaii has released their new

program's which I wasn't able to complete when I brought in their signature program, In Our Own Voice in 2004 when I got hired by AMHD. I am so glad that the CIT program will begin soon to expand the services offered by law enforcement to those that have behavioral health challenges and hopefully the improvement support line of 988, formerly the Access Line Dr. Hester created along with Steve Balcom and Ms. Danielson employed by AMHD!

Since becoming the most improved state in the nation by NAMI in 2006 and Dr. Hester departure from the islands in 2008, everything that he created under the Federal Mandate has since deteriorated such as the Hawaii Certified Peer Specialist program, the only successful program that came out of AMHD, where higher management were blocking the progress reports of the program and claimed they were unable to read the reports created by MHSRET lead by A. Michael Wylie, my immediate supervisor. DOH closed MHSRET and our office in Kaimuki with grad students such as Tia Roberts, because I was told by Wylie that everyone was jealous that I had my own office as someone with a mental health condition.

I worked out of home after I did my last 2-week certification/training in Hilo and had more than 150+ HCPS. I was unable to get the support of HGEA, as an exempt employee, and had to return to DOH Kinau Hale. Although I was given a mediation attempt with the Mediation of the Pacific, I was not advised that I could have someone from HGEA, MP sided with my supervisors and staff, against myself. I was unable to get any assistance from EEOC or any advocacy agency. I was placed back under the Office of Consumer Affairs, with no special accommodations by then supervisor William Lennox and director Karen Krahn and had to work with men formerly from the East Coast who had me doing their work, as the local girl, as well as the HCPS program and support the consumers in Hawaii along with a waiting list for the next training. Within a month, January 29, 2009 due to budget cuts under Governor Lingle's administration due to the collapse of the national economy, I was terminated from my position.

Since then I acquired my Masters degree in 2011, bu had turned down an offer to start up a Home for those with mental health and substance use challenges by Mark Chandler of Housing & Urban Development.
