House Bill 307 HD1 authorizes the Director of Finance to issue a special number plate for registered owner's vehicle commemorating the Island of Kaho'olawe. The Kaho'olawe Island Reserve Commission (KIRC) strongly supports this measure.

The intent of this measure is to commemorate the struggle and efforts relating to the return, cleanup and continuing restoration of the Island of Kahoolawe. This measure brings a daily reminder of the sacrifices made by the people of Hawaii to protest the bombing of Kaho'olawe and the efforts made by our leaders to get the island returned to the State of Hawaii. This measure also provides a continuing reminder and funding that the efforts are still not completed to heal the devastation done in the past and that the work continues for future generations.

We are Olan Leimomi Fisher and Kevin Chang, Kua'āina Advocate and Executive Director, respectively, testifying on behalf of [Kua'āina Ulu 'Auamo \(or KUA\)](#). "Kua'āina Ulu 'Auamo" stands for "grassroots growing through shared responsibility," and our acronym "KUA" means "backbone." **Our mission is to connect and empower communities to improve their quality of life through the collective care for their biocultural (natural and cultural) heritage, serving as a "backbone organization" that supports creative and community-driven solutions to problems stemming from environmental degradation.** Hawai'i's biocultural resources continue to be negatively impacted by political, economic, and social changes, and the increasing dangers of climate change make fostering and empowering resilient communities acutely critical.

Currently KUA supports three major networks of: (1) over 40 mālama 'āina (caring for our 'āina or "that which feeds") community groups collectively referred to as E Alu Pū (moving forward together); (2) over 60 loko i'a (fishpond aquaculture systems unique to Hawai'i) and wai 'ōpae (anchialine pool systems) sites in varying stages of restoration and development, with numerous caretakers, stakeholders, and volunteers known as the Hui Mālama Loko I'a ("caretakers of fishponds"); and (3) the Limu Hui made up of over 50 loea (traditional experts) and practitioners in all things "limu" or locally-grown "seaweed." **Our shared vision is to once again experience what our kūpuna (ancestors) referred to as 'ĀINA MOMONA – abundant and healthy ecological systems that sustain our community resilience and well-being.**

**KUA supports HB307 HD1 as an incremental step towards 'āina momona.**

This bill would create a special license plate to recognize and raise funds needed to help our Hawai'i community fulfill the collective promise and obligation to heal Kaho'olawe. Funds raised would go into the Kohe Mālamalama o Kanaloa Protect Kaho'olawe Fund. A new and cherished member of our E Alu Pū network is the Protect Kaho'olawe 'Ohana (PKO), long time champion and steward of Kaho'olawe.

A primary function of KUA includes support for the development of an 'auwai, or a system of resources, tools, bridges, relationships, and networks that cultivate and elevate our communities' efforts to greater levels of collective impact in the care of our biocultural resources. A core catalyst for the flow in this 'auwai includes increasing necessary resources and pathways for community-led efforts helping to manage and regenerate the condition of the 'āina that sustains us. **We trust that a share of the resources generated from this special license plate will go to support some of PKO's efforts which are core to connecting our broader community with understanding the importance and sacredness of Kaho'olawe.**

The communities we work with are committed to ensuring the long-term health of our biocultural resources that they have cared for and depended on for generations since time immemorial. **We believe our environment, the foundation of our very existence, is about long-term investment and a vision of ‘āina momona.** To get there requires taking the steps necessary for greater self-sufficiency, development of new and more innovative career pathways, mindsets, relationships, and resources for mālama ‘āina efforts that encourage and build upon the time-tested techniques of our ancestors in Hawai‘i. Passing this bill out of your committee will open an essential ‘auwai system toward reaching this vision.

Aloha Chair Yamashita, Vice Chair Takenouchi, and Members of the Committee on Finance,

On behalf of our over 20,000 members and supporters, the Sierra Club of Hawai'i **SUPPORTS HB307 HD1**, which would create a special number plate in recognition of Kaho'olawe, thereby reminding us of the lessons the island has taught and continues to teach us about our kuleana to these islands we call home.

Fifty years ago, the "Kaho'olawe 9" landed on Kaho'olawe as it was being actively bombed as target practice by the United States Navy. Through their bravery and defiance, the "Kaho'olawe 9" exemplified aloha 'āina, and their stand not only led to the eventual relinquishment of Kaho'olawe to the state of Hawai'i, but also catalyzed what is now referred to as the "Hawaiian Renaissance," resulting in transformative changes to our legal, cultural, and social landscape.

The story of Kaho'olawe holds many lessons of continued and particular relevance today. Its long history of mismanagement and abuse, the sacrifices made by the "Kaho'olawe 9" to stop its desecration, and the damage it continues to suffer from all remind us of the costs we and our future generations must bear when we do not uphold our responsibilities of reciprocity and care for the 'āina that sustains and nurtures us. The successes of the "Kaho'olawe 9" and the Protect Kaho'olawe 'Ohana against the United States Navy in securing the return of Kaho'olawe also gives us inspiration and hope, that a deep and steadfast love for our islands can, in fact, triumph over the greatest of odds. The community-led actions and efforts that ended the bombing of Kaho'olawe, and that continue to clean-up and heal the land, also remind us of the importance of grassroots voices and leadership in ensuring the proper stewardship of our Hawai'i nei – a lesson that we must continue to hold close, as we navigate the ongoing Red Hill water crisis, and as we contemplate the true costs of military live fire training and other activities from Ka'ula, to Pu'uloa, to Mākua, to Pōhakuloa.

Accordingly, the Sierra Club of Hawai'i supports this bill as a means of not only recognizing Kaho'olawe and sustaining the work of the Protect Kaho'olawe 'Ohana, but



as a way to also remind our communities of the critical lessons that Kaho'olawe taught and continues to teach us – lessons that we must remember now perhaps more than ever before.

Therefore, the Sierra Club of Hawai'i respectfully urges the Committee to **PASS** this measure. Mahalo nui for the opportunity to testify.

Aloha Chair Yamashita, Vice Chair, Takenouchi, and members of the Finance committee. My name is Kaulu Lu‘uwai, and I am testifying on behalf of the Protect Kaho‘olawe ‘Ohana in strong support of HB 307 Relating to Special Number Plates to recognize the island of Kaho‘olawe and the Aloha ‘Āina movement that it inspired.

January 4, 2026 will mark the 50th year since nine individuals landed on the island of Kaho‘olawe to draw attention to the injustices and discrimination experienced by Native Hawaiians and were unexpectedly astounded and deeply moved by the abuse and destruction that they witnessed of a fragile, starkly beautiful and spiritually powerful island. This gave rise to the organization of the Protect Kaho‘olawe ‘Ohana and its fiscal non-profit charitable entity, Kohe Mālamalama o Kanaloa Protect Kaho‘olawe Fund (‘Ohana).

A civil suit, *Aluli v Brown*, filed by the ‘Ohana in 1976 led to a court-mandated Consent Decree in 1980 under which the Protect Kaho‘olawe ‘Ohana was recognized as a steward working for the restoration of the island; was provided access, with volunteers, to engage in spiritual, cultural and educational activities; and began to jointly govern the island with the U.S. Navy. In 1977, the ‘Ohana lost two members, George Helm and Kimo Mitchell were lost at sea in the waters off of Kaho‘olawe during a protest of the bombing.

On October 22, 1990 the bombing of the island was stopped by U.S. President George H.W. Bush and all military use of the island was terminated by the U.S. Congress in 1993 under Title X of the 1994 Department of Defense Appropriations Act, which authorized the conveyance of Kaho‘olawe and its surrounding waters to the State of Hawai‘i and also authorized \$400 million for ordnance removal.

The ordnance removal program ended in 2004. The State of Hawai‘i manages the island through the Kaho‘olawe Island Reserve Commission under HRS 6K, established in July 1993 in partnership with the Protect Kaho‘olawe ‘Ohana and Kohe Mālamalama o Kanaloa Protect Kaho‘olawe Fund.

Kaho‘olawe has become a model of co-stewardship of Hawaiian ancestral lands by community groups working together with the Department of Land and Natural Resources. Kaho‘olawe is an iconic symbol of Aloha ‘Āina - the recognition and acceptance of generations of Native Hawaiians since 1976 of the kuleana/responsibility to love, care for and respect our precious islands and restore Hawai‘i sovereignty. Kaho‘olawe was the piko/catalyst for the dynamic cultural renaissance of Hawaiian hula, language, arts nationalism and pride that began in the 1970s and prevails today, almost 50 years later.

Our ‘Ohana recommends and supports special number plates for Kaho‘olawe in order to:

- encourage awareness about the injustices endured by Kaho‘olawe and Native Hawaiians and how Kaho'olawe's cultural and natural resources and Hawaiian cultural and spiritual practices were restored through longterm (50-years) commitment, sacrifice, dedication, and constancy by generations of Native Hawaiians and those who call Hawai‘i home;
- educate the general public about how the sacred nature of the island of Kaho‘olawe as well as other sacred places in Hawai‘i are able to be revived and protected through dedicated volunteer co-stewardship and the acknowledgement and revitalization of Native Hawaiian ancestral knowledge and related cultural and spiritual practices, as protected under the Hawai‘i State Constitution (Article XII. Section 7);
- acknowledge the efforts, work, ingenuity and lives that have been given in the pursuit of the protection of Native Hawaiian lands, people and Hawai‘i sovereignty; and

- connect the broader community with the mission of Kaho‘olawe's cultural and environmental recovery and serve as a reminder of the strength of collective action.

Having a Kaho‘olawe special number plate is a fitting tribute to the decades-long efforts of the Protect Kahoolawe ‘Ohana and all those in the broader community who have contributed to and benefitted from this important Kaho‘olawe Alohaa‘Āina movement.

Importantly, the proceeds from the sale of these plates will directly benefit the Protect Kahoolawe ‘Ohana, further supporting the important work collectively conducted in safeguarding and preserving the island for future generations. In celebration of 50 years since the first landings, this special number plate will provide a lasting legacy of commitment to Kaho‘olawe’s healing and stewardship. Here is a possible design for the plate:



We have started a petition for supporters to demonstrate their support. As of Monday February 17, 2025, we have 364 signers among whom 314 have indicated that they are interested in ordering a

1. Download and Complete the [application form](#).
2. Visit any satellite city hall.
3. Surrender your current Certificate of Registration and License Plates for your vehicle.
4. The initial cost is **\$35.50**. After that, the **annual** renewal fee is **\$25**. The organization receives **\$20** with each payment.



### Hawaii Specialty License Plates

The Polynesian Voyaging Society, Haleakala National Park and Hawaii Volcanoes National Park license plates are available to provide monetary support for these programs.
