- 1 Department Testimony: Department Testimony: The Department of Health (DOH) supports
- 2 the intent of HB1179 but defers to the Department of Education on implementation and
- 3 workforce details.
- 4 Later school start times have been shown to offer a variety of benefits for students, both
- 5 academically and physically such as improved sleep quality and duration as later start times
- 6 allow students to get more rest, which can help with cognitive function, mood, and overall
- 7 health.
- 8 Adequate sleep leads to better focus, memory, and retention. Students who are well-rested are
- 9 more likely to perform better in school, particularly in subjects that require concentration and
- 10 critical thinking. Conversely, lack of sleep is linked to higher levels of stress, anxiety, and
- 11 depression in students.
- 12 Teens experience a shift in their circadian rhythm during adolescence, making it naturally harder
- for them to fall asleep early. Later start times help align school schedules with their biological
- clocks, leading to more restful sleep patterns. With more time in the morning, students are less
- likely to be late or absent from school, which can lead to improved attendance rates and better
- 16 educational outcomes.

- 1 Implementing later school start times can be a win-win, especially when considering the long-
- 2 term effects on student health, well-being, and academic success.
- 3 Nevertheless, DOH recognizes the tremendous adjustment required of school staff, parents, and
- 4 communities from this proposal, but urges the conversation to continue.

Bill Title: HB 0333 RELATING TO EDUCATION.

Purpose of Bill: Beginning with the - school year, requires public elementary, middle, and high

school classes to start no earlier than 8:30 a.m. Requires the Department of Education to adjust state-provided bus and school meal schedules accordingly.

#### **Department's Position:**

The Hawaii State Department of Education (Department) respectfully provides comments on HB 333.

The bell schedule for each school is determined at the school level via a collaborative process led by the school administration, which involves all active bargaining unit members at the school. A compliant bell schedule must meet criteria set forth in Chapter 302A-251, Hawaii Revised Statutes, and the Hawaii State Teachers Association Bargaining Unit 5 (teachers) collective bargaining contract. The statute and contract outline limits on categories such as student instruction minutes, lunch minutes, teacher prep time, and other categories such as meetings.

Schools conduct an annual review of their bell schedule for the following school year via their annual school academic plan submission. Each school's bell schedule is different as some of the factors that schools consider when making their bell schedule include:

- Instructional design of curriculum and learning opportunities;
- Parental or guardian work schedules;
- Traffic and student transportation issues;
- Extracurricular activities, including after-school sports, clubs, lessons, and after-school care;
- Academic performance; and
- Alignment with neighboring schools.

Schools are best positioned to design flexible schedules that meet their unique needs and

characteristics. Restricting school start times will limit schools' options.

Chair Woodson, Vice Chair La Chica, and Members of the Committee:

The United Public Workers, AFSCME Local 646, AFL-CIO ("UPW") is the exclusive bargaining representative for approximately 14,000 public employees, which includes blue collar, non-supervisory employees in Bargaining Unit 1 and institutional, health, and correctional employees in Bargaining Unit 10, in the State of Hawaii and various counties.

UPW provides <u>comments</u> on HB333, which mandates that beginning with a yet to be determined school year, all public elementary, middle, and high school classes start no earlier than 8:30 a.m. This bill also requires the Department of Education ("DOE") to adjust state-provided bus and school meal schedules accordingly

As the committee is aware, most public employees begin the workday at 7:45 am or earlier. Should school classes start no earlier than 8:30 a.m., this could prove problematic for working families who may not have flexible work schedules nor the family support (e.g., grandparents) required to adjust to later a start time.

This issue would be more apparent for families with elementary school-aged children. While this bill proposes moving the start time a mere thirty-five minutes, this seemingly short amount of time could have a significant impact on drop-off schedules as each school establishes its own procedures. Thirty-five minutes can make a substantial difference when trying to get to work on time. We hope the committee will keep this in mind should it decide to pass this measure.

Additionally, should this measure pass, we would like to remind the DOE that work schedules are subject to collective bargaining, and that any changes to meal schedules would require consultation with the union.
