In consideration of HOUSE BILL 347 RELATING TO GOATS

House Bill 347 prohibits the Department of Land and Natural Resources from establishing or implementing bag limits for goats in public hunting areas. The Department of Land and Natural Resources (Department) acknowledges the intent of this bill and offers the following comments.

The Department is responsible for creating, maintaining, and managing public hunting opportunities as both a recreational resource and a management tool for game species populations. Public hunting provides an opportunity to reduce game species' impacts on native landscapes and can be a food resource for subsistence hunters.

The removal of bag limits for goats in public hunting areas removes one tool in the Department's management toolbox for managing a hunting program. Removing bag limits for goats is one way to control their population, but extending open hunting days to seven days a week is the Department's preferred approach. Data indicates that extending hunting days increases hunter effort and take on a sustainable basis and that bag limits are not the limiting factor as hunters can only take so many animals a day. This strategy gives hunters more opportunities while managing the goat population effectively and minimizing ecological damage.

My name is Christopher D. Thomas. I am an avid hunter, and a registered State of Hawaii gun owner. I do not support HB347; the legislation is overbroad and over-reaching. The legislation is reversible only by subsequent legislative action. The Bill also supersedes the authority of the DLNR to effectively manage game populations in Hawai'i.

I have no doubt that Goat populations in the County of Hawai'i are out of control; I have witnessed the danger they pose. However, an effectively managed hunting protocol, to include eradication or incentive hunts, is a better way to effectively manage this problem

The proposed legislation seems to indicate that the law removes, forevermore, the ability of the DLNR to set bag limits on a certain species. Would it not be more prudent to authorize the DLNR professionals responsible for game management to set reasonable (or temporarily remove) bag limits based upon changing conditions in the environment? Hypothetically, environmental conditions could change (disease, drought, hunting) that could effectively decimate a species' population, on any island. If bag limits are void, DLNR lacks the ability to then limit hunting to rehabilitate the population. The Bill does not seek to eliminate all Goats; only manage them.

Bag limits and population of game species should follow the direction of wildlife biologists and environmental experts; rather than being controlled by legislative action. Bag limits are established and regulated by wildlife management authorities to ensure the sustainable and responsible harvest of wildlife populations. These limits are set based on scientific assessments of the species' population dynamics, reproductive rates, and overall health of the ecosystem. Wildlife biologists and ecologists regularly assess the health of species and ecosystems, providing vital data that informs bag limit regulations. This should remain the case in Hawai'i.

Please consider alternatives to game management and vote against HB347. Rather, mandate the DLNR to devote efforts to effectively study and manage game populations consistently.

Testimony in Opposition to the Removal of Bag Limits for Goats in Hawaii

Aloha Chair and Members of the Committee,

I strongly oppose any measure that prohibits the Department of Land and Natural Resources (DLNR) from establishing or implementing bag limits for goats in public hunting areas. Maintaining reasonable bag limits is essential to balancing ecological health, cultural practices, and responsible wildlife management. Goats provide several benefits to the Mauna Kea area when their populations are properly managed. Hereâ€TMs why keeping bag limits in place is critical:

1. Goats Help Reduce Wildfire Risks

Invasive grasses, such as fountain grass, pose a major wildfire threat in dry environments like Mauna Kea. When managed sustainably, goat populations contribute to natural vegetation control, reducing the density of these fire-prone grasses. Completely eliminating bag limits could lead to overhunting, disrupting this ecological service and increasing the risk of large-scale wildfires that threaten native forests and communities.

2. Goats Support Sustainable Hunting and Food Security

Hunting is an important resource for many local families, providing a sustainable source of food. If unlimited hunting is allowed without regulation, goat populations could decline to

unsustainable levels, impacting subsistence hunters who rely on them. Bag limits help ensure long-term availability of this resource for future generations while still allowing responsible population control.

3. Maintaining Balance in the Ecosystem

While overpopulation of goats can damage native forests, responsible management is key. Goats play a role in maintaining open landscapes that support endangered bird species, such as the palila, by preventing the overgrowth of invasive shrubs that compete with native ma'amane trees. Allowing unrestricted hunting could cause population crashes, leading to unintended consequences for these fragile ecosystems.

For these reasons, I urge you to oppose the removal of bag limits and instead support scientifically guided wildlife management that ensures a balance between conservation, hunting traditions, and ecosystem stability. Mahalo for your time and consideration.
