Thank you for the opportunity to testify on this bill. The Campaign Spending Commission (“Commission”) supports the intent of this bill as we agree that the partial public funding program should be boosted, but we have strong concerns regarding funding. Presently, there are insufficient funds in the Hawaii Election Campaign Fund (“HECF”) to run the program as proposed under this bill and an appropriation is necessary.

In contrast to the Commission’s original proposal set forth in H.B. 370 to enhance the partial public financing program, S.D. 1 proposes the following:

1. Increase the expenditure limits for elected offices by 20%; and
2. Increase the maximum amount of public funds available from ten or fifteen percent of the expenditure limit to **67%** of the expenditure limit (except for the Office of Hawaiian Affairs which will increase from a maximum amount of \$1,500 for the election year to 67% of the expenditure limit).

In reviewing #2 above, the Commission submits that if one candidate for each elected office<sup>1</sup> qualifies and receives the maximum amount available, the maximum amount available for public financing would be **\$10,298,546** in the 2026 primary election and another **\$10,298,546**

in the 2026 general election. For purpose of comparison, under the existing partial public financing program, if one candidate for each office qualified to receive funding in the 2026 elections, the maximum available for public financing would be \$1,474,306 in the primary election and another \$1,474,306 in the general election. By the Commission's calculations, the enhancements to the partial public financing program as proposed in S.D. 1 will significantly increase the funding available to qualified candidates to an amount more than that offered by S.B. No. 51 (specifically, \$5,487,092 more) which is the measure that proposed a full or comprehensive publicly funded campaign program. As of January 31, 2025, the HECF balance was \$2,224,511.20. Based on these numbers, the HECF has insufficient funding to administer such a robust partial public funding program absent an appropriation if this bill is passed.

With respect to the other sections in this bill that provide for a downward adjustment of the minimum amounts of qualifying contributions for the office of prosecuting attorney for the city and county of Honolulu (from \$30,000 to \$25,000), and counties of Hawaii (from \$10,000 to \$5,000) and Kauai (from \$5,000 to \$3,000), and for the office of county council for the county of Maui (from \$5,000 to \$4,000), the Commission supports these amendments as it makes it easier for candidates to qualify for partial public funding and was originally proposed in H.B. 370.

With respect to the increase in the matching fund ratio from \$1 for each \$1 of qualifying contributions raised to \$2 for every \$1 of qualifying contributions raised in excess of the minimum qualifying contributions that a candidate must raise to participate in the partial public financing program, the Commission supports these amendments as it doubles the matching funds available to qualifying candidates and was originally proposed in H.B. 370.

Finally, with respect to Section 7 of this bill, the Commission requests that an appropriation of \$200,000 for the addition of two full-time equivalent (2 FTE) permanent positions be inserted. The Commission has not had an increase in personnel for the past 29 years despite the number of candidate committees and noncandidate committees having almost doubled in size. Currently, there are only 5 staff members who oversee 700+ committees that have anywhere from 1-3 officers who require assistance on how to comply with the various requirements of campaign finance law thereby generating hundreds of staff hours assisting committees over the phone, in-person, and by email as well as a number of enforcement actions for violations. Under HRS §11-314(7), one of the Commission's 14 duties is to investigate and hold hearings for receiving evidence of any campaign finance violations. The Commission has no investigator on staff and has had to rely on contracts for investigative services with outside agencies.<sup>2</sup> In comparison to other State and county good government groups with compliance and enforcement duties, the Commission has had a modest budget and nominal staff despite a

tremendous growth in committees, an expansion in its duties and responsibilities, and enforcement mandates. The Commission respectfully seeks your support so that the Commission may ensure that the integrity and transparency of the campaign finance process is upheld and approve our request for 2 new full-time permanent exempt excluded positions (i.e., an Elections Assistant and an Investigator).<sup>3</sup>

The Commission supports the intent of this bill with the suggested amendment and so long as the necessary funds are appropriated.

<sup>3</sup> The Commission requested these 2 full-time permanent exempt excluded positions in its FY 2025-2027 budget to which the Governor has approved – specifically, the request was for \$200,000 for FY 2026 and \$180,000 for FY 2027-2029. Notably, the Commission is an administratively attached agency with the Department of Accounting and General Services.

Aloha e Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Senate Committee on Ways and Means:

The Office of Hawaiian Affairs (OHA) respectfully submits COMMENTS on HB370\_HD2\_SD1, which increases the amount of public funds available to candidates for public office who participate in the State's Partial Public Financing program under Hawai'i Revised Statutes (HRS) Chapter 11, Part J, and increases expenditure limits.

**OHA generally supports public financing as a good government measure.** The amendments to HRS Chapter 11 proposed in HB370\_HD2\_SD1 will make the public financing program a more viable option for candidates by increasing the funding available to candidates who participate in the partial public financing system. Increased access to publicly financed campaigns makes elections more accessible, open, and fair.

**OHA also appreciates the amendments made in the last committee that would set the public funds available to OHA candidates who run statewide elections at 67% of the relevant expenditure limit, consistent with all other candidates, thereby reducing existing disparities in public funding.**

Nonetheless, because this measure leaves the significant disparities in HRS § 11-423(d) intact, OHA candidates are still not eligible to the same amount of funds as other candidates in statewide elections. This section sets candidate expenditure limits determined by multiplying the "number of voters in the last preceding general election registered to vote" in the relevant voting district by a specific dollar amount. **OHA trustees are the only candidates who run statewide election campaigns that are not explicitly listed in this subpart, and thus default to the lowest multiplier category with "other offices," or \$0.20 (20 cents). See HRS § 11-423(d)(5).** While this multiplier would increase to \$0.24 under this measure, this is still significantly less than other candidates who run statewide campaigns (see page 2 line 18 to page 3 line 4).

The total expenditure limits in HRS § 11-423(d) in turn affect the amount of public financing available to a candidate under HRS § 11-425, which sets public funding as a percentage of the total expenditure limits. As a matter of fairness and equity, OHA respectfully requests that OHA be treated comparably to other statewide office holders through necessary amendments to HRS § 11-423. **Specifically, the multiplier set in HRS § 11-423 should put OHA candidates' expenditure limit on parity with the lieutenant governor, another statewide office holder (increase from \$0.20 to \$1.68).**

# Testimony in Support of HB370 HD2 SD1

Chair Dela Cruz, Vice Chair Moriwaki, and all Committee members,

Mahalo for the opportunity to testify before you today. On behalf of Our Hawai'i's over 38,000 members and supporters across the pae 'āina, we write in strong support of HB370 HD2 SD1, which expands the state's Partial Public Financing Program to reduce the influence of big money in politics and make elections more accessible to everybody people.

In the historic 1978 Hawai'i Constitutional Convention, the public financing of elections was established as a key part of our constitution, stating that a public campaign fund could dilute "the effective influence of money and large contributors" and "equalize opportunity for all to participate meaningfully in the political process."

In the years that followed, public funding of elections played a meaningful role in major races up and down the ballot in Hawaii's local elections. But in recent decades, with rising costs, and the flood of unlimited political spending unleashed by the US Supreme Court's Citizens United decision in 2009, our public financing programs have not kept up with the reality of modern political campaigns. In fact, we have not made adjustments to our public campaign finance system since 1995 — before most people were using personal computers or cell phones.

The result of this is that we have seen an increase in big money in politics, and a declining use of our public financing system. **Why? Primarily because the campaign spending cap you must abide by when you opt in to taking public funds is too low to run and win an average State House and State Senate campaign.**

For example, the **current average expenditure limit for the upcoming 2026 election for a State House race is \$23,632**, for the primary or the general election. That means if you want to receive public funds, you have to agree to spend less than \$23,632 on your election.

However, the median amount spent by State House primary winners in 2024 was **\$31,311.60**, and the average amount spent in winning primary races was **\$37,473.95**. That means **currently, if you are a State House candidate who wants to do the right thing by opting into our public financing system, you have to agree to run on less than what it takes on average to win a race.**

**This bill makes progress towards addressing this by increasing expenditure caps by 20% across the board, while also increasing the maximum amount of matching funds available to candidates to support them to run competitive races without having to be over reliant on private funds.**

While campaign finance reform progress has been made in recent years, it is not enough. On April 17th, 2024 the New York Times dropped a [bombshell exposé on the front page of the New York Times](#), exposing to the world the deep culture of pay-to-play corruption that has existed at high levels of Hawai'i political leadership. With just days left in the legislative session, Hawaii Lawmak-



ers did not act to correct these real problems of corruption or the crisis of public trust they have exacerbated. Now, you all have the opportunity to act.



Expanding public financing will allow more grassroots candidates—those without deep-pocketed backers—to run competitive campaigns. It will free elected officials from the constant pressure of fundraising and instead allow them to focus on what truly matters: delivering for their constituents.

This bill does not radically upend our system; instead, it improves an existing, underutilized program. Incumbents will still be able to compete, and the overall partisan makeup of the legislature will not significantly shift. What will change is who has influence—moving power away from big donors and lobbyists and back to the people.

The people of Hawai'i are tired of a system where wealthy donors call the shots. Expanding public financing won't fix everything overnight, but it is a necessary step toward a government that truly represents the people—not just those who can afford to bankroll campaigns.

Mahalo nui loa for your leadership and commitment to restoring trust in our democracy. Together, we can move toward a brighter future for Hawai'i.

We support this bill as written, or any version of partial public financing reform that raises the expenditure limits for State House and State Senate seats to competitive enough levels for candidates to want to participate in the program.

If costs are of concern to lawmakers, it is important to understand that they are driven largely by the very expensive races at the top of the ticket, Governor and Lieutenant Governor's races. If these races did not have their matching proportions or expenditures limits increased, it could improve projected costs.

In addition, in the spirit of increasing participation in public financing programs while saving money overall, legislators could lower the percentage matched across all races from 67% to 35%, but consider a higher increase in the expenditure limit (a 30% increase instead of 20% would make the average House and Senate expenditure limits fully competitive). This would result in savings from the baseline projections of 43% in average annual costs. A 30% increase in expenditure limit at up to 22.5% matched would result in a 64% savings from baseline.

We've included tables demonstrating projected costs at these different match scenarios and expenditure limit levels for consideration.

#### TESTIMONY

Beppie Shapiro, Legislative Committee, League of Women Voters of Hawaii

Chair Dela Cruz, Vice Chair Moriwaki, and Committee Members:

**The League of Women Voters of Hawaii supports SB370 HD2 SD1, which would enhance the appeal of public financing by making its financial benefits more practical for current election campaign costs.**

The League of Women Voters of the US believes that methods of financing political campaigns should enable candidates to compete equitably for public office and ensure that candidates have sufficient funds to communicate their messages to the public. Hawaii's Partial Public Funding Program (PPFP) is intended to support those goals.

The amount available through the PPFP to publicly funded candidates has not changed in over two decades. Inflation in media prices, postage, and labor costs make the current amounts far less than competitive. The current amounts available to qualified candidates for public funding are far below the amounts spent by privately funded candidates who won election to the same office. Not surprisingly, the number of candidates using the PPFP has decreased every year since at least 2016. The increases proposed in HB370 HD2 SD1 unquestionably offer an improvement on the status quo.

In addition, HB370 HD2 SD1 cuts the amount of qualifying contributions required to access public funding for several offices, making the program easier to access.

To enable the Campaign Spending Commission (CSC) to fulfill the requirements of this bill as well as its existing duties, SB370 added 2 positions to CSC staff; currently

HAPA strongly supports HB370, which increases the partial public campaign financing available for all state and county elective offices.

Our state's public financing system has not been updated for 30 years. The value of the dollar has more than doubled since then with inflation. With that, this leaves our public financing system inadequate in today's political landscape.

Recent data also highlights the urgent need for campaign finance reform. For example, since 1994, incumbents in the Hawai'i House have spent an average of \$57,883 per election, while challengers spent only \$16,500 when adjusted for inflation. This disparity has resulted in a 90% reelection rate for incumbents over the past decade.

While there have been a few successful candidates who used the program and won their elections, it's not the norm. In 2024, 25 candidates initially signed up to seek matching funds, but only 10 actually used the program—6 for county council, 2 for OHA, and just 2 for the State House. We can do better.

By matching the funding amounts and raising the expenditure limits, we will get closer to making the partial public funding program a real viable option.

The bill also includes provisions for additional staffing at the Campaign Spending Commission, allocating \$200,000 for two full-time positions. This funding is necessary for the effective implementation and oversight of the expanded program. This is particularly important as the Commission has not received additional personnel in decades, even though campaign finance laws have become increasingly complex.

Please support HB370 as you have the opportunity to respond to public sentiment for an equitable and transparent electoral system.

The ACLU of Hawai'i **supports HB370 HD1 SD1 Relating to Partial Public Financing of Elections.**

In our view, the answer to concerns over the escalating cost of political campaigns is to expand, not limit, the resources available for political advocacy. **Thus, the ACLU supports a comprehensive and meaningful opt-in system of public financing that would help create a level playing field for every qualified candidate.**

A representative democracy functions best when it closely mirrors the electorate. And this is accomplished when access to public candidacy isn't limited by personal wealth or the deep pockets of private interests.

Financial means, or lack of such, can have a wide array of impacts. Access to wealth often results in better educational and health outcomes over the course of one's life. Those individuals and families impacted by our criminal justice system are predominately those who live in poverty. **So too do financial means impact our electoral system. Those with greater financial means and access to high-quality education are more likely to run for, and win, elected offices.**

Giving potential candidates the option to access a meaningful pool of public money will go a long way toward leveling the playing field against well-funded and entrenched incumbents. And a well-funded public financing system could very-well encourage individuals from these under represented demographics to run for public office.

## HOUSE BILL 370, HD2, SD1, RELATING TO PARTIAL PUBLIC FINANCING OF ELECTIONS

APRIL 1, 2025 · WAM HEARING

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus **supports** HB 370, HD2, SD1, relating to partial public financing of elections, which increases the amount of partial public campaign financing available for all elective offices; adjusts the minimum amount of qualifying contributions certain candidates must receive to participate in the program; increases the matching fund payments for excess qualifying contributions; and appropriates funds for the program and staff.

Our democracy belongs to we, the people. At a time when our nation is experiencing extreme political turmoil and basic civil liberties are under assault, we must take steps in Hawai'i to safeguard democratic participation. In the 2024 primary election, for example, our state experienced its lowest turnout in 65 years, with only 32.1 percent of registered voters filling out a ballot. This is, in part, a reflection of the public's deep cynicism with our electoral processes.

Hawai'i continues to be embroiled in public corruption scandals, following the bribery allegations that were levied against former Senate Majority Leader Kalani English and former State Representative Ty Cullen. Other public officials, such as employees at local permitting offices, have been ensnared in bribery scandals, in some cases with connections to Milton Choy, the lobbyist who was responsible for coordinating the bribery scheme that Sen. English and Rep. Cullen became a part of. These cases show that we have a moral crisis in our public institutions and must act to restore integrity to government. **Just last week, Civil Beat reported that an unnamed lobbyist gave \$35,000 to an unnamed legislator just before the 2022 legislative session, a case that remains under federal investigation.**

When candidates for public office are forced to rely on private donations to build relationships, those transactions can cause corruption or create the perception of it. Put simply, legislators are responsive to donors because donors fund their campaigns. Money is crucial to winning. Roughly 91 percent of candidates who outspend their opponents win their elections.

Relatedly, many people choose not to run for public office because they can't afford the cost of a campaign, leaving many incumbents routinely uncontested in their reelection bids. The average winner of a State House seat in Hawai'i spends approximately \$40,000 on their campaign, compared to only \$16,000 for the losing candidate. Over half of all campaign donations in 2022 came from just 980 donors, each of whom contributed at least \$6,000 in candidate donations during that election cycle.

This bill moves our islands toward an election system that is fair. We are also supportive of the proposed positional funding for the Hawai'i Campaign Spending Commission, which has not received additional staff since its inception decades ago. Robust public financing models, such as those being used in states like Maine. In the 2010 and 2012 election cycles, the Hawai'i Island County Council ran a pilot program for comprehensive public funding. Similarly, Connecticut and Maine have instituted comprehensive public financing programs, which have proven successful at increasing electoral participation and reducing candidates' reliance on private donations. Over 70 percent of Democratic legislators use public financing to fund their campaigns in Maine.

These models ensure that candidates no longer need to rely on contributions from wealthy donors. Instead, they can seek support from their constituents in the form of small donations that verify their credibility and subsequently obtain public funding in an amount sufficient to run effective campaigns. Legislators are, in turn, empowered to focus on engaging with their communities, rather than charming the donor class. Ultimately, this reorients our government toward the will of the people, not the wallets of the privileged.

We believe that government should work for the public interest, not special interests. It is in that spirit that we support reforms to uplift the transparency, accountability, and integrity of our state's election system.
