Thank you for the opportunity to testify on this bill.<sup>1</sup> The Campaign Spending Commission (“Commission”) supports this bill.

The purpose of this bill is to enhance Hawaii’s partial public financing program by increasing the maximum amount of public funds available for all offices by 50%<sup>2</sup> (except for the Office of Hawaiian Affairs (“OHA”) which will be significantly enhanced by over 1,000%) to qualified candidates. It also makes a downward adjustment of the minimum qualifying contributions for certain offices because it appears that publicly financed candidates for those offices were having a difficult time raising the minimum qualifying contributions. Respectfully, the Commission is submitting this bill as an attempt to boost an existing program that is mandated by the State Constitution which has not changed and whose maximum dollar amounts have not changed since 1995.

This bill amends Hawaii Revised Statutes (“HRS”) sections as follows:

- 1) HRS §11-425 by increasing the maximum amount of public funds available for all offices (except for the offices of the Mayor of the County of Kauai, Mayor of the County of Maui, and OHA trustee) by 50%. The bill also increases the maximum

amount available for candidates for Mayor of the counties of Kauai and Maui by 125% by moving those offices from subsection (a) to subsection (b) and increasing the maximum amount of public funds available for a candidate for trustee of OHA from \$1,500 for the election period to 10% of the expenditure limit for each election established in HRS §11-423(d).

- 2) HRS §11-429(a) by increasing the amount of qualifying contributions required for a candidate for trustee of OHA from more than \$1,500 in the aggregate to more than \$5,500 in the aggregate.
- 3) HRS §11-429(b) by increasing matching fund payments from \$1 for each \$1 of qualifying contributions in excess of the minimum qualifying contribution amounts to \$2 for each \$1 of excess qualifying contributions.

The bill also provides a downward adjustment of the minimum amounts of qualifying contributions for the office of prosecuting attorney for the city and county of Honolulu (from \$30,000 to \$25,000), and counties of Hawaii (from \$10,000 to \$5,000) and Kauai (from \$5,000 to \$3,000), and for the office of county council for the county of Maui (from \$5,000 to \$4,000). Lastly, the bill establishes two full-time equivalent (2.0 FTE) positions in the Commission and appropriates funds.

For illustration, here is a comparison of the present partial public funding program in contrast to the enhanced partial public funding program set forth in this bill. For a qualified Senate candidate running in District 1 in the 2026 election, the maximum amount of public funds available is \$7,269 in the primary election and another \$7,269 in the general election. In contrast, under this bill, this same candidate would receive \$10,903 in the primary election and another \$10,903 in the general election. For a qualified House candidate running in District 1 in the 2026 election, the maximum amount of public funds available is \$3,562 in the primary election and another \$3,562 in the general election. In contrast, under this bill, this same candidate would receive \$5,343 in the primary election and \$5,343 in the general election.

For a qualified candidate running for Kauai Mayor in the 2026 election, the maximum amount of public funds available is \$9,635 in the primary election and another \$9,635 in the general election. In contrast, under this bill, this same candidate would receive \$21,679 in the primary election and \$21,679 in the general election. For a qualified candidate running for Maui Mayor in the 2026 election, the maximum amount of public funds available is \$23,002 in the primary election and another \$23,002 in the general election. In contrast, under this bill, this same candidate would receive \$51,754 in the primary election and \$51,754 in the general election. Lastly, for a qualified OHA candidate in the 2026 election, the maximum amount of public funds available is \$1,500 for the election period. In contrast, under this bill, this same candidate would receive \$17,217 in the primary election and \$17,217 in the general election.

Under the bill, assuming one qualified candidate for each elective office<sup>3</sup> in the state, the maximum amount of public financing available would be **\$2,353,426** in the 2026 primary election and another **\$2,353,426** in the 2026 general election. As of October 31, 2024, the Hawaii Election Campaign Fund (“HECF”) balance was \$2,268,225.38. An appropriation into the HECF is likely necessary if this bill is passed.

In regard to the additional two full-time equivalent (2.0 FTE) positions in the measure, the Commission has not had an increase in personnel for the past 29 years despite the number of candidate committees and noncandidate committees having almost doubled in size. Currently, there are only 5 staff members who oversee 700+ committees that have anywhere from 1-3 officers who require assistance on how to comply with the various requirements of campaign finance law thereby generating hundreds of staff hours assisting committees over the phone, in-person, and by email as well as a number of enforcement actions for violations. Under HRS §11-314(7), one of the Commission’s 14 duties is to investigate and hold hearings for receiving evidence of any campaign finance violations. The Commission has no investigator on staff and has had to rely on contracts for investigative services with outside agencies.<sup>4</sup> In comparison to other State and county good government groups with compliance and enforcement duties, the Commission has had a modest budget and nominal staff despite a tremendous growth in committees, an expansion in its duties and responsibilities, and enforcement mandates. The Commission respectfully seeks your support so that the Commission may ensure that the integrity and transparency of the campaign finance process is upheld and approve our request for 2 new full-time permanent exempt excluded positions (i.e., an Elections Assistant and an Investigator).<sup>5</sup>

The Commission requests that this committee pass this bill.

<sup>4</sup> Act 10, Special Session 1995, was the single year that a sum of \$70,000 was appropriated for one investigator for the Commission for FY 1995-1996 and was then sunset. This request essentially restores this position and makes it permanent.

<sup>5</sup> The Commission requested these 2 full-time permanent exempt excluded positions in its FY 2025-2027 budget to which the Governor has approved – specifically, the request was for \$200,000 for FY 2026 and \$180,000 for FY 2027-2029. Notably, the Commission is an administratively attached agency with the Department of Accounting and General Services.

Chair Tarnas, Vice Chair Poepoe, and Committee Members:

**The League of Women Voters of Hawaii supports HB370, Relating to partial public financing of elections.** The League of Women Voters of the US believes that methods of financing political campaigns should enable candidates to compete equitably for public office and ensure that candidates have sufficient funds to communicate their messages to the public. Hawaii's Partial Public Funding Program (PPFP) is intended to support those goals.

The amount available to publicly funded candidates has not changed in over two decades. Inflation in media prices, postage, and labor costs make the current amounts far less than competitive. The current amounts available to qualified candidates for public funding are far below the amounts spent by privately funded candidates who won election to the same office. Not surprisingly, the number of candidates using the PPFP has decreased every year since at least 2016. The increases proposed in HB370 unquestionably offer an improvement on the status quo.

In addition, HB370 cuts the amount of qualifying contributions required to access public funding for several offices, making the program easier to access.

To enable the Campaign Spending Commission (CSC) to fulfill the requirements of this bill as well as its existing duties, HB370 adds 2 positions to CSC staff and increases the CSC budget by an unspecified amount.

These changes will bolster the use of the PPFP, thus advancing the goals of equitable and effective campaign funding. Please pass HB370.

Dear Chair Tarnas, Vice Chair Poepoe, and Members of the Committee,

HAPA strongly supports HB370, which increases the partial public campaign financing available for all state and county elective offices.

Our state's public financing system has not been updated for 30 years. The value of the dollar has more than doubled since then with inflation. With that, this leaves our public financing system inadequate in today's political landscape. Therefore, HB370 would address this by increasing the maximum amount of public funds available to candidates across various offices and makes public financing a more viable option for candidates.

Recent data also highlights the urgent need for campaign finance reform. For example, since 1994, incumbents in the Hawai'i House have spent an average of \$57,883 per election, while challengers spent only \$16,500 when adjusted for inflation. This disparity has resulted in a 90% reelection rate for incumbents over the past decade.

The proposed changes in HB 370 align with other reform efforts in the state. In 2023, lawmakers passed many recommendations from the Foley Commission, including strengthening penalties for government fraud and reforming lobbying practices. However, some of the toughest reform measures, such as full public financing of elections and prohibiting campaign contributions during legislative sessions, have yet to be enacted.

This bill addresses these gaps by increasing the maximum amount of public funds available for all offices by 50% and for the Office of Hawaiian Affairs from \$1,500 to 10% of the expenditure limit for each election. This change recognizes the unique needs of our state and ensures that candidates for this important office have the resources to reach voters across all islands.

The bill also includes provisions for additional staffing at the Campaign Spending Commission, allocating \$200,000 for two full-time positions. This funding is necessary for the effective implementation and oversight of the expanded program. This is particularly important as the Commission has not received additional personnel in decades, even though campaign finance laws have become increasingly complex.

We urge you to support HB370 370 as you have the opportunity to respond to public sentiment for an equitable and transparent electoral system.

## HOUSE BILL 370, RELATING TO PARTIAL PUBLIC FINANCING OF ELECTIONS

JANUARY 28, 2025 · JHA HEARING

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus supports HB 370, relating to partial public financing of elections, which Increases the amount of partial public campaign financing available for all state and county elective offices; amends section 11-425, Hawai'i Revised Statutes (HRS), by increasing the maximum amount of public funds available for each election for candidates (1) for Mayor of the County of Kauai and the County of Maui by 125 percent; (2) for the Office of Hawaiian Affairs from \$1,500 to 10 percent of the expenditure limit established in section 11-423(d), HRS; and (3) for candidates for all other offices by 50 percent; amends section 11-429(a), HRS, by increasing the amounts of qualifying contributions for the Office of Hawaiian Affairs from more than \$1,500 in the aggregate to more than \$5,000 in the aggregate; provides a downward adjustment of the amounts of qualifying contributions for the Office of Prosecuting Attorney for the City and County of Honolulu, County of Hawai'i, and County of Kauai and for the Office of County Council for the County of Maui; provides for an unspecified appropriation to pay for the increase in the partial public financing program; and provides for an appropriation in the amount of \$200,000 for the Commission to hire two additional staff members.

Our democracy belongs to we, the people. At a time when our nation is experiencing extreme political turmoil and basic civil liberties are under assault, we must take steps in Hawai'i to safeguard democratic participation. In the 2024 primary election, for example, our state

experienced its lowest turnout in 65 years, with only 32.1 percent of registered voters filling out a ballot. This is, in part, a reflection of the public's deep cynicism with our electoral processes.

Hawai'i continues to be embroiled in public corruption scandals, following the bribery allegations that were levied against former Senate Majority Leader Kalani English and former State Representative Ty Cullen. Other public officials, such as employees at local permitting offices, have also recently been ensnared in bribery scandals, in some cases with connections to Milton Choy, the lobbyist who was responsible for coordinating the bribery scheme that Sen. English and Rep. Cullen became a part of. These cases show that we have a moral crisis in our public institutions and must do all we can to restore integrity to government.

When candidates for public office are forced to rely on private donations to build relationships, those transactions can cause corruption or create the perception of it. Put simply, legislators are responsive to donors because donors fund their campaigns. Money is crucial to winning. Roughly 91 percent of candidates who outspend their opponents win their elections.

Relatedly, many people choose not to run for public office because they can't afford the cost of a campaign, leaving many incumbents routinely uncontested in their reelection bids. The average winner of a State House seat in Hawai'i spends approximately \$40,000 on their campaign, compared to only \$16,000 for the losing candidate. Over half of all campaign donations in 2022 came from just 980 donors, each of whom contributed at least \$6,000 in candidate donations during that election cycle.

This bill moves our islands incrementally toward an election system that is fair. **We are especially supportive of the proposed positional funding for the Hawai'i Campaign Spending Commission, which has not received additional staff since its inception decades ago.** That said, we urge your committee to continue evaluating more robust public financing models, such as those being used in states like Maine. In the 2010 and 2012 election cycles, the Hawai'i Island County Council ran a pilot program for comprehensive public funding. Similarly, Connecticut and Maine have instituted comprehensive public financing programs, which have proven successful at increasing electoral participation and reducing candidates' reliance on private donations. Over 70 percent of Democratic legislators use public financing to fund their campaigns in Maine.

These models ensure that candidates no longer need to rely on contributions from wealthy donors. Instead, they can seek support from their constituents in the form of small donations that verify their credibility and subsequently obtain public funding in an amount sufficient to run effective campaigns. Legislators are, in turn, empowered to focus on engaging with their communities, rather than charming the donor class. Ultimately, this reorients our government toward the will of the people, not the wallets of the privileged.

We believe that government should work for the public interest, not special interests. It is in that spirit that we support this and other reforms to uplift the transparency, accountability, and integrity of our state's election system.

# Testimony in Support of HB370

Chair Tarnas, Vice Chair Poepoe, and all Committee members,

On behalf of Our Hawai'i's over 38,000 members and supporters across the pae 'āina, I stand in strong support for Senate Bill 2381, relating to public financing of candidates to elected office. Our members and supporters are local people — kama'āina and kānaka 'oiwi, keiki and kūpuna, from Kaua'i to Kohala, Kailua to Kapolei and every place in between. They have joined our movement to fight for a Hawai'i that puts local people — not big money interests — first, because they are worried about the direction of our islands and believe now is the time for change.

For the last several years we have been at the forefront of a movement of over three dozen organizations and thousands of citizens pushing to create a true alternative to our private money campaign finance system — full public financing of elections. **We still believe that a full public financing system is necessary and urgent to provide balance to our legislature and give local working families more representation in government. However, we also support building upon, improving, and expanding our existing partial public financing system,** as this legislation would do.

We agree with the inflation-based argument presented by the Campaign Spending Commission for increasing the matching about from \$1-\$1 to \$2-\$1. **Under this same logic, we suggest further amending the legislation to have the multipliers for each different type of race double based on inflation since 1995, as well. This would mean changing amounts in the following ways:**

- (1) For the office of governor - ~~\$2.50~~ \$5.00;
- (2) For the office of lieutenant governor - ~~\$1.40~~ \$2.80;
- (3) For the office of mayor - ~~\$2.00~~ \$4.00;
- (4) For the offices of state senator, state representative, county council member, and prosecuting attorney - ~~\$1.40~~ \$2.80.

The major issue with the current partial public financing system is that it limits candidates for State Legislative races too much without providing enough funds to make opting in worth it. When combined with the other changes in the bill, the doubling of the multiplier to keep pace with inflation would bring an average State House race up from the current amount you receive in a primary of ~\$3,000 to around \$10,000. While this is not enough to run a race on, it is a significant improvement that, when augmented with private fundraising, would be meaningful.

Furthermore, while the increase to 22.5% is a welcome step in the right direction for the percentage of expenditure limit that can be matched, the advent of Citizens United since 1995 has caused an increase in campaign spending, and suggests we should be bolder overall, in the spirit of the Hawai'i Constitution's intent. Increasing this to 50% or even 30% would mean that candidates would be eligible for funds that are truly getting closer to supporting them to running a competitive campaign.

2. **Potential for Misuse:** With more funds available, there's a risk of increased spending on less substantive campaign activities if not monitored closely. This could lead to a perception of wasted taxpayer money.
3. **Inequity in Funding Adjustments:** While some adjustments lower qualifying amounts, others increase them, potentially creating disparities in how candidates from different offices can access public funds.
4. **Complexity and Bureaucracy:** The changes might complicate the existing system, potentially leading to administrative burdens or confusion among candidates and voters.

#### Improvements or Considerations:

1. **Transparency and Accountability:** Ensure there's a robust system for tracking how these public funds are spent, with public reporting requirements.
2. **Cap on Total Spending:** Consider implementing or reinforcing spending caps to prevent an arms race in campaign expenditures even with public financing.
3. **Balanced Adjustments:** Review the adjustments to qualifying contributions to ensure they are equitable across all offices, perhaps with a formula that considers population size or district wealth.
4. **Educational Campaign:** Given the changes, an educational campaign for candidates and voters might be necessary to explain the new system, its benefits, and how to participate or support candidates using public funds.

Conclusion:
