SUBJECT: **Testimony on H.B. No. 372, Relating to Campaign Contributions.**

Thank you for the opportunity to testify on this bill.¹ The Campaign Spending Commission (“Commission”) supports this bill.

In 2022, the Legislature enacted a ban on elected officials holding fundraisers during any regular or special session of the state Legislature. Hawaii Revised Statutes (“HRS”) §11-342(c). This measure seeks to close a loophole in the law by amending HRS §11-357 to ban elected officials from also soliciting or accepting campaign contributions during the same time period. It is common for elected officials to receive contributions outside of any formal fundraising event. This bill will prevent the corruption, or at least the appearance of corruption, of elected officials.

The Commission requests that this committee pass this measure.

Dear Chair Tarnas, Vice Chair Poepoe, and Members of the Committee,

HAPA strongly supports HB372, which prohibits state and county elected officials from soliciting and accepting campaign contributions during any regular or special session of the state legislature, including any extension of any regular or special session or any legislative recess day, holiday, or weekend.

Public opinion strongly backs campaign finance reform. A 2022 Data for Progress poll found that 74% of Hawai'i voters support measures to limit campaign contributions. This widespread support demonstrates the public's desire for clearer rules around political fundraising.

Campaign spending data reveals significant disparities in Hawaii's electoral landscape. Incumbents in the Hawaii House spend an average of \$57,883 per election, compared to just \$16,500 for challengers. This funding gap creates an uneven playing field that undermines fair political competition.

HB372's impact becomes clear when examining re-election rates. Over the past decade, 90% of incumbents have won re-election. While experience matters, this high rate suggests that current fundraising practices may unfairly advantage sitting politicians.

Recent corruption cases further highlight the need for this legislation. Two state lawmakers pleaded guilty to bribery, exposing vulnerabilities in the current campaign finance system. This bill provides a direct response to these ethical breaches.

Other states have successfully implemented similar restrictions. Alaska, Florida, and Tennessee prohibit fundraising during legislative sessions. These laws have helped restore public trust in government and created clearer ethical boundaries.

We urge you to support HB372 to ensure that there is a separation from legislative work and fundraising, therefore legislators focus on serving constituents when they need to be.
