Aloha e Chair Richards, Vice Chair San Buenaventura, and Members of the Senate Committee on Hawaiian Affairs:

Mahalo for setting HB410_HD1, which is part of the Office of Hawaiian Affairs's (OHA's) 2025 Legislative Package, for public hearing. OHA submits this testimony in **STRONG SUPPORT of HB410_HD1**, Relating to the Budget of the Office of Hawaiian Affairs, as necessary to ensure continued provision of high quality services to our beneficiaries.


The Office of Hawaiian Affairs is the constitutionally established body responsible for protecting and promoting the rights of Native Hawaiians. Haw. Const. Art. XII § 5. Among its statutory duties, OHA is required to (1) serve as principal public agency in the State of Hawai'i responsible for the performance, development and coordination of programs and activities relating to native Hawaiians and Hawaiians; (2) assess the policies and practices of other agencies impacting native Hawaiians and Hawaiians; and (3) conduct advocacy efforts for native Hawaiians and Hawaiians. Hawai'i Revised Statutes § 10-3.

In fulfillment of these duties, OHA is requesting a \$1,858,454 increase in FY26 and \$1,996,208 increase in FY27 in general fund appropriations (reflected in the FY26 and FY27 biennium budget totals of \$4.8M and \$4.9M).

The requested appropriation increases are necessary to adjust for the cost of inflation since 2020 when OHA began implementing its strategic plan [Mana i Maoli Ola](#) and to fund 13 new staff positions to accelerate implementation of the plan. The 13-member team will evaluate existing programs and develop new programs and tactics to advance 'oiwi well-being and reduce disparities in health, housing, education and economic development, as set forth in the strategic plan. The team will also partner with state and county agencies to leverage their resources, and ensure effective delivery of services to Native Hawaiian communities across providers through data sharing, program design, and program evaluation. To ensure transparency for elected officials and the public, staff will post dashboard progress reports on our progress in reducing disparities.

OHA is in the process of initiating bold new initiatives to make measurable progress in advancing Native Hawaiian well-being over the remaining 10 years of its strategic plan. We look forward to partnering with our beneficiaries, the legislature, other Native Hawaiian Organizations and state agencies, and private sector partners as we advance this mission. Mahalo for the opportunity to submit this testimony.

TESTIMONY IN OPPOSITION

This bill appropriates moneys to fund the operating expenses of the Office of Hawaiian Affairs for the fiscal biennium beginning on 7/1/2025, and ending on 6/30/2027.

According to OHA's Annual Report for the fiscal year ending June 30, 2024, on page 15, OHA's total assets were \$971 Million. By now, three-quarters of a year later, that figure is likely more than A BILLION DOLLARS. No other branch of the State government is allowed to carry forward such a huge amount. Yet here comes OHA, demanding money for its operating expenses like a beggar holding out his tin cup.

Hawai'i Free Press on Friday June 24, 2025 reported some information from OHA's check register which it was able to obtain only after demanding access through the Freedom of Information Act. OHA's payroll was \$15.9 Million for its bloated bureaucracy, which was 40.7% of its spending. Any charity spending such a large percentage on payroll would be regarded as a scam.

Every year OHA's bills demanding money try to distinguish between general funds and trust funds. That's a distinction without a difference. Money is fungible. All these funds belong to the State of Hawai'i, whether the money is kept in the right trouser pocket or the left pocket. It is laughable to make it look like there's a fair and equitable balance between general funds and trust funds by appropriating identical amounts of each type of fund for each of the listed purposes.

It might be asserted that OHA's administrative costs for the salaries of its board of directors and its bureaucrats, and the operation of its buildings, should be paid from general funds because OHA is an agency of the state government. However, most of the money appropriated in this bill is to provide political advocacy, personal assistance, or legal representation that will be given exclusively to OHA "beneficiaries" -- i.e., exclusively to people of Hawaii's favorite racial group who have at least one drop of the magic blood (at least one ancestor who lived in Hawaii before Captain Cook's arrival in 1778). All money restricted by race should come from "trust funds"; and even if thus restricted, it is probably unconstitutional for a government agency to engage in such blatant racial discrimination.

Please vote NO on this bill. Give the money back to Hawai'i's taxpayers, or spend it to help the thousands of truly needy people of all races who are citizens of Hawai'i.

Aloha Hawaii Legislators:

House Bill No. 410 (H.D. 1), introduced in the Thirty-Third Legislature of the State of Hawaii in 2025, appropriates funds for the Office of Hawaiian Affairs (OHA) for the fiscal biennium 2025-2027. It allocates general funds (A) and trust funds (T) across three programs: Office of the Trustees (OHA150), Administration (OHA160), and Beneficiary Advocacy (OHA175), with specific earmarks for housing, social services, education, legal services, land protection, and economic development benefiting Native Hawaiians.

Data and Statistics

- Funding Breakdown:
 - OHA160 (Administration): \$1,258,454 (FY25-26) and \$1,296,208 (FY26-27) in general funds, supporting 13 permanent positions.
 - OHA175 (Beneficiary Advocacy): \$3.6M (FY25-26) and \$3.7M (FY26-27) in general funds, matched by equal trust fund amounts, totaling \$7.2M and \$7.4M annually.
 - Specific allocations: \$1.2M-\$1.25M for housing, \$1.03M for social services, \$1.43M-\$1.48M for education, \$1.4M for legal services, \$1.2M-\$1.25M for land protection, and \$0.94M-\$0.99M for economic development per fiscal year.
- Native Hawaiian Context:
 - 2020 Census: 296,400 Native Hawaiians in Hawaii, 26.8% of the state’s 1.46M population.
 - Poverty: Native Hawaiians face a 15.2% poverty rate (2021 ACS), vs. 7.5% statewide; 22% of Native Hawaiian households earn under \$35,000 annually (2022 DHHL).
 - Housing: Median home price \$850,000 (2023 Redfin); Native Hawaiian homeownership at 30% vs. 60% statewide (DHHL 2022); 8,900+ on DHHL waitlist (2023).

- Education: 17% of Native Hawaiians hold bachelor's degrees vs. 32% statewide (UH 2022); 68% of Native Hawaiian students qualify for free/reduced lunch (DOE 2023).
- Homelessness: 45% of Hawaii's 6,500 homeless are Native Hawaiian (HUD 2023 Point-in-Time Count).
- OHA Historical Funding: FY23-25 budget ~\$37M annually (OHA reports); OHA175's \$7.2M-\$7.4M is 19.5%-20% of that, a focused escalation.
- Economic Impact: OHA's \$1.5M in micro-grants (2018-2021) generated \$4.5M in community revenue (OHA 2021); Hawaii's \$14B tourism industry relies on cultural preservation tied to Native Hawaiian land rights (HTA 2023).

Support

1. Addresses Dire Housing Crisis:
 - Evidence: \$1.2M-\$1.25M targets Native Hawaiian homelessness (45% of 6,500 statewide, HUD 2023) and a 70% gap in homeownership (30% vs. 60%, DHHL).
 - Impact: Could fund ~15-20 homes annually at \$60,000-\$80,000 per infrastructure unit (DHHL cost estimates), chipping at the 8,900-person waitlist.
2. Empowers Education and Stability:

Concerns for Corruption and Accountability

1. Loose Fund Transfers:
 - Risk: Section 10's flexibility to shift funds with only annual reporting echoes OHA's \$1.8M in dubious spending (2018 State Audit), including \$500K to a single firm with board ties (Star-Advertiser 2019).
 - Data: Hawaii ranks 35th in transparency (CPI 2022); \$600M HART scandal (2022) shows oversight gaps.
 - Analysis: Without real-time checks, \$7.4M could drift from intent, especially with trust funds tied to Native Hawaiian assets.
2. Vague Outcomes:
 - Risk: No metrics (e.g., homes built, students graduated) despite \$7.2M-\$7.4M; OHA met only 60% of goals in 2022 due to fuzzy targets (Hawaii Budget & Policy Center).

- Data: 2023 DHHL audit found 60% of 200,000 trust acres undeveloped, partly from poor fund tracking.
 - Analysis: Risks inefficiency or diversion without mandated results, eroding trust in a \$37M agency.
3. Corruption Exposure:
- Risk: High allocations (\$1.4M legal, \$1.25M housing) could favor insiders; OHA's 2019 legal contract controversy cost \$500K with no bids (Star-Advertiser).
 - Data: Hawaii's legislature killed transparency bills 5 times since 2018 (Civil Beat 2023); OHA's \$3M in lobbying (2015-2020) suggests influence.
 - Analysis: Lack of procurement rules or audits heightens misuse potential in a state with a "C" corruption grade (Center for Public Integrity 2015, still relevant).

Honest Assessment

H.B. 410 is a bold \$7.2M-\$7.4M lifeline for Native Hawaiians, tackling a 45% homelessness rate, 15.2% poverty, and 70% education gap with precision. Its \$14B tourism tie-in and 3:1 economic ROI make it a powerhouse for cultural and fiscal health. Yet, OHA's \$1.8M scandal history and Hawaii's 35th transparency rank scream for tighter controls. The \$1.26M-\$1.3M admin budget for 13 staff is lean, but \$7.4M in advocacy needs ironclad metrics to avoid waste. Support it, but demand accountability to match its ambition.

This 15-year roadmap is essential in addressing persistent disparities in education, health, housing, and economic stability, challenges that directly impact the future of our lāhui. Queen Emma Hawaiian Civic Club (QEHC) upholds the legacy of Queen Emma, who dedicated her life to the advancement of education, healthcare, and social welfare for her people. This bill continues that legacy by equipping OHA with the necessary resources to uplift our people and strengthen our communities.

HB 410 HD1 is more than just a budget appropriation. It is an investment in the well-being and self-sufficiency of Native Hawaiians. The funding directly supports the three foundational pillars of Mana i Maui Ola: ‘Ohana (Family), Mo‘omeheu (Culture), and ‘Āina (Land and Water). The ‘Ohana pillar is strengthened through housing assistance and social services, ensuring that Native Hawaiian families have access to stable, affordable homes. Mo‘omeheu is reinforced through educational improvement programs and workforce development initiatives, creating opportunities for Native Hawaiians to gain economic independence. ‘Āina is protected through legal advocacy for kuleana landowners, environmental sustainability initiatives, and the preservation of sacred sites, securing our cultural and ancestral ties for future generations.

Education and economic stability are key to breaking cycles of poverty and inequity, and HB 410 HD1 advances OHA’s efforts to close these gaps. The bill provides funding for educational improvement programs designed to help Native Hawaiian students prepare for post-secondary education and economic stability. These programs play a vital role in equipping our students with the knowledge, skills, and opportunities needed for success in a competitive economy. Additionally, financial literacy initiatives and workforce readiness programs supported by this bill will help Native Hawaiians build wealth, increase homeownership, and create sustainable economic opportunities for their families.

Beyond economic challenges, HB 410 HD1 reinforces OHA’s legal advocacy for Native Hawaiian land rights, a core component of Mana i Maui Ola. This bill ensures continued

funding for legal services that protect kuleana lands, quiet title claims, iwi kūpuna, and access to water rights, all of which are under increasing threat. OHA's legal services program has assisted hundreds of Native Hawaiian families in preventing displacement, and this funding will allow these essential efforts to continue.

Housing remains one of the most pressing challenges facing Native Hawaiians today. According to the U.S. Census Bureau, 53,000 Native Hawaiian and Pacific Islander renter households, or 51.7 percent, were cost-burdened in 2023, meaning they spent more than 30 percent of their income on housing costs {U.S. Census Bureau, September 12, 2024, News Release CB24-150}. This alarming statistic underscores the urgent need for affordable housing initiatives and homeownership retention strategies, both of which are supported by this bill. Stable housing is a foundation for economic and social success, and HB 410 HD1 ensures that OHA has the funding to continue providing critical housing assistance to our people.

Despite its broad mandate to serve the Native Hawaiian community, OHA continues to receive only a fraction of its rightful share of Public Land Trust revenues, specifically 21.5 million dollars of the 78.9 million dollars owed annually. Until this issue is fully resolved, legislative appropriations like HB 410 HD1 remain necessary to bridge the funding gap and ensure OHA can fulfill its mission. This is not just a matter of financial allocation. It is a matter of justice and equity for the Native Hawaiian people.

As President of the Queen Emma Hawaiian Civic Club, I strongly urge the Senate Committee on Hawaiian Affairs to pass HB 410 HD1 without delay. The future of our lāhui depends on investments in housing, education, and economic opportunity, and this bill provides the necessary foundation for Native Hawaiians to thrive. By passing this legislation, we honor the legacy of Queen Emma and take a crucial step toward a self-sufficient, empowered Native Hawaiian people. Mahalo for your time and consideration.
