**Bill Title:** HB 0497, HD1 RELATING TO THE HAWAII CHILD NUTRITION PROGRAMS.

**Purpose of Bill:** Transfers the Hawaii Child Nutrition Programs Agency from the Department of Education to the Department of Agriculture and codifies its establishment. Establishes a grant program to be administered by the Agency to support the funding of certain initiatives for the State's public schools. Appropriates funds for grants. Effective 7/1/3000. (HD1)

**Department's Position:**

The Hawai'i State Department of Education (Department) provides comments on HB 497 HD 1.

The Department has concerns with the suggestion that the current placement of the Hawai'i Child Nutrition Programs (HCNP) within the Department, results in the School Food Services Branch impeding HCNP's ability to operate with independence, efficiency, and flexibility in conducting compliance audits and fiscal reviews. The Department would note that action was taken years ago to address a perceived conflict of oversight by reorganizing HCNP to move it from within the Office of Business Services, which oversaw the School Food Services program, to the Office of the Superintendent, and then later to the Office of Fiscal Services. It should be noted that neither the Office of the Superintendent nor the Office of Fiscal Services falls under the control of the School Food Services Branch.

Despite this, if concerns exist with the current location of the HCNP, an alternative option is to reorganize the Department to place HCNP within the Department's compliance area, which would fall under the purview of Deputy Superintendent of Strategy and Administration, Tammi Oyadomari-Chun.

In addition, it is unclear why additional resources to advance the State's farm to school initiative would be provided to the HCNP, which is an agent of the United States Department of Agriculture that

takes its direction from the federal government and relies on federal funds for its operations except for an annual maintenance of effort general fund appropriation of approximately \$185,000. As noted in Section 1 of this measure, Act 175, Session Laws of Hawai'i 2021 established a target for the Department of thirty percent of the food products served in public schools, as measured by the total cost of food, shall be locally sourced. Work by the Department is already underway with planning for centralized kitchens to meet this target. Assigning responsibility to advance farm-to-school objectives in Hawai'i to an agent of the United States Department of Agriculture, who is now currently under a new administration, that may or may not share the same strategic and operational plans as the Department has the potential to undermine the work necessary to meet the thirty percent target.

Furthermore, given the fact that the HCNP monitors the Department's School Food Service program for federal compliance and approves the payment of federal reimbursements, this measure may inadvertently formalize in state law a conflict should there be a difference of opinion in strategic and operational plans to meet the State's thirty percent target.

Chair Kahaloa, Vice Chair Kusch and Members of the Committee:

Thank you for the opportunity to testify on House Bill 497 HD1. This bill proposes to transfer the Hawaii Child Nutrition Programs Agency from the Department of Education to the Department of Agriculture (Department) and codifying its establishment. It further seeks to establish a grant program, administered by the Agency, to support initiatives for the State's public schools and to appropriate funding for these grants. The Department respectfully offers the following comments.

While the Department supports the Legislature's intent behind this measure, it acknowledges a lack of familiarity with the operational functions and specific responsibilities of the various entities involved in the proposed transfer. Furthermore, there may be logistical challenges that could lead to unintended consequences.

Accordingly, the Department expresses its appreciation for all efforts to support child nutrition programs in Hawai'i but respectfully defers to the Department of Education regarding the proposed transfer of the Hawaii Child Nutrition Programs Agency.

Hawai'i Public Health Institute (HIPHI)<sup>1</sup>, the Healthy Eating, Active Living (HEAL) coalition<sup>2</sup> and the Hawai'i Farm to School Network,<sup>3</sup> are in Support of HB 497, which moves the Hawai'i Child Nutrition Programs (HCNP), currently located in the Department of Education (DOE), to the Department of Agriculture (DOA) and establishes a grant program to strengthen farm-to-school initiatives.

This bill ensures that federal child nutrition programs are managed with independent oversight, expands local food procurement, and strengthens ties to farm-to-school coordination under the DOA.

### Removing the Conflict of Interest

The Hawai'i Child Nutrition Program's intent is to ensure that the DOE is complying with federal school food nutrition guidelines. HCNP is unable to do its job effectively due to being housed within the agency it is tasked to regulate, the DOE. This move will enhance compliance with federal child nutrition standards while eliminating conflicts of interest in school meal audits and management. Schools will benefit from a direct link to local farmers, increasing purchasing opportunities and improving food quality for Hawai'i's keiki.

The three pillars of successful farm to school programs are 1) school gardens and on-campus farms, 2) education, and 3) school food improvements through local procurement.



### **Support for 30% Local by 2030**

Supporting Hawai'i's "30 by 30" school food goal requires a structural shift to integrate locally grown foods into school meals successfully. Act 175 (2021) mandates that 30% of food served in public schools be locally sourced by 2030, yet DOE reports that only 5.43% of its food currently comes from local producers.<sup>4</sup> Transferring HCNP to the DOA strengthens farm-to-school coordination by placing oversight within the agency best equipped to support agricultural procurement and regional food systems.

### **Farm to School Grant**

HB 497 establishes a grant program to expand farm-to-school efforts, funding initiatives that support fresh food procurement, kitchen equipment upgrades, and nutrition education. By investing in school food infrastructure and technical assistance for farmers, this bill helps create a sustainable, transparent, and farmer-focused school meal system. Increased access to local, minimally processed foods will improve student health outcomes and drive economic growth for Hawai'i's agricultural sector. The passage of HB 497 is a crucial step toward reducing the state's reliance on imported food, strengthening food security, and ensuring that future generations benefit from a more resilient and community-driven food system.

Chair Kahaloa, Vice Chair Kusch, and Members of the Committee,

The Hawaii Cattlemen's Council **supports HB497 HD1** which transfers the Hawai'i Child Nutrition Programs Agency from the Department of Education to the Department of Agriculture and codifies its establishment. Establishes a grant program to be administered by the Agency to support the funding of certain initiatives for the State's public schools and appropriates funds for grants.

The health and nutrition of our keiki is paramount to a successful future. This bill will allow for grants to purchase local food, educate children about good nutrition, and increase our access to federal child nutrition programs. This helps both our keiki as well as our farmers and ranchers.

The American Heart Association recognizes beef as a heart healthy protein and even provides recipes that include lean beef. Research by Roussell et al (2012) shows eating lean beef as part of a heart-healthy dietary pattern can help maintain normal cholesterol levels. Hawaii's locally grown beef provides 10 essential nutrients in a single 3 oz. serving. This includes high-quality protein, iron, zinc and B vitamins. The iron in beef is heme iron, which is more easily absorbed than nonheme iron, which is the main form of iron found in plant proteins. Iron is vital as it helps red blood cells carry oxygen to body tissue, but even further, it also plays an important role in cognitive health such as memory, learning, and reasoning.

We appreciate the opportunity to testify on this measure. The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of over 750 thousand acres of land in Hawaii, or 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.

My name is Mark Hines, and I am writing in strong support of HB497, which would move the Hawai‘i Child Nutrition Program (HCNP) from the Department of Education (DOE) to the Department of Agriculture (DOA). As an educator dedicated to deeper learning, student well-being, and community engagement, I see this transition as a crucial step in ensuring that our school meal programs better serve Hawai‘i’s students and local farmers.

For years, the HCNP has played an essential role in monitoring the quality and compliance of school meals. However, its placement within the DOE creates an inherent conflict of interest—limiting its ability to function independently and advocate effectively for improvements. By relocating HCNP to the Department of Agriculture, we create an opportunity for greater objectivity, accountability, and most importantly, a stronger commitment to sourcing local food for our schools.

This bill also aligns with Hawai‘i’s broader commitment to food security and sustainability. Act 175 (2021) set a goal for 30% of school food to be locally sourced by 2030, yet bureaucratic barriers continue to make it difficult for our schools to prioritize local food purchasing.
