Thank you for the opportunity to testify on this bill. The Campaign Spending Commission (“Commission”) opposes this bill.

This bill amends Hawaii Revised Statutes (“HRS”) §11-302 by repealing the exemption for a candidate’s own funds from the definition of contribution. This would make a candidate’s use of the candidate’s own funds subject to the contribution limits in HRS §11-357. The measure amends HRS §11-359(b) by making contributions from the candidate’s immediate family also subject to the contribution limits. Finally, the measure amends HRS §11-371(a) by limiting the amount of a loan from a candidate’s own funds to \$2,000 and repealing the ability of a candidate’s immediate family to loan the candidate up to \$50,000 (aggregated with contributions) during an election period.

The Commission is especially concerned of the constitutionality of subjecting a candidate’s use of the candidate’s own funds to contribution and loan limits. These limits on the use of a candidate’s own funds would not prevent corruption or the appearance of corruption. The Commission suggests that this measure be deferred so that this committee can seek an opinion from the Department of the Attorney General

The Commission requests that this committee defer this measure.

Testimony in Support of Bill Relating to Campaign Finance HB 662

Dear Chair Tarnas, Vice Chair Poepoe, and Members of the Committee,

I wholeheartedly support the intent of HB 662, but I would like to highlight specific areas of improvement of proposed changes and additional suggestions for amendments.

The proposed \$2,000 aggregate loan limit for candidates' personal funds does not accurately reflect the financial demands of campaigns for various races and does not reflect current contribution limits for different races. Campaign costs differ significantly between local, district, and statewide races. Contribution and loan limits should be adjusted based on the scale of the race. Suggested adjustments include:

2 Year Terms: A loan limit of \$20,000 proportional to the \$2,000 max contribution limit

4 Year Terms, districts: A loan limit of \$40,000 proportional to the \$4,000 max contribution limit

Statewide campaigns: A loan limit of \$60,000, proportional to the \$6,000 max contribution limit, but to be honest, that realistically is not enough start up capitol for a professionally run race at that size.

These increased loan amounts ensure candidates have the resources to run competitive campaigns while maintaining reasonable limits. This becomes especially important when factoring in outside influence on a campaign and running along incumbents who have been allowed to accumulate large campaign account balances over their careers, which I am hopeful this committee can address with other bills that will be heard during this session.

The requirement that loans be repaid within one year is unnecessarily restrictive, especially given the limitations on when incumbents can raise funds during legislative sessions. Campaign fundraising often intensifies closer to the election date, which may fall outside the one-year repayment period.

I propose amending the repayment deadline to align with the end of the campaign spending reporting cycle. This adjustment will give candidates sufficient time to manage funds and repay loans without undue pressure or disadvantage.

The proposed aggregate loan limited to other individuals who are not the candidate or immediate family or financial institutions creates an inequitable standard that I find slightly concerning. If candidates can secure loans from others up to the proposed limit, they should be afforded the same limit for loans from their personal or family funds.

This would insure that first-time candidates and those moving into higher office can adequately finance campaigns, particularly in the early stages.

Lastly, I must reiterate that these changes would be an improvement, but they will not benefit anyone but those already with campaign money and in power and who have access to others with money and power. We must address candidate-to-candidate contributions and accumulation of campaign coffers, improve publicly funded options, and better regulate non-candidate committee expenditures.

Please consider incorporating these recommendations into the final version of the bill.

I am writing in support of HB 662, which places limits on the amount of loans that a candidate may receive from themselves and other parties.

Importantly, this bill repeals the provision where an immediate family member of the candidate may loan up to \$50,000, which is an excessive sum for given the costs of campaigns for non-statewide or county-wide offices.
