EOA's Position: The Executive Office on Aging (EOA), an attached agency to the Department of Health, **strongly supports HB705 HD1.**

Fiscal Implications: This measure appropriates funds for SFY 2025-2026 and the same sum for SFY 2026-2027 for one full-time equivalent (1.0 FTE) position within EOA and operating costs.

Purpose and Justification: The bill establishes a Medi-Medi pilot project within the Advocacy, Education, and Outreach Section (AEOS). The project will assist older adults, individuals with disabilities, Medicare beneficiaries, and underserved who may qualify for low-income subsidy programs to navigate and apply for eligible benefits. The project will assist individuals who already struggle to make ends meet, with benefits to offset their healthcare costs while keeping money in their pockets.

Hawai'i is No.1 in the nation with the highest cost of living as well as having the longest average lifespan at 80.7 years of age. Residents continue to struggle with the increasing costs for healthcare services and prescription drugs. Since the pandemic, the Department of Human Services (DHS) reported the number of Medicaid members rose 24.4% from 46,013 to 58,085. The Medicaid eligibility redetermination period began in 2023 and ended in December 2024. Throughout this period, a significant increase in the volume of calls, emails, website visits, and referrals were received from Med-QUEST and the Social Security Administration (SSA) to help those who lost coverage. Two staff and the volunteer counselors successfully addressed the demands, however, the program experienced slower than usual response rates.

Currently, this Section screens for eligibility for low-income subsidy programs such as Medicaid, Medicare Savings Program, and Extra Help. In addition, uninsured individuals are assisted in MarketPlace options and provide information and referrals to other assistance programs to address food, housing, or caregiving needs.

The benefits of the Medi-Medi project are threefold. First, individuals will have a streamlined and timely application process thus receiving benefits to offset their healthcare costs. Second, MedQuest will more time to work on eligibility renewals. Third, EOA will build its infrastructure. EOA's intent was to demonstrate this as a project and make it a permanent program in future years as these needs will continue to grow. By supporting the general funded 1.0 FTE for this project, EOA will be able to bill for Medicaid Administrative Claiming thus building a sustainable funding stream for ongoing operating costs.

We are proposing technical amendments for clarity by replacing Section 2(b) as follows:

- (b) The medi-medi project shall:
 - 1) Develop and implement a community outreach program,

- 2) Streamline the eligibility application process for various low-income subsidy programs, and
- 3) Provide referrals and assistance to other low-income programs.

Delete section 2(d).

Recommendation: EOA **strongly supports** this measure provided that its enactment does not reduce or replace priorities with the Administration's budget request.

TESTIMONY:

This bill establishes a temporary Medi-Medi Project within the Hawai'i State Health Insurance Assistance Program administered by the Executive Office on Aging to assist older adults, Medicare beneficiaries, individuals with disabilities, and other underserved populations who may qualify for various low-income subsidy programs to gain access to their benefits. The patients are dually eligible for Medicare and Medicaid. The bill requires the Executive Office on Aging to implement the project and reports to the Legislature.

The EOA Medi-Medi Project is 100% federally funded. And the need for these services is clear. EOA is willing to partner with DHS to expand services for older adults who face barriers in applying for low-income programs.

The benefits for kupuna and to us, obvious. The Project will increase access to trained help with eligibility and enrollment, ensure applications get submitted properly and timely. It should also benefit the Med-QUEST team by improving eligibility and renewal applications and related processing times for those who qualify for available services.

SHPDA defers to EOA on details and likely need for at least one staff. To overlook funding this request will be to overlook care that is federally funded for kupuna who need it.

I am in STRONG SUPPORT of HB 705 HD1. which is requesting funding for 1 full time employee and operating expenses to launch a Medi-Medi initiative. As a SHIP volunteer, I have experienced firsthand the need for education and assistance with low-income subsidy programs More and more beneficiaries are calling the helpline asking about programs to help pay for their health insurance and MedQUEST is heavily relying on community partners like SHIP/MIPPA to help beneficiaries with eligibility screening and application submission. With additional funding and 1 dedicated staff, the Executive Office on Aging can 1) Increase application assistance, 2) Streamline Medicaid/MSP/Extra Help enrollments, 3) Reduce wait times to submit applications, 4) Expedite processing time, and 5) Ensure applications are submitted correctly and received by MedQUEST. This would be especially beneficial to our kupuna, who are typically less adaptable to searching the internet for answers without help. And some of the people I have interacted with don't know enough to know what they don't know.
