

- 1 **Fiscal Implications:** The Department of Health ("Department") requests that this measure be
- 2 considered as a vehicle to provide this needed funding so long as it does not supplant the
- 3 priorities and requests outlined in the Governors executive budget request. The appropriation of
- 4 \$1,750,000 for fiscal year 2025-2026 and for fiscal year 2026-2027.
- 5 **Department Position:** The Department is in strong support of this measure and respectfully
- 6 offers the following comments.
- 7 **Department Testimony:** The Emergency Medical Services & Injury Prevention System Branch
- 8 (EMSIPSB) is submits this testimony on behalf of the Department of Health. Based on a detailed
- 9 review of emergency response data, we support adding an ambulance in West Hawaii to improve
- 10 access to emergency care.
- Between March 1, 2022, and December 31, 2024, there were 74,619 emergency incidents in
- Hawaii County. The Makalei area, consisting of the South West section of County District 8,
- accounted for 5,127 of these calls, about 7% of the total volume (See Figure 1 on page 3 of this
- document). Currently, emergency medical services (EMS) in Makalei rely on ambulances
- from Fire Stations 7 (Kailua-Kona), 12 (Keauhou), 14 (Kamuela), and 16 (Waikoloa). Fire
- Station 21 in Makalei does not have its own ambulance. Because of this, Fire Station 7, one of
- the busiest stations in the county, handles nearly 50% of all Makalei's emergency calls. This puts
- significant strain on emergency response in both Kailua-Kona and Makalei. Adding an

- ambulance in the Kailua-Kona area or directly at Fire Station 21 in Makalei would help provide
- 2 better coverage for both communities and address Kona's growing demand..
- 3 Looking at the downtime between calls for EMS units across the county, Fire Station 7 has one
- of the shortest times between calls—just 129 minutes. This makes it the second busiest EMS unit
- 5 in the county. In contrast, other stations, such as Fire Station 14, have more time between calls
- 6 (267 minutes), while Fire Station 16 has the longest downtime (305 minutes). This data confirms
- 7 that Fire Station 7 is under heavy demand and needs additional support.
- 8 Placing an ambulance at Fire Station 21 in Makalei would help reduce the burden on Fire Station
- 9 7, improve response times, and improve access to lifesaving care for residents and visitors in
- 10 County Districts 7, 8, and 9. It is important to recognize the growing demand for emergency
- 11 resources in Kailua-Kona, as these demands may require Fire Station 21, Makalei, to provide
- backup coverage.
- We recommend these findings be considered when determining the optimal location for a new
- ambulance unit to ensure the delivery of effective, efficient, and equitable emergency medical
- 15 services.

The Office of Hawaiian Affairs (OHA) **SUPPORTS** HB 784 HD 1 which makes an appropriation for the operation of an additional ambulance for the island of Hawai'i to be based in Makalei.

OHA is the constitutionally established body responsible for protecting and promoting the rights of Native Hawaiians. Among its statutory duties, OHA is required to (1) serve as principal public agency in the State of Hawai'i responsible for the performance, development and coordination of programs and activities relating to native Hawaiians and Hawaiians; (2) assess the policies and practices of other agencies impacting native Hawaiians and Hawaiians; and (3) conduct advocacy efforts for native Hawaiians and Hawaiians.

In fulfillment of its mandates, OHA seeks to advance policies, programs and practices that increase access to quality, culturally informed healthcare for Native Hawaiians. HB 784 will expand critical emergency medical services infrastructure and mitigate transportation barriers, which is crucial for Native Hawaiians who live in rural areas on the island of Hawai'i. Given the island's significant growth and aging population, an additional ambulance is necessary to help reduce death and disability among residents and visitors.

The Office of Hawaiian Affairs respectfully urges this committee to **PASS HB 784 HD 1**. Mahalo nui for the opportunity to testify.

I am writing in strong support of HB 784, which seeks to appropriate funding for an additional advanced life support (ALS) ambulance to be based in Makalei, North Kona. As Fire Chief of the Hawai'i Fire Department, I can attest to the critical need for additional EMS resources to meet the growing demand for emergency medical services on Hawai'i Island.

In West Hawai'i alone, ambulances cover a vast 1,922-square-mile area, responding to thousands of calls annually. Despite continued growth in population, tourism, and EMS call volume, the number of ambulances serving this region has remained the same. As a result, ambulance units are frequently overburdened, response times are increasing, and ambulances must often be pulled from surrounding districts to meet demand.

Adding an ALS ambulance in Makalei would directly improve public safety and emergency medical outcomes by:

- 1. Reducing response times, ensuring faster pre-hospital care for residents and visitors.
- 2. Alleviating strain on existing ambulances, preventing dangerous coverage gaps in North Kona, and Kailua.
- 3. Enhancing firefighter-paramedic readiness, reducing burnout and improving overall service delivery.
- 4. Strengthening Hawai'i's disaster resilience, ensuring EMS resources are better distributed for wildfire, hurricane, and mass casualty incidents.

Without immediate action, EMS resources in North Kona and Kailua will continue to be overstretched, leading to life-threatening delays for residents and visitors in need of urgent medical care. The data overwhelmingly supports the need for this additional resource.

I strongly urge the committee to pass HB 784 and invest in this critical expansion of emergency medical services for the island of Hawai'i.

My name is Jake Styner and I am writing this testimony in supporting of HB784. I am a firefighter, paramedic, and most importantly someone who personally lives in this community alongside numerous other family members and friends. As many others have stated, this ambulance has been long overdue. I have been stationed in Kailua for 3 years and served this community/district in various positions (paramedic, EMT, T/A FRS). During my time here I have come to find that a large chunk of our emergency responses are in district 21. Every other "district" on the island has a designated ambulance, however, district 21 does not and is instead taken care of by neighboring medical units (M07, M12, M06, and sometimes even M16 & M14). The palisades/kalaoa subdivisions are one of the most densely populated areas in Kona. Station 7 is already the busiest on the whole island statistically backed, yet we are the first in response for this community. Im sure you have all the numbers and stats available to look at but the simple fact is that there needs to be an ambulance at Makalei. There has been an exponential growth in call volume even just in the time that I have been stationed here, to the point where I feel like it is approaching gross negligence on part of the legislature for the County of Hawai'i by not have one for district 21. There's a saying, "stuff changes when stuff happens", I just feel it would be a shame for someones tragedy to have to be the catalyst to finally get the ALS ambulance support for an community that obviously needs it, and has obviously needed it for several years. I humbly ask for your understanding on the seriousness of this matter and please do the right thing. Get this ambulance funded and get the taxpayers of district 21 and County of Hawai the emergency services that they deserve!

On behalf of the Daniel R. Sayre Memorial Foundation, a 501 (C) 3 public Foundation, whose primary mission is to save lives in Hawaii, I am grateful for the opportunity to submit testimony in <u>strong support</u> of HB784 HD1.

This legislation seeks funding for an advanced life support ambulance to be stationed in Makalei, North Kona, to improve emergency medical outcomes. This ambulance is desperately needed to provide adequate emergency services to the citizens that dwell in North Kona and to alleviate the stress on the Kailua-Kona HFD EMS Station at Rescue 7, which currently serves a vast district ranging from Pu'uanahulu to Sea View Circle. This Foundation has been working for the past 20 years to secure an ambulance for this station, to no avail. The need for this service is becoming more critical and can no longer be put on a back shelf. The DOH has stated that the amount of calls for service in this area does not warrant a ambulance and I beg to differ with them. Many of us rush down to Emergency Care Clinics because we know that there is no ambulance available in our community and we take the ambulance from there to the hospital. That being said, I feel that the data that they are quoting is skewed and does not truly represent the actual need. When my shoulder was severely dislocated, I had to wait for an ambulance to come from Captain Cook to take me to the hospital. I live in Kaloko!!! My husband was picked up at the Emergency Care Clinic near Costco when he went into atrial fibrillation because we knew that no ambulance was available in our district to take him to Kona Community Hospital.

Per HFD Station 7 Captain Chad Sohriakoff's testimony:

"The District of Kona has experienced a significant increase in emergency calls due to population growth. The Kailua-Kona Station is the busiest Fire Station on the Island of Hawai'i. In 2024 alone, the Kailua-Kona Fire Station received over 4,550 emergency calls."

Currently, their emergency response system is under strain due to:

-Longer response times because of limited ambulances, putting lives at risk; overburdened EMS personnel leading to burnout and staffing challenges; delays in critical care where every second counts and can mean the difference between life and death.

The residents of North Kona deserve to have this critical access to care and we beseech you to please pass this Bill and help us to acquire this much needed ambulance.

I worked as a dispatcher for the Hawai'i Fire Department from 2018- 2022. There were days where there were simply no ambulance units available to send to calls in Makalei's district. This was attributed to the volume of calls Kona receives and the physical, geographic span of the districts. Patients would potentially wait for the next unit to clear from Kona Community Hospital, an additional 20 minutes or more, before beginning their own transport to the hospital. As we all know, minutes matter in medical emergencies. It can mean a difference in disability or death.


