HB 840 - RELATING TO UNIVERSITY OF HAWAII ATHLETICS

Chair Garrett, Vice Chair Amato, and Members of the Committee:

Thank you for this opportunity to submit testimony in support of HB 840 that relates to the appropriation of \$8,519,341 for University of Hawai'i Athletics. Within HB 840, the amount of the appropriation to the University of Hawai'i at Hilo Athletics Department (UH Hilo Athletics) is \$800,000 for fiscal year 2025-2056 and fiscal year 2026-2027 for the program and operations..

HB 840 will help UH Hilo Athletics offset significantly higher costs associated with competing in the Pacific West Conference. The primary increase in costs being travel related. Nearly 250 student-athletes and our coaches, in 12 intercollegiate athletic programs, serve proudly as Ambassadors of Aloha representing the State of Hawai'i, the University of Hawai'i at Hilo and our Big Island community.

In the past 18 months, the Pacific West Conference has expanded adding four more institutions which has increased the length and amount of our travel significantly. With the expansion, the Pacific West Conference has also added end of season conference championships in the sports of men's and women's soccer, women's volleyball, baseball and softball. The addition of these championships alone adds a significant travel expense. This in combination with increased and longer travel due to the addition of the four schools in the conference necessitates our request for the \$800,000 appropriation. In addition, as part of the Pacific West Conference, UH Hilo Athletics brings in teams to play in-state in front of Hawai'i residents

This appropriation will be appreciated and beneficial to all of our sports and studentathletes at the University. Funding would be used to offset costs that are uniquely higher than our competitors, for example:

1. **TRAVEL EXPENSES**: Nearly 70% of our operational budget is allocated to travel related costs. In comparison, our peers on the continent appropriate between 20-25% of their budget towards travel-related expenses.

2. **RECRUITING COSTS**: It costs UH Hilo significantly more than our peers on the continent to recruit student-athletes that can compete at the NCAA II level.

In addition, UH Hilo Athletics intends to utilize funds to expand student-athlete directed programs such as:

- 1. Nutritional programs (training table)
- 2. Augment athletic training services to improve health, wellness and safety of our student-athletes through strength and conditioning
- 3. Upgrade and enhance treatment and rehabilitation equipment for student-athlete health and wellness

HB 840 will assist in addressing these unique costs, which in turn will make UH Hilo Athletics more competitive while at the same time improve the overall student-athlete experience. As our current and future Ambassadors of Aloha, this is vitally important. This funding will also assist in bringing immeasurable benefits to the Big Island and Hilo community as a collective source of community pride in our program.

In addition, UH Hilo Athletics provides significant economic benefits to the State and the Big Island communities over the course of the year with various teams, families, students and visitors that our program attracts each and every year that stay in our hotels, rent their vehicles and dine at our local restaurants.

UH Hilo is grateful for the support from the legislature. This funding will go to the costs listed above and will directly benefit our student-athletes health and wellness, experience and their competitiveness in the sports they participate in.

We respectfully requests the passage of HB 840. Thank you for your time and consideration of this testimony.

HB 840 - RELATING TO UNIVERSITY OF THE HAWAII ATHLETICS

Chair Garrett, Vice Chair Amato, and Members of the Committee:

The University of Hawai'i at Mānoa (UH Mānoa) supports HB 840, which appropriates monies to athletics departments of the University of Hawai'i. This measure will help UH Mānoa athletics address the needs of our student-athletes and athletic program.

The request is to make permanent the \$3,200,000 in order to stabilize the operating budget from year to year. The money is used to supplement costs of women's athletics programs including costs related to team travel, game guarantees, recruiting, nutrition and supplies. Costs are continuing to rise significantly in the areas of team travel and nutrition. We are committed to complying with Title IX and the efforts of our women's sports teams and female student-athletes. Please consider that the Legislature has historically appropriated this level of funding to UH Mānoa Athletics for the last several years, but always as non-recurring funding. This bill will serve as another means to provide funding support for existing programs for nutrition, supplies, and operating expenses.

Our special fund continues to be depleted in the volatile landscape of collegiate athletics. Salaries for these positions that serve as core support for UH Manoa Athletics, compounded with the fringe benefit rates that we do not control, have a massive impact to our overall operating budget. Moving the source of funding for these positions will allow us to better serve our student-athletes, especially in the areas that directly affect their health and well-being (Athletic Trainers, Mental Health Counselor, and Strength and Conditioning).

Additional support is also needed to fund ongoing costs related to nutrition and stocking a fueling station for our student-athletes in the weight room in order to provide protein, and other nutrition for pre and post workout. This is an industry standard at Division I FBS institutions across the country. Lastly, the ability to award Alston funding plays a significant role in student-athlete recruiting and retention. Offering Alston awards to student-athletes who qualify is a common recruiting tool to be able to attract highly sought after student-athletes.

We continue to strive for greatness in proving opportunities for our student-athletes to play at the highest level of collegiate athletics and represent the University and State with pride and integrity.
