Bill Title: HB 0863 RELATING TO EDUCATION.

Purpose of Bill: Appropriates funds to the Department of Education for teacher-requested

classroom supplies.

Department's Position:

The Hawaii State Department of Education (Department) strongly supports HB 863.

Through an existing public-private partnership, the Department is able to provide teachers and students with financial resources to fund teacher-led projects for their classroom.

Through our public-private partnership, the Department is able to receive matching funds from individual donors, corporate partners, and foundation partners. Since 2007, 45,055 projects have been funded for 11,072 teachers. Of which, 21,208 projects have been funded for 8,035 teachers with Department funds. With the \$3,000,000 appropriation (and funds matched by donors), the Department estimates it may be able to fund 8,000 more projects next school year. The Department will have 13,000 teachers in the school year 2025-2026.

Funding to continue this program will support teachers with providing books, computers and tablets, art supplies, educational kits and games, lab equipment and other resources that they would not otherwise be able to purchase on their own.

Chair Woodson, Vice Chair La Chica, and members of the Committee:

The State Public Charter School Commission ("Commission") appreciates the opportunity to offer testimony in **SUPPORT of HB 863** which is to appropriate funds to the Department of Education for teacher-requested classroom supplies.

The Commission appreciates this measure and the support for public school teachers that it provides; it should be noted that charter schools would benefit indirectly from this through a modest increase in per pupil funding. Pursuant to the per pupil funding formula, an increase in funding to the department in the major general fund cost categories results in an increase in charter school per pupil funding. Also, per pupil funding is provided as lump sum funding to charter schools, so charter schools would have the discretion on using these additional funds for other expenses, not just classroom supplies.

The Commission is available to work with this committee, the DOE, and our public charter schools in moving this legislation forward. Thank you for the opportunity to provide this testimony.



HOUSE BILL 863, RELATING TO EDUCATION

FEBRUARY 4, 2025 · EDN HEARING

POSITION: Support.

RATIONALE: The Democratic Party of Hawai'i Education Caucus <u>supports</u> HB 863, relating to education, which appropriates funds to the Department of Education for teacher-requested classroom supplies.

According to the National School Supply and Equipment Association, public school teachers annually spend \$1.6 billion of their discretionary income on supplementary school supplies and instructional materials. On average, teachers surveyed spent a total of \$485 on school supplies and instructional materials, with more than 10 percent spending over \$1,000 of personal income each school year to educate their keiki. Those figures have risen as inflation has gotten worse. In September of 2024, our state's inflation rate was 4.2 percent, roughly 1.8 percent higher than the national inflation rate.

That trend is, if anything, worse in Hawai'i, which consistently ranks at the bottom in national teacher compensation studies. Pay cuts, rising health care costs, adjusted insurance co-pays, and the loss of the state's \$1,690-per-special-education-teacher classroom supply fund have all aggravated the financial burden borne by teachers' pocketbooks. In a recent survey conducted by HSTA, 47 percent of respondents cited personal expenditures between \$250 and \$500 each

year on classroom supplies, with many claiming expenditures in excess of \$1,000. Lawmakers

must take action to lighten their financial load.

Ensuring that educators do not have to pay for their own classroom supplies effectively increases

their purchasing power, puts money back into the local economy, and incentivizes the teaching

profession at a time when our state's high cost- of-living and low adjusted-average income levels

compel many would-be teachers to choose more highly compensated professions or, even worse,

leave the state altogether. Today, approximately half of Hawai'i's teachers leave our state's

classrooms every five years. Therefore, to recruit and retain quality teachers for our schools, we

should provide fiscal incentives that offset the inflationary cost of classroom supplies that support

the learning growth of our keiki.

Dear Chair Woodson, Vice Chair La Chica and members of the committee,

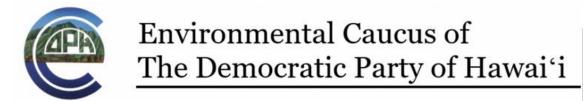
