I am Beverly Ann Gotelli, Chair, of the Policy Advisory Board for Elder Affairs (PABEA), which is an appointed board tasked with advising the Executive Office on Aging (EOA). My testimony does not represent the views of the EOA but of PABEA.

I STRONG SUPPORT of HR 175 /HCR 179 which convenes a legislative working group for a paid family and medical leave program for the state.

We are an aging population and must rely on our children to help with our well-being at the cost of losing their jobs.

It is important that the working group develop recommendations on a paid family leave policy and program that supports working family caregivers to better balance their job and family responsibilities, reducing their stress and allowing them to better support their loved ones

As I age, I wonder what will happen if I need my children to relocate so they can be my caregiver. Will this mean they will lose their current employment; will they be able to find a new job should they relocate. Will they be able to take paid family leave if available at their job site.
