Aloha Chair Lee, Vice Chair Inouye, Chair Wakai, and Vice Chair Chang,


[HCR205](#), is important to the community of Kihei/

Kihei (HD 11) has only 2 roads in and out (see Figure 1). It has been hit by 6 major floods causing significant damage and 3 ‘once in a century floods’ in the last 4 years. The current Kulanihako‘i bridge was meant to be a temporary structure, and is now outdated and exacerbating repeated flooding damage to businesses and homes. This is an urgent issue, as Kihei is suffering repeated floods on a regular basis.

I have included images of recent flood damage and flood events in South Maui from our last major flood, this year.

I hope that you will please consider passing resolution so we can urge for this bridge to be replaced. With my appreciation,
