Chair Rhoads, Vice Chair Gabbard, and members of the Senate Judiciary Committee:

I strongly support Rochelle Vidinha's nomination to serve as a district family court judge.

When I was first assigned to the Sexual Assault Team, I was not looking forward to the job. I had interned with the unit and had some inkling of what the cases involved. The crimes were disturbing. Prosecutions could take years. The statutes and the case law were always changing. But I accepted the post because the supervising attorney was stellar. I knew her and trusted her.

As an intern, I watched Rochelle Vidinha prosecute a continuous sexual assault case. These cases involve child molesters with recurring access to the victim. These are among the most challenging cases to try. Trials always come with surprises. This one was no different; an expert witness needed to testify earlier than expected. But Rochelle was prepared, and the new order did not rattle her at all. When the victim testified, Rochelle questioned her with patience and kindness. The little girl told a roomful of strangers about crimes no child should ever experience.

When the defendant took the stand, Rochelle did not shout or badger him. She did not need any crude inquisitorial tools. Her preparation, her attention to detail, and her confidence in the truth were all that were required. She carefully and thoroughly picked apart his story, catching details many had missed. By the time cross-examination was over, it was clear how the jury would find.

So years later, I had faith in Rochelle when I took the assignment. And that faith was rewarded. Rochelle Vidinha was an excellent Team Captain. She promptly trained me on search warrants, grand juries, and the intricacies of vertical prosecution. I saw the thorough preparation she brought to her cases. Many times, victims were initially reluctant to speak about the crimes. Rochelle would simply ask them about their lives. She cared about them as people, not simply names on a witness list or an evidence sheet.

Rochelle also treated defendants with fairness. That can be especially hard in sexual assault cases, where the crimes are completely despicable. But before becoming a prosecutor, Rochelle worked as a probation officer. She understood defendants as human beings too. Serious accusations, she stressed, deserved the highest evidentiary standards. She did not cut corners or take the easy way out. She was a minister of justice, not a demagogue or a bully.

Rochelle has exceptional knowledge of the law. But the judiciary is not simply a scholastic calling. It is a public trust. I have seen Rochelle's integrity and judgment constantly tested under extreme circumstances. Not once has she failed. Her compassion for victims, her fairness to defendants, and her fidelity to the great ideal of justice—those irreplaceable aspects of character are what recommend her to the bench. I have complete confidence in her.

Our office will lose so much when she is gone, but the benefit to the Hawai'i bench and to the whole community will be worth it.

This nomination is truly a fitting capstone to Chief Justice Recktenwald's career. I am so proud to join in support.

I highly recommend Deputy Prosecuting Attorney Rochelle Vidinha to the judiciary. Frankly, this letter is somewhat bittersweet as I do not want to lose Ms. Vidinha as my supervisor. She serves as the Team Captain of the Sexual Assault Team in my Department. Since assuming this position five years ago, Ms. Vidinha has remained very humble; she has not in any way abused her position of power. Instead, she inspires the other members of our team to do our very best.

There is a difference between a supervisor and a leader; Ms. Vidinha is definitely a leader. She leads by assigning some of the most difficult and problematic cases to herself. She leads by taking those cases to trial and addressing the concerns of victims, witnesses, defense attorneys and partner agencies, fairly and professionally. Although Ms. Vidinha has extensive experience in the courtroom, including jury trials and other proceedings, she recognizes that sometimes, the best resolution of a case is not a guilty as charged verdict, but resolving the case so that the victim does not need to testify, and the defendant can get treatment and put his life back together.

Ms. Vidinha displays the utmost professionalism towards everyone with whom she comes into contact. Because she is a sex crimes prosecutor, the adult victims or the parents/family of minor victims can sometimes be emotionally distraught and/or difficult to work with. Mr. Vidinha is extremely patient and compassionate. She is able to take an emotionally charged situation where tensions are extremely high and address what is important to all parties. She does so with compassion and grace. As supervisor of the Sexual Assault Team, she must do so not only with her own case load, but quite often, with the cases of those whom she supervises.

Ms. Vidinha would be a definite asset to the judiciary. She is recognized in the legal community as a person of integrity and trustworthiness. She takes seriously the prosecutor's duty to do justice. I would regret seeing a valued colleague leave my Department, and her departure would definitely be a great loss to our team, in particular.

Thank you for the opportunity to share the Hawaii State Bar Association (HSBA) Board of Directors' comments on JC 31, Nomination of Rochelle I. Vidinha for the District Court of the First Circuit.

After a rigorous process, described below, the HSBA Board of Directors concluded that Ms. Vidinha is **QUALIFIED**. Ms. Vidinha has considerable experience in the public sector as a Deputy Prosecuting Attorney and Supervising Prosecuting Attorney. She has demonstrated her commitment to public service, her community, and to survivors of violence, abuse, and neglect for much of her professional life. She has considerable jury trial experience and experience with settling contentious litigation.

The HSBA Board of Directors followed its multi-step process to arrive at its conclusion, which included:

- The nominee was notified of the HSBA appointment review process, which includes a questionnaire requesting educational credentials, legal and other professional work experiences, and personal references; a resume; a copy of the Judicial Selection Commission (JSC) application; a form authorizing disclosure from the Office of Disciplinary Counsel of any disciplinary action; and an interview with the HSBA Board of Directors.
- The HSBA membership received an electronic notification of the appointment and a request for comments on the nominee.
- A neutral fact-finding body comprised of three HSBA Board members was called upon to review documentation submitted by the nominee, contact references submitted by the nominee review comments received from the HSBA membership, conduct follow-up for clarification, if necessary, and prepare a report for the HSBA Board.
- Ms. Vidinha submitted documentation, which was reviewed, and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Ms. Vidinha in all categories of the
