Aloha nui to the committees addressed above,

My name is Ka'imipono Inofinada and I was born and raised in Kalihi, O'ahu. I am currently a senior at Hālau Kū Māna Public Charter School. I have written this testimony regarding Senate Bill 1051 and my full intention of supporting it. Coming from the perspective of a Native Hawaiian student enrolled in a charter school that designates Hawaiian culture and values as its core education, I write this testimony regarding Senate Bill 1051 regarding its intentions and fully support the passing of the bill in the legislature. Through the possibility of it passing, I hope to see the perpetuation of Hawaiian History and the commemoration of Queen Lili'uokalani grow in school systems.

Since my enrollment as a student in Hālau Kū Māna, I have learned so many components and stories of our history and Her Majesty Queen Lili'uokalani and of her prominence to the Hawaiian people. It is of no mistake that she is revered in our community due to her

actions taken in order to preserve Hawai'i Nei. While it is unfortunate that the actions of the Overthrow were plotted and enacted against Her Majesty 132 years ago, the ripple effects still affect the Hawaiian Kingdom and Hawai'i itself as a whole.

If I was enrolled in a DOE school system as I had been before being enrolled in Hālau Kū Māna, it is a possibility that the topic of the Overthrow and Queen Lili'uokalani would not be as taught commonly in a classroom, if even taught at all. If this were to happen, I would not be able to fully understand my history and identity and the importance of knowing such components. It is unfortunate that the same is still currently happening in school systems statewide.

Through the passing of Senate Bill 1051, it would not only recognize September as Hawaiian History Month and honor Her Majesty Queen Lili'uokalani but also spread more awareness and inspire the telling of our stories of this land to more audiences in the islands, especially to our people. The story of our people and kingdom should be known to every Native Hawaiian man, woman, and child but not excluding other ethnicities and kingdom subjects present in the islands.
