1 **Fiscal Implications:** \$75,000 general fund appropriation.

2 **Department Testimony:** The Department of Health (DOH) supports the intent of SB1246,
3 which is to ensure access to reproductive health and family planning services. DOH is actively
4 working with community partners to secure a supply of mifepristone. SB1242 may supplement
5 those efforts by securing additional doses.

6 The department recommends amendments that permit the greatest degree of flexibility and
7 options as the situation develops.



Aloha Chair San Buenaventura, Vice Chair Aquino, and Committee Members,

I am testifying in support of SB 1246, which directs the Department of Health to purchase and store a 1-year supply of mifepristone by working with one or more pharmacies in the State. All people in Hawai‘i – regardless of income, gender identity, or type of insurance – should have access to the full range of preventive sexual and reproductive health services. Chairperson Senator Joy A San Buenaventura and Vice Chair Senator Henry Acquino,

Thank you for the opportunity to offer comment on SB 1246. We provide testimony on behalf of our professional member organization, the Hawai'i Affiliate of the American College of Nurse-Midwives (HAA), whose mission is “to promote the health and well-being of women and newborns within their families and communities through the development and support of the profession of midwifery as practiced by Certified Nurse-Midwives (CNMs) and Certified Midwives (CMs).” Within our stated purpose is to support legislation related to women’s health issues and to represent official positions of the ACNM.

IN SUPPORT WITH COMMENT FOR SB 1246

ACNM’s Position Statement regarding “Access to Comprehensive Sexual and Reproductive Health Care Services (2016)” affirms the following:

Everyone has the right to make choices regarding sexual and reproductive health (SRH) that meet their individual needs.

Everyone has the right to access factual, evidence-based, unbiased information about available SRH care services in order to make informed decisions.

Access to SRH care services should be available and affordable for those with limited means.

Parenting, adoption, and abortion are all legal and appropriate SRH options within the ethical context of self-determination.

Midwifery care includes fertility assessment and support of those who seek pregnancy.

Midwifery care includes support of individuals who choose to not become pregnant as part of their reproductive life plans.

As providers of SRH care, midwives may provide abortion care as expanded scope of practice depending on scope of practice regulations and credentialing approval in the state.

The HAA Board is in strong support of SB 1246 relating to healthcare. In light of increasing federal restrictions on access to comprehensive sexual and reproductive health care services which includes access to standard of care pharmacologic treatment for elective abortion, the HAA Board, in alignment with ACNM official positions, supports protection of the right to privacy and bodily autonomy of individuals in Hawai'i via stockpiling mifepristone, an abortifacient medication, in alignment with other states in the regions such as California and Washington.

It is unclear after the initial investment of the State, will the doses be for sale or available for all. The bill mentioned in-person care is not available on all islands. Will Hawai'i tax payers equally benefit from this investment? Is there a way to equally protect access? The bill could be amended to indicate how the doses would be dispensed. Furthermore, will the State be reimbursed? For taxpayers who may not feel in alignment with the position stated above regarding access to care, a mechanism for State reimbursement could seek to address this philosophical debate.

Mifepristone allows pregnant individuals to make timely decisions about their reproductive health, reducing the need for more invasive and costly procedures later in pregnancy, which often requires traveling by plane for people who do not live on O'ahu. When people can control their reproductive futures, they can better provide for and nurture their existing children. Research consistently shows that the majority of individuals seeking abortion care are already parents, making it clear that reproductive healthcare is family care. This bill supports parents in making decisions that best serve their families' well-being, stability, and economic security by ensuring continued access to mifepristone.

Additionally, a proactive approach to securing a mifepristone supply strengthens our public health infrastructure by mitigating the risks of legal or logistical barriers that may arise in the future. States that have taken similar measures recognize that access to medication abortion is an essential component of comprehensive healthcare and a fundamental right.

I urge you to pass **S.B. No. 1246** to protect access to critical reproductive healthcare and uphold the rights of individuals and families to make the best decisions for their lives and well-being. Mahalo for your leadership in advancing reproductive justice and ensuring that all residents of Hawai'i have access to the care they need.

The American College of Obstetricians and Gynecologists (ACOG) Hawai'i Section supports **Senate Bill 1246 (SB1246)**, which takes a crucial step in protecting reproductive health access by directing the Department of Health to stockpile a one-year supply of **mifepristone**, ensuring continued availability of medication abortion in the state.

Hawai'i has a long-standing commitment to reproductive rights, being the first state in the nation to decriminalize abortion at the request of the patient in 1970. The Hawaii State Legislature has repeatedly expressed a commitment to protecting reproductive rights since then. However, recent shifts in the legal and political landscape, particularly the *Dobbs v. Jackson Women's Health Organization* decision, have placed reproductive autonomy under threat across the country. As other states impose severe restrictions and potential civil or criminal liability for providing or receiving abortion care, Hawai'i must take proactive measures to safeguard access for its residents.

SB1246 upholds Hawai'i's policy of protecting bodily autonomy and access to reproductive health services by:

1. **Ensuring a Supply of Mifepristone** – Given that 63% of abortions in Hawai'i are medication-based, any disruption in the availability of mifepristone could severely impact patient care. By stockpiling a one-year supply, the Department of Health can ensure continuity in reproductive health services despite potential **regulatory, legal, or supply chain disruptions**.
2. **Addressing Geographic Barriers to In-Person Abortion Care** – In-person abortion care in Hawai'i is not available on every island, and residents face significant logistical and financial burdens to access this care. Medication abortion, which can be prescribed and administered remotely, is a vital option for those in rural and neighbor island communities. Ensuring an adequate stock of mifepristone supports equitable access for all individuals, regardless of location.
3. **Proactively Safeguarding Reproductive Rights in Hawai'i** – Other states, including **California, New York, Massachusetts, and Washington**, have already taken steps to **stockpile medication abortion drugs** as a protective measure.

Protecting access to essential reproductive healthcare aligns with Hawai'i's long-standing values of **privacy, autonomy, and equity in health services**. For these reasons, **ACOG Hawai'i Section supports SB1246**.

We appreciate your leadership in advancing reproductive health protections in our state. Please do not hesitate to reach out if we can provide more information.

Dear Senator Joy A. San Buenaventura, Chair, Senator Henry J.C. Aquino, Vice Chair and the Members of Committee,

Members of *Indivisible Hawai'i* thank you for this opportunity to testify in strong support/support of SB 1246 which would create a stockpile of the abortion medication Mifepristone to assure that, regardless of action taken at the federal level, Hawai'i's residents still have access to essential reproductive health services. We also recommend that the Department of Health collaborate and share resources with states that have experience with stockpiling mifepristone, such as California and Washington State – if they have not already done so.

Mifepristone is used in over 60% of U.S. abortions. Mifepristone is now available from certified providers via mail and at pharmacies for use up to 10 weeks' gestation. However, women's access to mifepristone still largely depends on state law, with only about half of U.S. states allowing full access. In 2023, several states led by Democratic governors, including Massachusetts, California and Washington State began stockpiling doses of drugs used in medication abortions, amid fears that a court ruling could restrict access to them. Most stockpiled mifepristone, which has a shelf life of 5 years. California also stockpiled misoprostol, with a shelf life of 2 years. California reported in June 2024 their stockpiles had been depleted. As of October 2024, at least two states, Washington State and Massachusetts, maintain a stockpile of mifepristone.

In June 2024, the Supreme Court (SCOTUS) issued a ruling that (temporarily) left current laws and regulations in place. A battle is right now being waged in the lower federal courts re: access to and restrictions on mifepristone specifically, and abortion essentially. **In the same way that recent SCOTUS rulings have required Hawai'i to fundamentally reshape its gun laws, so federal rulings and restrictions could suddenly and significantly impact abortion access in our state.** As early as 2025, restrictions on medication abortion could come from federal courts, SCOTUS, Congress and/or the Executive branch. The Republican majority in Congress may attempt to enforce old **Comstock laws that ban the mailing of contraceptives and abortifacients**, and will use this as a basis for a nationwide ban of abortifacients, including mifepristone and misoprostol. Therefore, we respectfully request that Hawaii's legislature act with all due speed to create a state medication abortion stockpile in order to protect the rights and health of all women and families in Hawai'i nei.

Thank you for considering my testimony on SB1246, Relating to Health Care.

The language used in this bill, uses a very hypothetically notion that the supply of mifepristone and misoprostol will be in short supply or outlawed in production due to the Federal Government ending the funding of abortions. This is comical in nature and downright misleading in focus.

First, these drugs are a money maker for the drug companies, they are not going to stop the drug's supply and the federal government is NOT going to prohibit manufacturing of these drugs; as a capital-based economy, demand always drives supply. Several states promote abortion-using drugs so demand will remain high....!

Second, isn't the Hawaiian state budget strapped, meaning, the legislature is looking for ways to reduce the budget and pull from one account to support expenditures to another account. How, with Medicaid claims exceeding funds, is the legislature going to allocate \$75,000 for mifepristone and/or misoprostol? Where are the funds coming from? How's recovery of Maui coming along?

Third, how many pills does \$75,000 buy? An internet search revealed the average cost of these two drugs is approximately \$0.05 apiece. As I understand, discounts based upon purchase quantity are also available bringing the cost down to around \$0.03 apiece. Taking these costs into consideration that means overtime, the state will buy and store 1,500,000 mifepristone pills. Referring to the Mifepristone drug guide available through the FDA, only one mifepristone

is needed along with a second drug to end an abortion. Is the Hawai'i state legislature supporting the ending of 1,500,000 pregnancies?

Fourth, what is the 'shelf-life' of mifepristone averages is about 5 years. Of course, as I understand it, mifepristone loses its potency (efficacy) over time.....implying that.....consuming mifepristone may or may not work to end a pregnancy as advertised; resulting in a medical emergency at best.
