SUBJECT: SB1284 – Proposing an Amendment to Article 1, Section 5, of the Hawai'i Constitution Relating to Due Process and Equal Protection

The Hawai'i State Council on Developmental Disabilities SUPPORTS SB1284, which proposes an amendment to the state constitution to prohibit discrimination based on ethnicity, age, disability, religion, national ancestry, sex, sexual orientation, gender identity, pregnancy, and pregnancy outcomes.

For individuals with intellectual and developmental disabilities (I/DD), ensuring due process and equal protection is vital for their full participation in society without fear of discrimination. ### TESTIMONY TO THE SENATE COMMITTEE ON JUDICIARY

Senate Bill 1284 – Proposing an Amendment to Article 1, section 5

The Disability and Communication Access Board (DCAB) supports Senate Bill 1284 – Proposing an Amendment to Article I, Section 5 of the Hawaii Constitution Relating to Due Process and Equal Protection.

This bill proposes to expand the existing list of groups that are protected from discrimination to include persons with disabilities, among others, in alignment with various federal civil rights laws. Federal laws have ensured civil right protections through acts such as the Civil Rights Act of 1964, Fair Housing Act of 1968, Individuals with Disabilities Education Act of 1975, Rehabilitation Act of 1973 (specifically section 504), Age Discrimination Act of 1975 and finally, the Americans with Disabilities Act of 1990. These federal laws prohibit discrimination. Enshrining these same protections into the State Constitution would be a powerful symbol of Hawaii's commitment to equality.

The passage of these statutes has been instrumental in breaking down barriers that once excluded individuals with disabilities from education, employment, transportation, and public life. They have opened up opportunities for people with disabilities to pursue higher education, secure meaningful employment, and navigate public spaces with greater independence and confidence.

Incorporating these protections into the Hawaii State Constitution would further emphasize Hawaii's commitment to ensuring that individuals with disabilities have equal access to opportunities and can fully participate in all aspects of society. This measure would provide a lasting affirmation of Hawaii's dedication to building a more accessible future for people with disabilities.

Aloha Chair Rhoads, Vice Chair Gabbard, and esteemed Members of the Committee:

My name is Abby Simmons, Chair of the Stonewall Caucus of the Democratic Party of Hawai'i, and I am I am testifying on behalf of our Caucus in strong support of SB1284, a proposed amendment to Article 1, Section 5 of the Hawaii State Constitution, to ensure explicit **protections against discrimination based on sexual orientation, gender identity, pregnancy, and pregnancy outcomes.**

#### **Why This Amendment is Necessary:**

Hawai'i has long been a leader in protecting civil rights, but our constitution must reflect the evolving understanding of equal protection and human dignity. SB1284 strengthens our commitment to fairness and inclusivity by ensuring that all individuals—regardless of their gender identity, sexual orientation, or reproductive choices—receive the same protections as other protected groups.

#### 1. Explicit Constitutional Protection Matters

- While federal and state laws provide some protections, constitutional amendments create lasting safeguards that cannot be easily overturned by shifting political climates.
- By adding sexual orientation, gender identity, pregnancy, and pregnancy outcomes to Hawaii's constitution, we affirm that no person should be treated as less than equal under the law.

## 2. Protecting LGBTQ+ Rights

- Discrimination based on sexual orientation and gender identity continues to be a reality in employment, housing, healthcare, and public accommodations.
- By enshrining these protections in our constitution, Hawaii sends a clear message: All individuals, regardless of who they love or how they identify, are entitled to full and equal protection under the law.

## 3. Defending Reproductive Freedom

- In light of recent national threats to reproductive rights, it is critical that Hawaii upholds its commitment to protecting pregnant individuals from discrimination.
- No person should face employment discrimination, denial of healthcare, or biased treatment based on their pregnancy status or reproductive choices.
- SB1284 ensures that decisions about pregnancy, childbirth, and reproductive healthcare remain personal and free from discrimination.

## **Hawai'i Must Continue to Lead on Civil Rights**

As one of the most diverse states in the nation, Hawai'i has a moral responsibility to ensure that our laws reflect the values of equality, dignity, and respect. Passing SB1284 would solidify our state's commitment to justice and fairness for all, regardless of gender identity, sexual orientation, or reproductive decisions.

For these reasons, I strongly urge the committee to pass SB1284 and allow the people of Hawai'i to vote on this important amendment.

Members of AAUW of Hawai'i thank you for this opportunity to testify in strong support of S.B. 1284, proposing a constitutional amendment to prohibit discrimination against a person because of ethnicity, age, disability, religion, national ancestry, sex, sexual orientation, gender identity, pregnancy and pregnancy outcomes.

The current Equal Protection Provision in the Hawai'i State Constitution only protects against discrimination based on **race, religion, sex or ancestry**. Art. I, Sec. 5 Due Process and Equal Protection Clause.

S.B. 1284 would add these additional categories for protection against discrimination: ethnicity, national origin, age, disability, sexual orientation, gender identity, gender expression, pregnancy, and pregnancy outcomes. These additional categories are also protected under Hawai'i state employment discrimination law.

Including these additional categories in the state constitution:

- ensures that individuals belonging to these groups are afforded equal protection under the law. This protection is crucial for upholding civil rights and preventing discrimination based on immutable characteristics.
- sends a strong message about Hawaii's commitment to equality and inclusion. It establishes a legal foundation for promoting diversity and fostering a society where all individuals are treated with dignity and respect.
- acknowledges past and current injustices against certain groups, e.g., pregnant people, ethnic minorities, LGBTQ+ individuals, people with disabilities, Kupunas, etc., and signals a commitment to rectifying them through legal protection and equal treatment.
- establishes a clear standard for evaluating laws and policies to ensure they do not discriminate against individuals based on these protected characteristics.

- serves as a safeguard against the enactment of discriminatory legislation that targets or disproportionately affects individuals based on their ethnicity, national origin, age, disability, sex, sexual orientation, gender identity, gender expression, pregnancy, or pregnancy outcomes.
- reflects evolving societal values and norms regarding equality, diversity, and inclusion. It demonstrates a commitment to adapting legal frameworks to align with changing perspectives and addressing emerging issues related to discrimination and equality.
- ensures that individuals who experience discrimination based on these characteristics have legal remedies and recourse available to them. It strengthens their ability to challenge discriminatory practices and seek justice through legal avenues.

S.B. 1284 will foster a more inclusive and equitable society, where individuals are treated fairly and have equal opportunities regardless of their immutable characteristics.



Due to time constraints, I will focus on the gender identity portion of the bill. Biological boys/men often have a physical advantage over girls/women in competitive sports. Girls/women have been seriously injured playing against trans athletes. Last year, a trans athlete spiked a volleyball, and caused a female athlete, Payton McNabb, to suffer a serious brain injury, paralysis and a host of other physical problems. These trans women have sexually assaulted and raped women. They have been caught staring at the women when they shower, and making lewd comments to them. Convicted child molesters and sexual predators are being allowed to be in the same cell as women. Women have complained about it to the guards, but often, little is done right away. Sometimes the abuse goes on for months.

The legal implications of this component of the bill are not clear. Last week Friday, the DOE scrapped Biden's executive order rewriting Title IX so that trans persons were protected against discrimination. President Trump also issued executive orders stating that sex discrimination does not apply to gender identity.

In addition to actions of the DOE and President Trump, I ask that you respectfully consider the women's rights of privacy, their safety and well-being, and protect them from sexual, verbal, emotional and physical abuse. Kindly vote no on SB 1284. Thank you.
