1 **Fiscal Implications:** Estimated annual administrative cost of a Universal Immunization Funding  
2 Program is anticipated to be \$2.8 – \$3.6 million, which is expected to be covered by the costs  
3 saved on immunization purchases by leveraging large contracts that provide economies of  
4 scale. One-time program start-up costs are estimated to be approximately \$934,000. Various  
5 funding models can be explored for coverage of start-up and ongoing operational costs of this  
6 program, including models which are entirely self-sustaining. In any of these models, the  
7 measure will decrease reliance on uncertain federal funding for branch operations, and can be  
8 scaled should the federal Vaccines for Children program be disrupted.

9 **Department Position:** The Department strongly **SUPPORTS** this measure and offers comments.  
10 The purpose of this measure is to establish a collaborative, self-sustaining, “universal” funding  
11 model for immunization purchases by the Department of Health Immunization Branch to  
12 enable streamlined procurement, oversight, distribution, accountability, and reporting for all  
13 persons under the age of 65, regardless of insurance status (public/private). Namely, providers  
14 take on considerable risk because of the need to pay for their private sector immunization  
15 supplies up front, as well as incurring other expenses such as secure and temperature-  
16 controlled storage. A universal purchasing program will reduce the financial and administrative  
17 burden to health care providers and create economies of scale that can reach more patients

1 than the current uncoordinated model. By centralizing public and private sector immunization  
2 procurement and leveraging bulk purchasing power through Federal or State consortium  
3 contracts, this initiative would lower private-sector costs and improve access to needed  
4 immunizations for all keiki, families, communities, and healthcare providers statewide. This  
5 initiative addresses increasing disparities between publicly and privately insured individual's  
6 access to immunizations and reinforces Hawai'i's commitment to preventive health care, cost-  
7 effective public-health infrastructure, and data-driven decision-making – key pillars of our  
8 nationally-recognized healthcare system.

Testimony:

SHPDA strongly supports creating a Universal Immunization Funding Program managed by the Department of Health (DOH) to assure access to vaccines for individuals in the State who are not eligible to receive immunizations at no cost through other programs. Establishes the Universal Immunization Purchase Special Fund into which fees will be deposited to finance the Universal Immunization Funding Program.

SHPDA defers to the DOH on the amount of appropriation estimated to be needed.

Aloha Chair Dela Cruz, Vice Chair Moriwaki, and Committee Members,

The American Academy of Pediatrics, Hawai‘i Chapter, which represents more than 200 pediatricians across our islands, would like to express our strong support for SB1434, Relating to Universal Immunization Funding Program.

As you know, vaccines are one of the greatest public health advances of all time and have saved over 150 million lives around the world. They are also highly cost-effective. According to one study, the lifelong cost of measles or rubella disease is approximately 100x the cost of vaccination.<sup>1</sup> Our keiki rely on vaccines to protect them from devastating diseases such as measles, pertussis (whooping cough) and meningitis. Vaccine access is more important than ever today, in light of potential threats to Medicaid funding and the growing measles outbreak in rural West Texas, which has already claimed the life of one unvaccinated child and infected over 120 people, many of whom have required hospitalization.

Despite the known benefits of vaccines, many community pediatricians in Hawai‘i struggle to stock vaccines due to high upfront costs and take significant losses if vaccines are not used by their expiration date. Additionally, community pediatricians caring for privately insured patients are not able to access the lower prices at which the Vaccines for Children (VFC) vaccines are able to be bulk purchased. SB1434 would alleviate both these problems. By creating a state vaccine purchase program, Hawai‘i would be able to access lower pricing for all our keiki, not just those who receive vaccines through VFC. Additionally, pediatricians and family physicians would be relieved of the burden of trying to estimate how many vaccines they will use in a given time period and the risk of wasting vaccines that are not used before their expiration date. This, in turn, would promote increased access to all recommended vaccines, reduce cost and disruptions to a families' schedules (for additional visits for vaccines if they are not in stock at the first visit), and help to keep our keiki healthy. It is imperative that we maximize efforts to ensure access to vaccines for all of Hawai‘i during this legislative session.

BILL NUMBER: SB 1434 SD 1

INTRODUCED BY: Senate Committee on Health and Human Services

EXECUTIVE SUMMARY: Establishes the Universal Immunization Funding Program for the purpose of administering immunizations to individuals in the State who are not eligible to receive immunizations at no cost through other programs. Establishes the Universal Immunization Purchase Special Fund into which fees will be deposited to finance the Universal Immunization Funding Program.

SYNOPSIS: Adds a new part to chapter 321, HRS, for a Universal Immunization Funding Program (Program) that would allow the Department of Health to manage the supply of immunizations. The Program is expected to lower health care providers' administrative costs and ensure immunizations can be quickly supplied during emergencies or immunization shortages.

Defines "Assessed entity" as any insurer in the State, that is not federally funded, issuing individual and group accident and health or sickness insurance policies, individual or group hospital or medical service plan contracts, and nonprofit mutual benefit society, fraternal benefit society, and health maintenance organization health plans.

Defines "Assessment" as the association member liability with respect to immunization costs determined in accordance with this part.

Defines "Immunization" as any preparation of killed microorganisms, living attenuated organisms, living fully virulent organisms, or part thereof, or any other treatment intended to trigger an immune response that is authorized by the United States Food and Drug Administration, recommended by the national Advisory Committee on Immunization Practices of the federal Centers for Disease Control and Prevention, or has been authorized for purchase by the director for the purposes of producing or increasing immunity to particular diseases. "Immunization" includes any other substance designated as immunization by order of the director of health.

Defines "Provider" as a person licensed by the State to administer immunizations or provide health care services or a partnership, corporation, or other entity made up of those persons.

Establishes the Universal Immunization Purchase Special Fund (Fund) into which fees, fines and cost reimbursements paid by Assessed entities will be deposited. Expenditures from the Fund shall be used to purchase immunizations, at no cost to Providers, to administer to individuals who are not eligible to receive immunizations at no cost through other programs.

The Fund will be administered and expended by the Department of Health. The Director shall determine regular immunization assessment rates and may make changes to the assessment collection mechanism.

The measure provides an appropriation of \$\_\_\_\_\_ out of general revenues, or so much thereof as may be necessary, into the Fund for fiscal year 2025-2026.

EFFECTIVE DATE: July 1, 2050.

STAFF COMMENTS: This is an Administration bill sponsored by the Department of Health and designated HTH-18 (25).

The 1989 Tax Review Commission noted that use of special fund financing is a “departure from Hawaii’s sound fiscal policies and should be avoided.” It also noted that special funds are appropriate where the revenues to the funds maintain some direct connection between a public service and the beneficiary of that service. The Commission found that special funds which merely set aside general funds cannot be justified as such actions restrict budget flexibility, create inefficiencies, and lessen accountability. It recommended that such programs can be given priority under the normal budget process without having to resort to this type of financing.

This bill creates a special fund to administer a newly created Program to manage the supply of immunizations to ensure immunizations can quickly be supplied to vulnerable patient groups during emergencies or shortages.

Special funds are pots of money that exist for a specific purpose and largely bypass the legislative appropriation process. The existence of hundreds of these special funds has often confounded those who seek answers to simple questions like “How much money does the State have?”

Our Legislature is supposed to be the steward of all state moneys, but special funds make it very easy to lose track of where the money is and how it is being spent. Departments are supposed to tell the Legislature if they have special funds and how much is in them, but let’s just say they don’t always. Recently, in Report No. 20-01, the State Auditor took DBEDT to task for failing to report \$6.5 million in non-general fund moneys. DBEDT’s response? Just that they’ll “take corrective action.” Not even a “Whoops! We screwed up and promise to do better next time!” This followed closely on the heels of Report No. 19-16, where the Auditor found that \$1.04 million in non-general fund moneys administered by the Attorney General wasn’t reported. That department responded that they “shall establish procedures to assure required reports are issued.” Is it any wonder that it’s getting harder and harder to follow the money and rein in government spending?

Perhaps as a result of the foregoing concerns, the Legislature has itself established criteria for when a special fund may be maintained (HRS section 37-52.3). Those criteria are that the special fund:

(1) Serves a need, as demonstrated by:

(A) The purpose of the program to be supported by the fund;

(B) The scope of the program, including financial information on fees to be charged, sources of projected revenue, and costs; and

(C) An explanation of why the program cannot be implemented successfully under the general fund appropriation process;

(2) Reflects a clear nexus between the benefits sought and charges made upon the program users or beneficiaries or a clear link between the program and the sources of revenue, as opposed to serving primarily as a means to provide the program or users with an automatic means of support that is removed from the normal budget and appropriation process;

(3) Provides an appropriate means of financing for the program or activity that is used only when essential to the successful operation of the program or activity; and

(4) Demonstrates the capacity to be financially self-sustaining.

In this bill, the apparent plan is to impose a new charge on “assessed entities,” namely health insurers and health plans, to fund a program to make bulk purchases of vaccines. The Health Department, in its justification sheet accompanying the measure, complains that private providers take on considerable risk because of the need to pay for immunization supplies up front, as well as incurring expenses such as secure and temperature-controlled storage. It believes that a universal purchasing program will reduce administrative burdens to the providers and create economies of scale that can reach more patients than the current uncoordinated model. “The Department's ability to leverage highly competitive federal immunization purchasing contracts may result in lower overall costs to Hawaii's health system,” the justification sheet continues, “as well as increased rates of immunizations that will lower incidences of immunization-preventable diseases.”

Even if all this is true, the new special fund, program, and fee basically constitute a new tax on health insurers and plans to fund bulk purchasing of vaccines along with reimbursing the Department of Health for its costs for things like secure and temperature-controlled storage. The normal and proper process would be for a new tax to be enacted, and for the proceeds to be legislatively appropriated out to the Department of Health for this program. There is no need to subvert the normal appropriation process to service this, as opposed to any other, health program or, for that matter, any other program administered by any other department. Establishing this special fund is inappropriate, and we question the need for a new tax to finance the program.

If the real problem is inability of the existing tax system to reach some of the entities targeted by this bill, perhaps because of well-entrenched exemptions such as those for mutual benefit

societies (section 432:1-403, HRS) and fraternal benefit societies (section 432:2-503, HRS), then those exemptions need to be reexamined.

SB1434 is a direct violation of our rights found in the U.S. Constitution and the Hawaii State Constitution.

**Government Overreach**

As a retired health care professional and a consumer of health care, we are entitled to Informed Consent and have the right to refuse any medical intervention including immunizations in any circumstances. Government shall not determine the need for immunizations.

**Big Pharma Profit Scheme**

Tax dollars should not be used to purchase immunizations. The only entities that will benefit from a Universal Purchase (UP) program are big pharmaceutical companies.

**U.S. Constitution**

SB1434 is a violation of our religious freedom. Our first amendment protection of religious liberty cannot be subjugated by state law. Americans have the right to refuse any order, medicine, or procedure that violates their religious beliefs as well as anything that is immoral or unethical according to their well-informed conscience.

SB1434 assumes that adults and children will be participating in immunization programs. No one shall be mandated to participate. **Hawaii State Constitution**

Section 4. No law shall be enacted respecting an establishment of religion, or prohibiting the free exercise thereof, or abridging the freedom of speech or of the press or the right of the people peaceably to assemble and to petition the government for a redress of grievances.

**LATE**

The Libertarian Party of Hawaii is in **strong opposition** to the proposed Universal Immunization Funding Program. We believe that this bill raises several concerns that contradict the fundamental principles of individual rights.

This bill paves the way for universal forced vaccinations, making them responsible for covering the costs of state-mandated vaccinations. Remember just a few years ago, they forced Hawaii's population to take part in illegal and inhumane experimental mRNA gene therapy which was mislabeled as a vaccine for the laboratory-engineered virus which triggered the state's overreaction. They forced us to show proof of vaccination or face total deprivation of human rights. The same irresponsible and unaccountable authoritarians in office now, unsurprisingly, want to pave the way for future abuses. This measure is falsely labeled as public health policy, while they simultaneously push to remove religious exemptions - another grave violation of human rights.

- 1. Financial Strain on Assessors:** Imposing assessment fees on insurers and other entities could result in heightened operational costs, which can easily trickle down to the consumer.



2. **Privacy and Data Security:** The requirements for reporting “covered lives” and immunization data raise serious privacy concerns, jeopardizing the security and confidentiality of personal health information.
3. **Lack of Accountability and Oversight:** The centralized management of funds through the Universal Immunization Purchase Special Fund raises questions about accountability, transparency, and potential misuse of resources.
4. **Public Distrust:** Implementing a program that is mandatory risks further erosion of the already lacking public trust in healthcare institutions.
5. **Economic Distortions & Malinvestment:** government interventions into the free market always come with common unintended consequences, including persistent malinvestment, price distortions, consumer abuses, racketeering, interference with liability, and many other problems.

The only real solution for Hawaii to make medicine sustainably affordable is to get the government out of healthcare and insurance altogether, and in general to make the state government stop its constant usurpations of power from individual market participants.

The Libertarian Party of Hawaii advocates for individual liberty, free markets, and limited government intervention. We believe that this bill is governmental overreach and threatens the core values of personal freedom. I write in strong opposition to SB1434, which seeks to establish a state-run Universal Immunization Funding Program. While I recognize the importance of public health, this bill represents an unnecessary expansion of government power, undermines individual medical freedom, distorts market competition, and imposes financial burdens on businesses and consumers.

This bill **grants the Hawai‘i Department of Health unchecked authority** to control vaccine procurement and distribution, setting a dangerous precedent for government intrusion into personal medical decisions. Private-sector supply chains are more agile and responsive in adapting to shortages or emergencies than a rigid, state-run system. By monopolizing vaccine distribution, this bill removes incentives for efficiency and flexibility in the private market.

I strongly urge you to **VOTE NO** on S.B. No. 1434, which establishes the Universal Immunization Funding Program in Hawaii. Fiscal hawks on the Republican side and budget-minded Democrats should see the red flags: our hard-earned tax dollars deserve transparency and restraint, not a free-for-all fund for bureaucrats.

**Crushing Fines and Audits Target Small Businesses**

The bill slams insurers and providers with fines up to \$1,000 per day per offense (§321- Reports and audits (d)) and invasive audits for missing its convoluted reporting requirements (§321- Reports and audits (a)). In Hawaii's tough economy, this hits small businesses and healthcare practices hardest—folks who can't afford extra red tape or penalties. I am Tiare Smith, a Native Hawaiian and resident of Kahalu‘u, O‘ahu, where I have lived for 45 years. As a proud member of this community, deeply rooted in the cultural and natural heritage of our islands, I write to express my resolute opposition to Senate Bill 1434, which proposes the establishment of a Universal Immunization Funding Program. While the intent to bolster public health infrastructure may appear laudable on its face, a closer examination reveals that this legislation is precipitously flawed—both in its conception and its potential consequences. It threatens to disenfranchise Hawaii’s residents, undermine individual autonomy, and impose an unwieldy bureaucratic apparatus antithetical to the values of our diverse and resilient communities.

First, SB1434’s funding mechanism, predicated on assessments levied against health insurers and translated into per-child and per-adult “covered lives” costs, represents a regressive burden that will inevitably cascade to families already grappling with Hawaii’s exorbitant cost of living. The bill’s assertion that these assessments will reduce administrative costs for providers is specious at best; it conveniently elides the reality that such costs will be shifted onto consumers through higher premiums or reduced coverage options. For Native Hawaiian families like mine, who have long navigated systemic economic disparities, this additional financial strain is not merely inconvenient—it is unconscionable. The department’s discretionary authority to impose interim assessments during vaguely defined “public health emergencies” further exacerbates this concern, granting unchecked power to extract funds without sufficient public oversight or accountability.

Second, the bill’s centralized approach to immunization procurement and distribution erodes the agency of individuals and healthcare providers to make informed, context-specific decisions. By mandating state-supplied immunizations and disallowing providers from utilizing private stocks, SB1434 supplants professional judgment and patient preference with a one-size-fits-all paradigm. This is particularly troubling for Native Hawaiian communities, where trust in government-led health initiatives has been historically strained by past overreaches and cultural insensitivity. My 45 years in Kahalu‘u have taught me that health solutions thrive when they respect the diversity of our people—not when they impose uniformity under the guise of

efficiency. The bill's vague promise to maintain "available choices" rings hollow when the state retains unilateral control over which immunizations are deemed acceptable.

Third, the establishment of the Universal Immunization Purchase Special Fund, while framed as a prudent fiscal safeguard, invites inefficiency and opacity. The inclusion of reserves up to ten percent and discretionary "working capital" allocations, coupled with the department's ability to accrue interest on unpaid assessments, suggests a structure more attuned to self-perpetuation than public benefit. Moreover, the provision for fines—up to \$1,000 per offense, with each day constituting a separate violation—imposes a draconian penalty on entities that may struggle to comply with the bill's labyrinthine reporting requirements. This punitive framework risks alienating the very stakeholders—insurers, providers, and patients—whose cooperation is essential to any successful health program.

Finally, I must underscore the broader philosophical implications of SB1434. Hawaii's strength lies in its people's ability to navigate challenges collectively, drawing on our cultural wisdom and communal bonds. This legislation, however, represents a disconcerting shift toward top-down control, subordinating individual rights to an expansive state apparatus. For a Native Hawaiian like myself, whose ancestors thrived through self-determination and mutual care, this approach is not merely impractical—it is antithetical to the spirit of aloha that defines us.

In conclusion, I urge the Senate to reject SB1434. Its fiscal imprudence, erosion of autonomy, and bureaucratic overreach threaten to undermine the very public health goals it purports to advance. Hawaii deserves policies that empower its people, not ones that encumber them with untested mandates and hidden costs. After 45 years of calling Kahalu'u home, I implore you to honor the voices of residents like me and preserve the integrity of our healthcare landscape.

Dear Members of the Hawaii State Legislature,

I am writing to express my opposition to Senate Bill 1434, which proposes the establishment of a Universal Immunization Funding Program and the creation of the Universal Immunization Purchase Special Fund. While I acknowledge the importance of public health initiatives, I have several concerns regarding this bill.

1. Financial Implications

The bill seeks to appropriate funds from the state’s general revenues to finance the Universal Immunization Funding Program. However, the exact amount required remains unspecified, raising questions about the potential financial burden on taxpayers. Implementing such a program without a clear budget could lead to unforeseen expenses, especially considering the startup operations and initial procurements estimated at \$934,000.

2. Redundancy with Existing Programs

Hawaii already benefits from federal and state immunization programs that provide vaccines to eligible individuals at no cost. The introduction of a new program may duplicate existing efforts, leading to inefficient use of resources. Instead of creating a new funding mechanism, it would be more prudent to assess and enhance the effectiveness of current programs to ensure broader coverage and accessibility.

3. Administrative Challenges

Establishing and managing a new special fund and program would necessitate additional administrative infrastructure. This could divert resources from other critical public health services and introduce complexities in program oversight and accountability. Streamlining existing services might achieve the desired outcomes more effectively without the need for new bureaucratic layers.

#### 4. Public Opposition

It's noteworthy that during committee hearings, a significant number of individuals—173 in total—submitted testimony opposing this measure. I urge the legislature to reconsider this proposal and explore alternative strategies that build upon and optimize existing programs, ensuring fiscal responsibility and public trust.

I am an ICU physician here in Hawai'i, caring for both pediatric and adult critically ill patients and I strongly support this bill, as both a physician and as a parent.

As the COVID pandemic taught us, access to immunizations is critical to assuring that vulnerable populations can be protected from communicable diseases. The COVID vaccines were initially complicated and expensive to store and administer, meaning that most private physician's offices were unable to offer them (thus creating challenges for the public to access them). As a result, even now, it can be very difficult to find a provider willing to provide up to date COVID immunizations. On top of that, reimbursement from private insurers does not adequately cover costs of vaccine administration to private physicians, creating a disincentive to vaccines being offered. Indeed, my own family members have struggled to find providers willing to administer immunizations. This is a failure of the public health system in this state.

This bill will assure access to immunizations in Hawai'i by eliminating the financial barriers that prevent access. On top of that, it will save the state and the health care system money. My name is Tashya Whitehead, MD, a physician with the Queens Health System, and I appreciate the opportunity to submit testimony in support of SB1434, Relating to Universal Immunization Funding Program.

Hawai'i faces the risk of a significant crisis of vaccine-preventable disease outbreaks due to unvaccinated children. During the 2023-24 school year, 21% of the students from public, charter, and private schools were not up-to-date on their school-required immunizations, which represents a 25% increase from the 2022-23 school year [source: DOH]. Maintaining 95% vaccination coverage is essential for preventing measles outbreaks. For instance, according to CDC data, if measles coverage rate dips to 93%, there is a 36% chance of an outbreak if an infectious child were to attend school. If measles coverage rates dip to 85%, that risk of an outbreak exponentially increases to 61%. These statistics represent the difference between containment and a potential epidemic. As an outpatient general pediatrician, these statistics are terrifying, and we need to find a way to make all vaccinations easily accessible to everyone.

SB1434 would unburden healthcare providers by centralizing and leveraging economies of scale in immunization purchasing, hence improving access to immunizations for everyone in the state. After initial state investment, there are several business models in a self-sustaining public/private partnership, which is sustainable even if federal funding for immunization programs were to be unavailable.

I respectfully and strongly urge the Committee see fit to pass SB1434. Thank you for the opportunity to testify
