Department Testimony: The Department of Health (DOH) Child & Adolescent Mental Health
Division (CAMHD) strongly supports this bill. It has been 50 years since the Mental Health
Services for Children and Youth statutes have been codified. The amendments proposed by this
bill bring the statute up to date to reflect the current role of the Child & Adolescent Mental
Health Division in addressing intensive mental health needs of children and adolescents in
Hawaii.
Although originally a branch of the Adult Mental Health Division, Child & Adolescent Mental

8 Health became its own Division of the Department of Health decades ago as research emerged about the distinct and specialized nature of child and adolescent mental health services. Today 9 CAMHD is the state's Medicaid provider for intensive mental health services for children and 10 11 adolescents with a serious emotional disturbance (SED). CAMHD works collaboratively with other child-serving agencies and has developed a comprehensive array of treatment services for 12 13 youth with SED via Purchase of Service contracts. Mental health assessments, clinical oversight and care coordination are provided by employees at Family Guidance Centers on Oahu, Hawaii, 14 15 Maui, and Kauai. In addition, the Family Court Liaison Branch on Oahu provides mental health services to youth who are incarcerated or detained. This system of care is based on core values to 16 17 provide child and family-centered, culturally sensitive, least restrictive and evidence-based mental health services. Over the past 30 years, CAMHD has leveraged federal system of care 18 19 grants to actively develop and improve the child and adolescent mental health service system of care in Hawaii based on national standards and best practices. 20

- 1 In 2023, CAMHD partnered with the University of Hawaii, School of Public Health to conduct a
- 2 five-year statewide needs assessment of mental health services for youth. The final assessment
- 3 report is expected by December of 2027. Once completed, this assessment will be used to
- 4 develop a Child & Adolescent Mental Health Services Plan.

Comments:

To the extent this bill is primarily a housekeeping bill we don't have much to add. However, we want to point out that the mental health services provided to children in the state suffer from a lack of resources and a lack of coordination between the Department of Health and the Department of Education. The fragmentation does not serve the children well and one of the main problems is that there are not adequate facilities or services for children, which at times forces them to be sent out of state in order to obtain treatment. We would urge both CAMHD and the Legislature to do more than simple housekeeping amendments and undertake the effort to actually provide more and better services than they currently do.
