Dear Chair San Buenaventura and Vice-Chair Aquino and Members of the Health and Human Services Committee:

Members of AAUW of Hawai'i thank you for this opportunity to testify in strong support of S.B. 350, proposing an amendment to article I of the Hawai'i Constitution to protect a person's right to obtain contraceptives and engage in contraception.

The right to contraception is protected by *Griswold v. Connecticut*, 381 U.S. 479 (1965), and *Eisenstadt v. Baird*, 405 U.S. 438 (1972). In *Griswold*, the U.S. Supreme Court recognized that the constitutional right to privacy includes the right of married people to obtain contraceptives, and in *Eisenstadt*, the U.S. Supreme Court extended the constitutional protections in *Griswold* to unmarried persons.

However, *Dobbs v. Jackson Women's Health Organization*, 597 U.S. 215 (2022), opens the door to challenges to the right to contraception.<sup>1</sup>

Access to contraceptives and the right to engage in contraception is a medical necessity for many women. "The American College of Obstetricians and Gynecologists (the College) supports access to comprehensive contraceptive care and contraceptive methods as an integral component of women's health care and is committed to encouraging and upholding policies and actions that ensure the availability of affordable and accessible contraceptive care and contraceptive methods."<sup>2</sup>

Hawai'i has long been a leader in advancing reproductive rights and advocating for access to affordable and comprehensive sexual and reproductive health care without discrimination. The right to obtain contraceptives and engage in contraception is critical for the health and economic security of all people in Hawai'i. S.B. 350 is prudent policy that will improve the overall health and economy of the State's communities.

**Testimony in Strong Support of Senate Bill [350]** PROPOSING AN AMENDMENT TO THE HAWAII CONSTITUTION TO PROTECT THE RIGHT TO CONTRACEPTION.

Aloha Chair San Buenaventura, Vice Chair Aquino, and esteemed Members of the Committee:

My name is Abby Simmons, Chair of the Stonewall Caucus of the Democratic Party of Hawaii, and I am testifying on behalf of our Caucus in strong support of SB350, which proposes an amendment to the Hawaii Constitution to explicitly protect the right to contraception.

#### **Why This Amendment is Necessary**

Access to contraception is a fundamental component of personal autonomy, reproductive freedom, and public health. By enshrining this right in our state constitution, Hawaii ensures that individuals can make private, informed decisions about their health without government interference.

Protecting the Right to Contraception is Essential for:

SB350 is a common-sense measure that upholds individual freedom, promotes public health, and protects personal privacy. I urge this committee to pass this bill and give the people of Hawai'i the opportunity to vote on protecting their reproductive rights in the state constitution.

Thank you for allowing Indivisible Hawai'i this opportunity to testify in **support of HB350** which will allow to be placed on the next election ballot a Constitutional Amendment to protect the right to obtain or use contraceptives. This testimony was also submitted in support of HB297.

The right to contraception is protected by two landmark Supreme Court decisions, *Griswold v. Connecticut* (1965) and *Eisenstadt v. Baird* (1972). We once thought the right to abortion was settled law in *Roe v. Wade*, but that was overturned by a conservative Supreme Court. Should either or both of the contraceptive protection decisions be overturned, each state will need to protect contraceptive rights in the state constitution.

This bill demonstrates prudence and good judgement, and hopefully will never be tested. But if needed, it will be in Hawai'i's Constitution to protect the rights of all in Hawai'i.

## SENATE BILL 350, PROPOSING AN AMENDMENT TO THE HAWAII CONSTITUTION TO PROTECT THE RIGHT TO CONTRACEPTION

FEBRUARY 5, 2025 · HHS HEARING

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus supports SB 350, which proposes an amendment to Article I of the Hawai'i Constitution to protect a person's right to obtain contraceptives and engage in contraception.

Reproductive care is an essential form of healthcare. In March of 1970, Hawai'i became the first state to legalize abortion, three years before the landmark *Roe v. Wade* decision by the United States Supreme Court protected access to abortion nationwide. In so doing, the state recognized that preserving access to safe and legal reproductive care is a vital public health objective for the islands. Yet, Hawai'i's unique geography and high cost of living present barriers to obtaining reproductive care for potential patients. As of 2022, only three abortion providers exist in the islands and only Oahu and Maui host reproductive care clinics. According to Planned Parenthood, the number of abortion providers in the state has been on the decline since the 1990s.

Moreover, studies show that access to abortion care is linked to financial well-being. According to The Turnaway Study conducted by Advancing New Standards in Reproductive Health at the University of California San Francisco, people who were denied access to an abortion experienced an increase in household poverty lasting at least four years relative to those who

received an abortion. Women who lacked access to reproductive care were also found to be less able to pay for basic living expenses, had lower credit scores, and had higher rates of debt and eviction than those with access to abortion care.

The U.S. Supreme Court's disastrous ruling in *Dobbs v. Jackson Women's Health Organization* overturned *Roe v. Wade* and ended the federal constitutional right to abortion care. In overturning *Roe v. Wade*, the U.S. Supreme Court erased nearly fifty years of legal precedent supporting the fundamental right to reproductive freedom, leading to a wave of abortion restrictions enacted by state legislatures across the country. The Court's decision disproportionately harms black, latino, indigenous, and other people of color, for whom access to healthcare and economic opportunities has historically been impeded by systemic racism.

Fifteen states—California, Colorado, Florida, Illinois, Massachusetts, Michigan, Minnesota, New Jersey, New Mexico, Ohio, Oregon, Rhode Island, Vermont, and Washington, plus the District of Columbia—have statutory or constitutional protections for the right to contraception. Donald Trump has already signaled his intent to erode the right to contraception. As part of Trump's first week in office, he reinstated the "Global Gag Rule", a sweeping policy that will decrease abortion access in countries around the world. This far-reaching policy defunds health organizations in other countries that provide abortion services or information, even for victims of sexual assault. Government agency webpages about HIV, LGBTQ+ people, and other public health topics—including contraception—have also been taken down because of Trump's executive orders aimed at "gender ideology" and diversity, equity and inclusion programs.

**In response to the Supreme Court's catastrophic ruling in *Dobbs v. Jackson Women's Health Organization* and further attacks on abortion care that are expected to be made by the Trump administration, state policymakers must take action to uphold Hawai'i's legacy as a leader in advancing reproductive care and support measures to strengthen reproductive rights in the islands.** Accordingly, we support empowering the people of our state to defend reproductive care for generations to come.



Hawai'i Family Forum is a non-profit, pro-family education organization committed to preserving and strengthening families in Hawai'i. We have deep concern regarding SB350 due to its use of broad terminology and because we feel that amending the constitution is unnecessary as these rights are already protected under existing law.

### **Overly Broad and Ambiguous Language**

SB350 employs vague terminology that invites extreme interpretations. By using the term "person" instead of "woman" or "adult," the bill could undermine parental notification laws, potentially allowing minors under 14 to access contraceptives without parental knowledge or consent. This raises concerns about future legal ambiguity regarding the definition of "person" and its application in reproductive health policies. We also hold concerns that religious organizations and/or people with deeply held religious convictions could be forced to provide services that are contrary to their religious tenets.

### **Hawai'i Law Already Protects Contraceptive Access**

SB350 falsely suggests that Hawai'i's constitution must "further the right to privacy," creating unnecessary confusion for voters. This phrasing implies that such a right is incomplete or at risk—when in reality, it is already well established. Women in Hawai'i have unrestricted access to abortion, contraception, and pregnancy-related medical care. Even Planned Parenthood Action confirms: "Abortion is legal in this state. Very few to no restrictions exist, and abortion is accessible."<sup>i</sup>

### **Conclusion**

SB350 is unnecessary, as it introduces vague policy language while preemptively shutting down future legislative efforts aimed at protecting life and family. This bill does not expand rights—it misleads the public and attempts to enshrine redundant policies into law. "

Good Afternoon, Senate Members. My name is Ayman El-Swaify and I am OPPOSED to SB350.

This Senate Bill proposes a new Hawaii Constitutional Amendment to “to protect a person's ability to seek and obtain contraceptives and to engage in contraception.”

It also gives the justification that 15 states “have [such] statutory or constitutional protections.” I submit that the argument “others have done it” is not a sufficient basis legislation. And even if someone felt it were, the corollary to this statement is that 35 states do not have this.

The language in the proposed amendment is vague and open to very broad interpretation, for example, “access by all persons” can easily be interpreted to include minors without parental consent.

The definition of contraceptive in the bill includes things “specifically intended to prevent pregnancy or for other health needs...” Other health needs” could be interpreted to include almost any type of alleged need, including irreversible gender mutilation surgery.

I therefore appeal to you – please OPPOSE SB350. It is unnecessary and introduces risk to the health of keiki and others in Hawaii.

Hawai'i Health & Harm Reduction Center (HHHC) **strongly supports** SB 350, which amends the Hawai'i State Constitution to protect a person's right to obtain contraceptives and engage in contraception.

The Guttmacher Institute, which is committed to advancing sexual and reproductive health and rights, has noted that contraception may be at serious risk if the recommendations of Project 2025 become federal policy through erosion of the federal contraceptive guarantee in the Affordable Care Act (ACA). In short, [the plan would make it easier for any employer to exclude contraceptive coverage from its health plan](#). This may make the costs of contraceptive care prohibitive for many employees when the ACA guarantee [has a record of "dramatically reducing patients' costs and helping them to use the birth control method of their choice and to use it effectively."](#)

While this constitutional amendment is a welcome development, far too many in this state still have difficulty accessing reproductive healthcare services, especially on the neighbor islands. Further state investment is needed to expand access to these vital services in an equitable fashion.

HHHC's mission is to reduce harm, promote health, create wellness, and fight stigma in Hawai'i and the Pacific. We work with many individuals impacted by poverty, housing instability, and other social determinants of health. Many have behavioral health problems, including those related to substance use and mental health conditions, and have also been deeply impacted by trauma related to histories of physical, sexual, and psychological abuse.
