**Testimony in OPPOSITION to SB0644**  
**RELATING TO WATER QUALITY.**

1 **Fiscal Implications:** The Department of Health (“Department”) requests that this measure be  
2 considered as a vehicle to provide this needed funding so long as it does not supplant the  
3 priorities and requests outlined in the Governors executive budget request.]

4 **Department Position:** The Department opposes this measure with comments.

5 **Department Testimony:** The Environmental Management Division, Safe Drinking Water Branch  
6 (EMD-SDWB) provides the following testimony on behalf of the Department.

7 Regulated public water systems continue to deliver safe water to Hawai‘i’s residents.  
8 Hawai‘i is consistently an excellent performer delivering drinking water which meets the  
9 National Primary Drinking Water Regulations due mostly in part to being blessed with good  
10 source water. The continued vigilance under the existing authority maintains safe distribution  
11 of the water to the greater public and does not need to be extended, with additional authority,  
12 and would be duplicative with the County permitting and infringe on the property of a private  
13 residence.

1           The measure proposes to provide the Department with the authority to access and test  
2 water quality in both residential and commercial buildings on public and private property. The  
3 current authority of the Department does not extend past the water meter onto private or  
4 public property. The Department regulates the drinking water quality distributed by the public  
5 water system purveyor who supplies the drinking water up to their consumers water meters.

6           The Department does not regulate the drinking water quality within private or public  
7 properties. The water quality in premise plumbing is impacted by use of the sampling point or  
8 tap (e.g., kitchen sink, bathroom sink, utility sink, etc.) within a private or public property and  
9 may not be reflective of the water quality provided by the water purveyor to the property. The  
10 mixing of hot water and the potential for line stagnation also creates a complex change in water  
11 chemistry which cannot be differentiated between water that represents the premise or  
12 distribution lines. In addition, water quality in a building's premise plumbing will change due to  
13 construction material type, as well as the operation, maintenance, and management of the  
14 building's cold and hot water plumbing system.

15           The regulation of plumbing and associated water quality at the tap is facilitated through  
16 building and plumbing codes as well as County building permits. Enforcement of such standards  
17 is delegated to the County as unsafe conditions, post-construction, may impact public health  
18 and safety.

19           Premise plumbing is unique to the property and tap water test results cannot be  
20 definitively determined to be the responsibility of a water purveyor unless expensive and  
21 extensive measures are taken to identify the origin of the detected contaminant. The lineal  
22 footage of premise piping nationally is four times that of the lineal footage of water distribution  
23 piping managed by a water purveyor. As such, the risk for drinking water quality issues is much  
24 higher in premise plumbing which is not the responsibility of a water purveyor.

1           An evaluation of the effort and expense of the proposed widespread testing indicates  
2 that it is not practical or executable. There are approximately 568,000 housing units in the State  
3 of Hawai'i. By comparison, the U.S. Department of the Navy (Navy)'s Joint Base Pearl Harbor-  
4 Hickam and U.S. Department of the Army's Aliamanu Military Reservation water systems serve  
5 9,800 units (residential and commercial). Due to the 2021 jet fuel contamination, the Navy is  
6 committed to analyze one test suite of 40 compounds for each building. It would cost up to  
7 \$1.02 billion if every house in Hawai'i were tested once for the same suite of 40 compounds.

8           Chapter 342D, Hawaii Revised Statutes (HRS), for water pollution pertinent to the Clean  
9 Water Act, and Chapter 11-54, Hawaii Administrative Rules (HAR) for Water Quality Standards,  
10 are not the appropriate regulation and rule to be cited. Chapter 340E, HRS, regulates drinking  
11 water quality and water purveyors under the Safe Drinking Water Act. As previously stated, the  
12 standards of construction to ensure potable water in premise plumbing is regulated under  
13 plumbing codes and approved by the County through building permits.

Subject: Senate Bill 664: Relating to Water Quality

The Honolulu Board of Water Supply (BWS) strongly supports Senate Bill (SB) 664.

This measure proposes to expand the duties and powers of the Department of Health (DOH) relating to water quality and water testing to ensure compliance with water quality standards and protect public health and the environment. The bill also directs DOH to adopt rules pursuant to chapter 91 and appropriates funds to carry out the purposes of the measure.

Jet fuel and fire suppressant chemical leaks from the Red Hill bulk fuel facility have resulted in detecting many kinds of chemical contaminants in water samples from Navy waterlines and the environment. Many do not easily degrade and/or linked to severe health issues highlighting the need for the State to take the lead in managing a comprehensive water quality testing program. This measure will improve our surveillance and understanding of our exposure to chemical contaminants to better protect public health and the environment.
