Dear Chair Rhoads, Vice-Chair Gabbard, and Honorable Committee members:

I serve as the President of the State of Hawaii Organization of Police Officers ("SHOPO") and write to you on behalf of our Union in strong opposition to SB 971 SD1, which proposes significant changes to the handling of unlicensed drivers by law enforcement officers. While we recognize the intent of this bill to enhance public safety, we believe that as currently drafted, the bill poses several challenges that could adversely affect law enforcement operations and officer safety.

As you know, our county police departments are experiencing a critical staffing shortage. The requirement for officers to ensure that a vehicle is moved by a licensed driver or towed at the owner's expense places an undue operational burden on law enforcement. Officers are already tasked with numerous responsibilities during traffic stops, and adding the obligation to arrange for vehicle removal without discretion will most certainly detract from their primary duties of ensuring public safety and enforcing the law.

In addition, because it is common for one tow wagon to work a large area, wait times for tow trucks to respond to accidents average about thirty minutes. Thus, the bill's provisions would prolong traffic stops, increasing the time officers spend on the roadside, thereby elevating the risk of accidents or confrontations.

In conclusion, while SHOPO supports efforts to improve road safety, we believe that SB No. 971 SD1, in its current form, presents significant challenges that could hinder law enforcement operations and compromise officer safety. We urge the legislature to consider alternative approaches that balance public safety with practical enforcement measures.

Thank you for considering our perspective on this important issue.

The State of Hawaii one some of the <u>highest rates of fatal car crashes involving an</u> <u>unlicensed driver</u> in the nation, with nearly <u>one-fifth of all fatal crashes</u> involving an unlicensed driver. OahuMPO supports the effort to remove unlicensed drivers from our roadways to reduce motor vehicle crashes and fatalities.
