The Department of Transportation (DOT) **supports** this resolution and continuing the work of the Water Carriers Working Group established by Senate Resolution 125 in 2020.

In the final report of the Water Carriers Working Group, Recommendation No. 3 is the Federal/State/County Subsidies Working Group and Recommendation No. 4 is the Federal Waterborne Cargo Subsidies Program. This resolution addresses both and requests a report on the status of these subsidies prior to the next Regular Session of the legislature. To expedite this work, DOT recommends a reduction of the size of the working group to no more than five members excepting DOT, provided that the working group consult with additional parties prior to the transmittal of the report to the legislature.

Aloha Chair Lee, Vice Chair Inouye, and Members of the Committee:

Thank you for the opportunity to submit testimony on behalf of Young Brothers, LLC ("YB")<sup>1</sup> offering **STRONG SUPPORT** for Senate Concurrent Resolution No. 150.

This resolution requests the Hawaii State Department of Transportation ("HDOT") to convene a working group and lead committees to develop and recommend federal, state, and county programs to subsidize the transport of waterborne cargo.

During the 2020 legislative session, the Hawaii State Senate adopted Senate Resolution No. 125, S.D. 1 (2020), requesting the PUC to convene a working group to discuss and recommend solutions to ensure continuous water carrier service throughout the State, balanced with the need for water carriers to maintain financial sustainability. Said working group (the Hawaii Water Carriers Working Group, hereinafter "HWCWG") was comprised of 18 key stakeholders from both the public and private sectors<sup>2</sup> and met 13 times from August 2020 through October 2021 to gather background information on water carriers, Hawaii's harbor system, and regulatory oversight of water carriers.

YB is currently the only water carrier authorized to transport property under Chapter 271G, Hawaii Revised Statues ("HRS") (i.e., the Hawaii Water Carrier Act), subject to the regulatory authority of the Public Utilities Commission of the State of Hawaii ("PUC"). Since 1900, customers across Hawaii have relied on YB's frequent, regular, and universal sailings to serve as the bridge that connects all communities in this island-state.

In the HWCWG's final report summarizing its findings and recommendations, the HWCWG recommended that the State Legislature pass a resolution directing the Hawaii Department of Transportation to convene working group(s) to create and recommend federal, state, and county subsidies for the transport of waterborne cargo. The working group found that due to Hawaii's dependency on the import of goods, maritime support to ensure food security in the State is required.<sup>3</sup>

YB is generally supportive of efforts to secure subsidies that can reduce the cost of shipping goods for its customers in ways that are consistent with State policy decisions. YB believes that such policy driven subsidies should be funded from external sources (e.g., federal funds or the State General Fund) rather than through cross-subsidization between YB's customers, which can lead to distorted non-cost-based rates for all customers.

For the reasons stated above, YB offers **STRONG SUPPORT** for this measure.

Thank you for your service to the State of Hawaii, and for the opportunity to testify offering comments on this measure.

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, manufacturers and distributors of food and beverage related products in the State of Hawaii.

HFIA is in support of this resolution. Increasing local food production and access is a critical priority for our state. However, Hawaii's unique geography poses significant challenges for local food producers, particularly the high costs of interisland transportation. These costs often hinder the ability of local farmers and producers to bring their goods to market efficiently and competitively.
