Comments:

All of South Maui traffic is channeled from Piilani Highway through a single ingress-egress to Veterans' Highway. Several hours each workday traffic barely moves because of commuting vehicles. If there is a fire or severe flooding, the choke point could be catastrophic. The many additional developments planned for South Maui will only add to the congestion. In particular, the Kihei Mauka master-planned development mauka of Piilani Promenade and the High School will likely include 1,500 homes and need a way to get both south and north to get to Central Maui. A Kihei Mauka Road is needed both for the traffic and safety of the Kihei Mauka development as well as to ease traffic on Piilani Highway. Important segments of the Kihei Mauka Road will be constructed by the developments it will pass through - Līpoa, Kihei Mauka and Hawaiian Homelands - but it cannot connect to Veterans' Highway without State planning and implementation.

Comments:

Please support the development of this critical life-saving road. South Maui is essentially a cul-de-sac. There are two roads that traverse most of the length of the area. One (S Kihei Road) is on the coastline. It is very old and annually is closed due to storms and mud floods. The other (Pi'ilani Highway) is bogged down with traffic that often backs up with long stoppages about a third of each day and when the coastal road is blocked, this main road is severely overwhelmed. It is practically a Parking Lot.

The situation is only going to get worse with more housing and development. In addition to over a 1,000 new luxury homes at the end of our 'cul-de-sac' in Wailea, there are plans for over a 1,000 homes planned in new neighborhoods near this mauka road. Developers would create piece meal sections of this road, which can be leveraged by state and county resources to complete the 'Kihei Mauka Connector Parkway'. This new road would provide an alternative route around the most congested sections of Kihei.
