TESTIMONY IN SUPPORT OF SB2603 SD1

Aloha Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Committee,

As Music and Artistic Director and President and CEO, respectively, of the Hawaii Symphony Orchestra, and we request your support of **SB2603 SD1**, which would designate the Hawai'i Symphony Orchestra as the State of Hawai'i Symphony Orchestra. This designation would ensure **equal access to world-class symphonic music for all residents, regardless of where they live.**

Music is not only entertainment; it helps mental health, physical health, brain development, and socialization. It teaches concentration, perseverance, listening, and working together. Music brings people together and uplifts our communities, and HSO is a community service provider.

Providing State designation is important for both HSO and our state for a number of reasons:

1. HSO Provides Significant Public Service to the State

HSO delivers meaningful public service through cultural, educational, and artistic programming. It enhances access to high-quality music and promotes cultural engagement across Hawai'i. We are proud of all we offer at HSO, such as:

- More than 40 diverse concerts annually
- Free community concerts
- Free education concerts including Symphony of the Hawai'i Seas
- Our Na Hoku Opio - Young Stars competition that showcases the talented young Hawai'i students
- Side-by-side projects with Hawai'i Youth Symphony
- A Masterworks Series that brings the world's best music and greatest artists to Hawai'i

Our HapaSymphony concerts that combine the talents of Hawai'i's most revered musicians including Keola Beamer, Jake Shimabukuro, and Raiatea Helm with the power of a full symphony orchestra

- Commissioning new works by living composers from around our Pacific region, embracing our geography as a Pacific orchestra
- Uniting the state's most important arts organizations under one umbrella in our groundbreaking Beethoven Festival and this year's Sounds of Shakespeare Festival
- The musicians are our greatest asset: We employ some of the United States' finest musicians to play in the HSO. They don't only play in the orchestra, though; they also play the vital role of educating our children
- Sharing live symphonic music that has been linked in numerous studies with vastly improved academic performance, better outcomes for young people, and increased social cohesion

2. HSO Has Deep Historical Roots in Hawai'i

HSO (formerly the Honolulu Symphony) was founded in **1902**, making it one of the oldest orchestras in the United States west of the Rockies. Its longevity reflects a century-long bond with Hawai'i's communities and cultural heritage. This long history includes surviving world wars, the Great Depression, and major financial crises — demonstrating resilience that mirrors the perseverance of Hawai'i itself.

3. HSO is a Vital Cultural Institution Delivering Essential Public Service

The orchestra's educational initiatives support thousands of children, addressing unequal distribution of arts education and improving academic and social outcomes through exposure to music.

4. It Reflects and Elevates Hawai'i's Cultural Identity

HSO works with both world-renowned guest artists and local musicians, promoting Hawai'i-based talent and fostering cultural collaborations that reflect Hawai'i's unique heritage. Our programming includes classical masterworks, film concerts, pops performances, Hawaiian collaborations, and more, showcasing the cultural diversity of the islands and enriching local artistic life – for residents and visitors alike.

5. It Supports Local Musicians and Strengthens Hawai'i's Creative Economy

HSO employs **85 professional musicians** and regularly commissions or collaborates with top-tier artists. This contributes to Hawai'i's creative economy and provides stable professional opportunities within the arts sector.

In Summary

Designating the Hawai'i Symphony Orchestra as the official State Orchestra of Hawai'i is supported by strong evidence that HSO:

- Serves the public good statewide
- Preserves and elevates Hawai'i's cultural identity
- Expands arts access and education
- Supports local professionals and the arts economy
- Has a 125-year historical legacy worth honoring

A **designated State Orchestra** would be a **cultural and economic asset**, supporting local jobs, driving tourism, and strengthening our communities through music.

The Hawaii Symphony Orchestra benefits the state and its residents far beyond subscribers and classical music fans. Its members, who rely on the HSO as a primary source of their livelihood, are the instructors for hundreds of keiki who are learning to play instruments. Without the HSO, many of them could not live here as professional musicians.

They provide the music for the Hawaii Opera Theatre and performances by the Hawaii Ballet Theatre. The HSO offers free community concerts at venues outside its homes at the Blaisdell and the Hawaii Theatre, and invites students into the concert halls for programs that enrich their lives through exposure to live orchestra music, in many cases for the first time.

Programs featuring top Hawaiian music performers and live music accompanying popular films extend the HSO's appeal to audiences not habitually drawn to orchestra concerts.

The high-quality programs of the HSO attract internationally known guest performers and inspire audiences consisting of both residents and visitors.

My wife and I are long-time subscribers and donors, and we know that the HSO relies heavily on community financial support and volunteers to supplement the income from ticket sales. Not long ago, the former Honolulu Symphony Orchestra faced a financial crisis and was forced to disband. It took a herculean effort by supporters and volunteers, both local and from the mainland, to revive the organization in its present form. Establishing official state support with this bill would help stabilize the HSO for future generations. Please pass it.

There is a strong, well-documented correlation between students who take music lessons—particularly instrumental/classical training—and higher academic achievement, *including better grades in math, science, and English.* Studies suggest these students are often academically ahead of their peers, with benefits stemming from improved cognitive skills and self-discipline .

Key details regarding the relationship:

- **Performance Gap:** Students involved in music education can be up to an academic year ahead of their non-musical peers in core subjects.
- **Instrumental Advantage:** The strongest correlation exists for students playing musical instruments, rather than just singing.
- **Brain Benefits:** *Learning an instrument develops skills in processing, organizing, and prioritizing information. It is also linked to neurological changes that improve cognitive functions.*
- **Transferable Skills:** *The dedication required to master an instrument translates into better academic discipline and study habits.*
