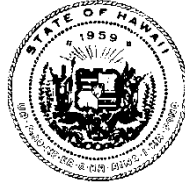

Honorable Chair Dela Cruz, Vice Chair Moriwaki and members of the Senate Committee on Ways and Means:

The Hawaii Public Housing Authority (HPHA) appreciates the intent of Senate Bill (SB) 3011, SD1 and offers comments. This measure requires the HPHA to allow any resident of a public housing project or State low-income housing project to keep one or more pet animals in the resident's unit, subject to applicable state laws, county ordinances, and any reasonable conditions. Provides that the HPHA may charge a refundable deposit for each pet animal but shall not impose a monthly pet fee or pet rent. Allows the HPHA to remove a vicious animal to protect persons or property.

HPHA currently manages over 5,400 federal low-income public housing units statewide. In these projects, HPHA already allows pets and has an established Pet Policy that tenants must follow. This policy was developed in consultation with the public housing Resident Advisory Board, reviewed through a public hearing process, and adopted by the HPHA's eleven Board of Directors after multiple opportunities for public input.

HPHA also manages 912 State low-income public housing units. Approximately 86% of this State low-income public housing inventory serves elderly and disabled residents. For these properties, HPHA has not implemented a general pet policy in order to preserve the quiet and peaceful enjoyment, safety and health of kupuna and residents with disabilities. This decision is informed by HPHA's operational experience in federal low-income public housing and includes concerns



such as smaller unit sizes, pets roaming common areas, injury to children and adult tenants, damage to units and common areas, increased maintenance and cleaning costs, liability risks related to pet-related injuries, and noise complaints that disproportionately affect elderly residents.

It is important to note that residents in both federal and state low-income public housing are already permitted to have pets needed for health or disability reasons through a Reasonable Accommodation Request, consistent with fair housing requirements.

HPHA also respectfully notes that many of its developments are large, high-density communities, with some properties exceeding 500 units and supports the bill's SD1 provisions for staffing resources and funding to support appropriate infrastructure and services, including but not limited to designated pet or animal parks, waste disposal stations, enforcement and education resources, and other measures necessary to protect animal welfare, tenant and staff well-being and safety, and State property. Without these additional resources, this measure would present operational, safety, and infrastructure challenges.

HPHA looks forward to working collaboratively with the Legislature to ensure that any statutory changes preserve the Authority's ability to establish reasonable conditions, address nuisance or dangerous behavior, protect residents and staff, and maintain safe, well-managed communities—while supporting the overall well-being of residents.

Thank you for the opportunity to provide comments and for your continued support of public housing residents statewide.

On behalf of the Hawaiian Humane Society, thank you for considering our support for Senate Bill 3011, SD1, which requires the Hawai'i Public Housing Authority to allow any resident of a public housing project or state low-income housing project to keep one or more pet animals in the resident's unit, subject to applicable state laws, county ordinances, and any reasonable conditions; provides that the Hawai'i Public Housing Authority may charge a refundable deposit for each pet animal but shall not impose a monthly pet fee or pet rent; and allows the Hawai'i Public Housing Authority to remove a vicious animal to protect persons or property; establishes positions; and appropriates funds.

Lack of access to pet-friendly housing is among the most common reasons that pet owners surrender their beloved family members to the care of animal shelters. In a 2024 survey of O'ahu households conducted by Ward Research, housing access topped the list of reasons residents had to surrender a pet to a shelter. Thirty percent of families who had surrendered a pet in the past five years said it was due to an inability to be housed with their pet.

For some this is unthinkable and they will stay in abusive relationships or chose to become or remain houseless rather than give up their pets. In collaboration with Partners in Care, the umbrella group of social service providers on O'ahu, we added a question regarding pet ownership to the annual Point in Time count in 2019. The results confirmed what our Outreach and Field Services teams see every day. Pet ownership is extremely important to houseless individuals and families. In the 2024 count, 29 percent of the unsheltered on O'ahu reported owning at least one pet.

Hawai'i residents should not have to choose between keeping their family intact or having a roof over their heads.

While public housing under the direct management of the Hawai'i Public Housing Authority allows pets, it does so under antiquated restrictions. This bill adopts the more progressive language of the California public housing statute, which prohibits restrictions based on breed or size; but allows those that account for the type of housing accommodation and the behavior of the animal. It also would require the HPHA inventory that is managed by private contractors to allow pets. This would open hundreds of additional units to pet owners as they become available.

We note the prior committee's allocation of generous funding and personnel to implement these changes. We hope that will not be a deterrent to its passage. Access to housing that welcomes pets is not a niche issue. Nearly 60 percent of O'ahu residents reported owning at least one pet in the 2024 Ward Research survey. The highest rates of pet ownership were in the more rural areas of the North Shore and West O'ahu, suggesting pet ownership rates on the neighbor islands are likely even higher. Housing paid for with tax dollars should welcome all of our local family members.

Please pass SB 3011, SD1, and open state and federally funded housing in Hawai'i to our most vulnerable families and their animal companions. Mahalo for your consideration.

Comments:

It is also good that the HPHA inventory which is managed by private contractors also allows companion animals, which would open hundreds of additional units to companion owner guardians as they become available.

Dear Chair Dela Cruz and Members of the Senate Ways and Means Committee:

The American Kennel Club (AKC) writes today on behalf of our 41 Hawai'i based kennel clubs and the many responsible dog owners in the state to respectfully ask you to support Senate Bill 3011, which would require the Hawai'i Public Housing Authority (HPHA) to permit residents of public housing and state low-income housing projects to keep pets in their units. This bill reflects thoughtful, balanced policymaking: it creates meaningful pathways for responsible pet owners to maintain their human-animal bonds without imposing mandates that would disrupt the broader private rental market.

SB 3011 is notable for what it does not do. It does not mandate pet-friendliness across the private rental market, impose rent controls, or limit a landlord's discretion in negotiating lease terms with private tenants. Its scope is deliberately and appropriately confined to HPHA-administered public housing — properties where the State already exercises direct oversight and where residents have limited alternatives. By drawing this careful boundary, the Legislature can address a genuine access gap without distorting market incentives for private housing providers.

The bill's provisions further demonstrate fiscal discipline. The HPHA may charge a refundable deposit for each pet to cover potential damage, ensuring that landlord costs remain internalized rather than subsidized. At the same time, the prohibition on monthly pet fees or pet rent prevents punitive fee structures that too often price responsible pet owners out of stable housing.

The human cost of pet-restrictive housing policies is well documented. For residents of public housing — many of whom are elderly, disabled, or experiencing housing insecurity — companion animals provide critical emotional support and companionship. **When housing policies force a choice between a pet and a home, the result is not only unnecessary animal shelter intake but also housing instability as residents are forced to make desperate decisions.** The AKC maintains that responsible pet ownership and stable housing are complementary goals. SB 3011 acts on this principle in a context where the State can set a meaningful example.

SB 3011 does not create an unqualified right to keep any animal under any circumstances. The bill expressly subjects pet-keeping to applicable state laws, county ordinances, and any reasonable conditions imposed by the HPHA. **Critically, it authorizes the HPHA to remove a vicious animal where necessary to protect the safety of other residents or the property.** These provisions ensure that housing managers retain meaningful authority to address problem situations while extending fair accommodation to responsible pet owners.

The American Kennel Club urges the Committee to pass Senate Bill 3011. It is the kind of measured, well-crafted legislation that advances animal welfare and housing equity without overreaching into the private market — a model that reflects the best of thoughtful public policy. We are also happy to provide information and insight on policies that can improve the overall state of Hawai'i's housing rental market for people with pets.

Honorable Chair and Members of the Senate Committee on Ways and Means,

I am writing as a private citizen in strong support of SB3011, SD1.

No one should have to choose between their pet and a roof over their head. Sadly, that is the reality for too many people in our community. For many residents of public housing, their pet is family, and a source of comfort and companionship. We know that individuals and families will refuse supportive housing rather than give up the pet that may be their closest companion. They would rather remain on the streets. Research from the Michelson Found Animals Pet-Inclusive Housing Initiative validates this. More than 80 percent of dog guardians surveyed reported difficulty securing housing, leading many to rehome their pets, misclassify them as emotional support animals, or hide them. Arbitrary barriers like breed and size restrictions force these impossible choices.

Policies that restrict pet ownership based on breed or size are not grounded in evidence. I am encouraged that this measure would require the Hawai'i Public Housing Authority (HPHA) to remove those restrictions from properties under its direct management, while still allowing for reasonable conditions that account for the type of housing and the behavior of the animal. California has already adopted similar language for its public housing, and Hawai'i should follow suit.

I am also pleased that this measure would extend pet-welcoming policies to HPHA inventory managed by private contractors, which could open hundreds of additional units to pet owners as they become available.

I respectfully urge the Committee to pass SB3011, SD1.

Aloha,

As both a private citizen and the president of the board of directors of Hawai'i Island Humane Society (HIHS), I have seen firsthand how many pet owners in our state have difficulty finding, and keeping, pet-friendly rentals, regardless of the size, breed, or good behavior of their companion animals.

Every year, the HIHS shelters in Kea'au and Hōlualoa take in many pets, either directly or via our county's Animal Control department, from people who reluctantly have to rehome them due to the loss of pet-accepting housing. I have also met people who have said they would love to adopt a pet from HIHS but can't, because they don't currently have pet-accepting accommodations. I believe that expanding the amount of available public housing that accepts pets, by removing breed and other restrictions, is an important step forward in preventing more animals from entering shelters statewide.

I'll note that when my husband and I were renting out our house in Waimea for several years, we rented to tenants with multiple animals with no incident or damage. People in public housing should also not be denied the emotional and physical benefits of animal companionship through unnecessary restrictions.
