My name is Emily Lundblad and I support the Hawaii Superferry. I believe the Superferry can work together with Hawaii resource managers, including the Humpback Whale National Marine Sanctuary (HWNMS) and others, to continue operations. The entire debate over the superferry has, in my opinion, been the largest awareness campaign that managers of the Humpback Whale's habitat have ever seen. Awareness is certainly heightened tremendously right now. I believe this is an opportunity for the state to work with all boat captains and resource managers to come up with a system that will benefit the economy as well as resource protection. The Superferry and other traffic should simply have seasonal speed limits within and/or restricted routes around HWNMS boundaries. If the state could agree that the EIS should be finished before the typical humpback whale migration season arrives, then the Superferry should be able to operate until that date. That being said, the whales will begin migrating within the next month or so; that leaves very little time. The Superferry should not begin operations without applying appropriate restrictions if their operations would begin at the same time that the whales tend to arrive. I work with seafloor mapping and have personally done preliminary research with whale sightings and their proximity to seafloor features.

I can tell you, with first hand knowledge, that scientists and state partners already have scientific data (publicly available state wide (w/ some gaps) undersea elevation models & a decade of whale sighting

information) that can contribute to a speedy turn around for determining where the whales would most likely "reside" during their seasonal stay around the Hawaiian Islands. Of course an official EIS would have to determine if these data are enough to make any conclusive decisions.

Dear Chairs Souki and Oshiro,

We have regularly visited the Hawaiian Islands several times over the last 15 years and, because of our love of the Islands, have invested in the Islands. We own and operate a condomimiun unit on the Garden Isle of Kauai, have been good and responsible neighbors, and have paid a large amount of taxes to Hawaii. We support the Hawaii Superferry and believe that HB 1 constitutes an appropriate and responsible response to the issues created by the prospect of the Superferry providing inter-island lines of commerce, transportation, and communication that have not previously been available.

Inter-island commerce is a critical component of Hawaiian economic development, and an alternative to the only current inter-island transportation, the airlines. Anybody who has spent any time on domestic airlines over the past few years knows that air travel in this country is challenged and unpredictable. When an alternative is available, it makes sense to explore it. The Hawaiian Superferry is such an alternative.

We have read that some of the opposition to the Superferry on Kauai is a fear that certain "undesireable" individuals might use it to relocate to Kauai and burden social services on the Garden Isle. Frankly, that strikes us as elitist and prejudiced. We encourage the Hawaiian legislature to reject such hysterical and unfounded arguments, and focus on the facts. Hawaii would benefit from improved inter-island commerce and the economic boost that arises whenever the lines of commerce are improved. The various islands are not separate entities, but components of one economy and government -- the State of Hawaii. Hawaii achieved greatness when Kamehameha I unified the islands. Separatism and fragmentation are nothing more than a step backwards and a surrender to the kind of parochial insulation that never benefits a society.

We understand that there are legitimate concerns over the environmental impact of the Superferry. However, those concerns are responsibily addressed in the proposed legislation. Hawaiian waters are already plowed on a regular basis by the United States military. The Superferry is unlikely to remotely approach the impact of the large vessels owned and operated by the military and should be given the same fair treatment as the United States Navy. It is difficult to understand why the Superferry is considered an environmental threat in certain quarters when the impact on the environment and Hawaiian lifestyle by the United States military far exceeds the scope and impact of this simple and necessary transportation accommodation.

What's fair is fair. The Superferry is good for Hawaii and for Hawaiians and should be given a chance to improve interisland commerce and help the Hawaiian Islands maintain their identity as a state and political entity, as opposed to a fragmented and balkanized state of confusion and the economic distress that always follows such fragmentation.

My name is Brad Canfield. As Hawai'i residents, my wife & I offer our enthusiastic testimony in strong favor of allowing the Hawai'i Superferry to begin immediate operations pending completion of the EIS.

We were excited to be taking our Harley Davidson motorcycle to Maui last month on the Hawai'i Superferry. An inter-island vehicle ferry is an idea we had dreamed about for many years. I first thought of the idea when Seaflight came to Hawai'i in the 1970's. It was unfortunate that they did not offer land vehicle transport. More on them later....

For our Maui trip on the superferry, we had booked a condo on the beach in Ka'ana'pali. We planned to shop in Lahaina, attend a luau, do some diving & ride our bike all over the island. We had to cancel all of that, & have lost room deposit money as a result. Many business' in Maui lost even more, as we never spent any money there.

We had purchased actually two sets of tickets. We originally booked at full fare, & then booked a second date at the reduced 5 dollar fare. Many of our friends were also planning to avail of this exciting new service, which would for the first time, connect all of Hawai'i's counties to personal land vehicles.

Many Kama'ainas are tired of the inconvenience of flying inter-island, & then having to rent a car. Many will just stay home like we did. No superferry = no trip!

We were shocked, but hardly surprised, when all the resistance ensued as the long-awaited ferry service began. Hawai'i has a tragic history of allowing special interest groups to impose their own twisted view of the world upon the rest of this. This has happened with our own business ambitions.

It is well-known that Hawai'i has an unfriendly business climate. Many foreign & mainland business' that would like to open shop in Hawai'i will not do so. They know that it is often not cost effective, & that there are many seen & unforeseen roadblocks that can spring up here in Hawai'i.

Come now the Hawai'i Superferry; a long-overdue addition to our limited inter-island transportation choices. Back in the 1970's, Seaflight offered waterborne transportation

My name is *William Stohler*. I strongly support Hawaii Superferry. The following are my comments regarding the current Superferry situation.

- 1. An EA was required for certain harbor improvements made using State funds. Of the \$40M in State funds used to 'improve' the harbors, ~\$37.5M went to barges, which are not harbor improvements. This only leaves ~\$2.5M that actually went towards harbor improvements. For 4 harbors, the improvements (along with the \$) were minor, included mostly striping, barricades and traffic control and had no impact on the environment.
- 2. The requirement for an EA was aimed at harbor improvments. Wheather or not the Superferry will harm anything has nothing to do with the requirement for an EA related to harbor improvements.

 3. I am strongly in favor of letting the SF operate during the EA phase. While I care deeply about the ocean, the humbpack whales, and the threat of invasive species, I firmly believe that the SF has planned to do more to prevent these problems than any other vessel using Hawaii's ports. Even the State's invasive species expert has testified that the SF will not make a significant impact on the interisland spread of invasive species.
