My name is Elizabeth A Baldwin. I am unable to testify in person but, as one of the many supporters of the Hawaii Superferry, I would like to add my voice to the many others in favor of allowing the Superferry to operate while an environmental impact statement is being conducted.

While many claims of the dangers posed by the Superferry on our ocean wildlife as well as the spread of invasive species are possible, it is more likely to occur with the unregulated and unsupervised operations of the various whale tours, fishing trawlers, and cruise ships. The Superferry has already taken many preventative steps in their Standard Operating Procedures to avoid harming the ocean wildlife and curtailing the spread of invasive species.

The Superferry has so many more positive aspects than negative that it is hard to understand the reluctance of the protesters on the islands of Maui and Kaua'i. It would greatly enhance our tourist attraction by making an affordable "mini-cruise" to the outer islands available for those unable to take a regular cruise. The economic gains for each island will increase with the constant movement of Superferry visitors by allowing them to visit and move through the islands instead of being "landed" on one island.

Maui has begun televising its Maui Minute commercials trying to attract visitors to events taking place on their island. How hypocritical is it to then be so unwelcoming to visitors coming via the Superferry? How much better could it be to welcome visitors using the Superferry for these events who leave to go home to the other islands without taking up extra airplane seats and cars so that regular visitors to the island are still able to get there and rent cars?

Kaua'i was devastated by Hurricane Iniki and has not fully recovered from its destruction yet. It is so sad to see the Coco Palms sit vacant. Kaua'i could use the Superferry to help boost its economy with visitors traveling though that beautiful island. It could stimulate the economy enough to rebuild the many businesses and hotels hurt by Iniki. When another hurricane strikes and the Superferry is gone, will these same protesters then ask the state why there is no help coming to them?

More importantly, it would be a boon to the state at a time when emergency response is needed. The ability to move throughout the islands bringing supplies, emergency workers and equipment, and food would be immeasurable. That point alone should make sense to approve the operating of the Superferry. With the effects of global warming causing unstable weather and a greater threat of hurricanes, it seems imperative that we have an alternative means of transportation for emergencies to aid air travel and barges.

Allowing the Superferry to operate while the environmental impact statement is being conducted is the best test of its ability to avoid harm to the environment and any peoples. It seems illogical to prevent the operation of

something that could be of great significance to the islands because of what "might happen". So many clinical trials for medicines that have cured people or prevented the spread of diseases could not have happened without first testing them on people. Let the Superferry run supervised so that it can prove its worth to our state that is now known as one of the unfriendliest to businesses.

The boat is not large enough to drive back to Oahu - especially with the trailer. I have cancelled the purchase of the boat because of the problems with the superferry - i had hoped to simply hitch it up and tow it home, and have the ferry available to tow it back when it needs its annual maintenance work.

I have negotiated the purchase of the same model boat from a dealer in Long Beach, CA since it would be cheaper to do so even considering the shipping to Hawaii. I was willing to eat the few hundred dollars difference to support a local dealer, but i cannot and will not swallow the additional shipping cost over the ferry's rates just to get the boat here to Kaneohe and then have to pay another \$1400 per year to ship the boat back and forth to Maui for servicing or service it at a non-dealer location... in which case i may as well just buy from the mainland.
