Thank you for the opportunity to testify in opposition to this measure. The purpose of this measure is permit the operation of an inter-island ferry service in the State of Hawaii while an environmental impact statement is being conducted.

The Maui County Council has not had the opportunity to take a formal position on this measure. Therefore, I am providing this testimony in my capacity as an individual member of the Maui County Council. However, Resolution No. 06-78, entitled "OPPOSING THE PROPOSED COMMENCEMENT OF SERVICE OF THE HAWAII SUPERFERRY AT KAHULUI HARBOR", the Maui County Council unanimously resolved that it opposed Superferry operations "pending update of the Harbor Master Plan, preparation of an Environmental Impact Statement pursuant to Hawaii Revised Statutes Chapter 343, and construction of necessary improvements to adequately accommodate current harbor users and the Hawaii Superferry". The Hawaii County Council and Kauai County Council adopted similar resolutions.

I continue to maintain that the State government should not allow the Superferry to commence operations without the benefit of an environmental assessment and a possible environmental impact statement.

Because the State Department of Transportation (DOT) had exempted the Superferry from the normal requirements of the Hawaii Environmental Protection Act (Chapter 343, Hawaii Revised Statutes), the public was excluded from participation in the environmental review process. Thus, the public meetings conducted by the Maui, Hawaii, and Kauai county councils provided the only opportunity for public comment to governmental bodies regarding the Superferry. In all three counties, the testimony was overwhelming in support of requiring normal environmental review for the Superferry.

In an order on August 23, 2007, and a written opinion on August 31, 2007, the Supreme Court of Hawaii unanimously found that the DOT should have considered the Superferry's potential environmental impacts, concluding that the failure to do so contradicted the Legislature's stated view that public participation in the environmental review process is critical.

Public participation in the environmental review process benefits all parties, including businesses. In fact, little would need to be considered at this point had the entities involved simply made a sincere effort to complete the required studies. Rather, the public observes negotiations among the offending parties behind closed doors.

The Superferry issue raises larger questions regarding the pace of growth in our communities and the perception that government favors the needs of the visitor industry, high-end developers, and other outside interests over the needs of hard-working local people. Our people have reached their limits, but our State administration seems unaware of the polarization and division that already exist within our neighbor island communities. The State administration's way of addressing this issue exacerbates the problem. If these issues continue to be ignored by the State government, we may see a social and political revolution of the same magnitude as the 1954 revolution that swept in a new generation of political leaders.

In conclusion, there was time for the State administration and the Superferry's promoters to do the studies necessary to adequately consider the public's concerns. Yet, they chose to rely on an exemption with a questionable legal basis. To excuse the State administration for such tactics would, in the long run, undermine respect for the Legislature as well as our laws.

Thank you for your consideration of my comments. I would be pleased to answer any questions you may have.

I wish to share my opinion of the superferry. I am not completely sold on the idea of having a superferry. I am familiar with a ferry system. I have travelled on many that operate in other states and foreign countries. I see both the good advantages and the bad in having one. I would like to make sure that we have the opportunity as tax payers and citizens of our great state to make an intelligent decision about what happens to our islands.

I am a native Hawaiian (known as Kanaka Mauoli.) I did have the opportunity to tour the Superferry in Kawaihae. The staff were not equipped to answer many of my questions. My family's most precious heiau is in the water at the base of Pu'u Kohola which is known as "Pelekane". I often go to pay my due diligence to my ancestors there. I have been quite troubled in recent months on the amount of pollution in the water and the shoreline there.

I know of a group of local young men and women who have been going on their own and cleaning up the coastline of Kawaihae. They have been raising monies through various odd jobs to help provide refreshments for the many volunteers who have been coming out to help. I have donated monies to provide them with safety equipment, gloves, trashbags, etc. The county and state government were sought out to offer assistance to these young people. To my surprise they haven't wrote back or called to offer any assistance. Yet the state has been quick to offer assistance to a private company to do major renovations to the harbors to allow a superferry to come in and capitalize on our residents. So my question is that there isn't any reassurances that more pollution will not be placed in the harbors or I would say our sacred sites and deplete our living cultural resources? What will be done to make sure this doesn't grow into a bigger problem?

We have already seen an incident with the maiden voyage to Honolulu from Maui. Where our lava rocks were loaded into pickup trucks, because they are no longer available on Oahu. The question I asked to the staff was-- is there going to be screening of items being transported between islands like agriculture, illegal goods, and cars that may possibly be stolen. The answer at first was "no" and when I asked the question about the resources or illegal items they couldn't give me an intelligent answer. When I grew up on Oahu and the big island as a child and till just a few years ago, there were many resources available to us. I no longer can take my mo'opunas to our fishing grounds, due to the illegal buoys being placed in the "ko'a's" (local native fishing grounds) because it is all fished out by the diving tours, we can't go into the forests and gather our la'au, there are fences and signs. No fruits available th at were plentiful that we could eat along the way. Now we have to pack lunch whereas, we use to live off the land when we went gathering or camping. We now have to pack our opala (trash) out when we do go to practice our culture because we need to pack it in. Other people tend to rape the forests and it is becoming harder and harder to find our la'au lapa'au (herbal medicines). The big island is the last of the islands to still have some of our resources.

I'm sure if every legislator would take a moment to think about what they did as a child here in the islands and see what their children have missed out on, I'm sure they would think twice about the decisions they are making. I am demanding an "EIS" not an 'EA" for this project or any other project that might devastate our island community. We need to know what perils are and how we can prevent it from happening. I wish our legislators could go to New York City and take a ride on the ferry out to Ellis Island and you will see what has happened there. I have a true little story to share...I have a

friend in New Jersey, whose grandfather use to fish on the shoreline more than 80 years ago and his last fishing line he placed in the water was about 15 years ago when he hooked up to a used tampon. Think about how many used tampons we'll be pulling up in the next few years. I hope I haven't offended anyone but, I feel we should seriously think about what we are doing. The Kanaka Council is in support of the views and also demands an EIS be completed on this issue.

Humpback Whales are wonderful creatures, and thankfully so, they are on a comeback, compared to the years when they were almost hunted to extinction. The number of the whales visiting Hawaii has been steadily increasing, and providing that large scale commercial hunting does not resume, their numbers will likely continue to increase. It is inevitable that more whales will be struck by vessels as time continues on, for their numbers are increasing, and there is more vessel traffic. But should this be the reason to stop human progress. The answer should be no. As long as companies take prudent measures to try to avoid collisions with whales, and act responsibly in the handling of their vessels, they should be allowed to operate in Hawaii waters, and not

singled out for unfair, overly harsh treatment, that no one else has been subjected to. The Hawaii Superferry has a detailed whale avoidance policy, much more that other companies. But even with all their measures, it will quite definitely occur with their operating that they will eventually hit a whale, but the same will likely be true for Norwegian Cruise Lines, and the Pacific Whale Foundation. In Alaska a few years ago, a dead whale was found hooked around the bow of a large cruise vessel. That incident did not cause the end of cruise vessels in Alaska waters. If the superferry is not allowed to operate out of whale concerns, then it would only be fair to ban cruise ships, and all other ferry and larger vessels in Hawaii waters. Yes, that would be a ridiculous thing to do, and it is ridiculous to object to the superferry out of whale concerns.

In regards to invasive species, if that had been a concern in this state, then cross contamination between the islands, and other locations, has already occurred. Vehicles have been transported for a long time inter-island on Young Brother's barges, and the vehicles have not been decontaminated (if there was ever any contamination at all). Foreign vessels come to Hawaii regularly, and likely have been emptying their bilge tanks around our islands. They may have been spreading contamination for years. None of these potential contaminators have been focused on; but wait, we must focus on the superferry, bahh. This issue is a prime example of the superferry being unfairly targeted.

The positives of a superferry system far outway any potential negative consequences. From my talking with many people about the superferry, I feel that a large majority of citizens, and voters, do want an inter-island ferry system, and do wish that the Hawaii Superferry succeeds, and stays a viable business. Hawaii should not miss this great opportunity. Please support the Hawaii Superferry, and pass legislation that undoes bad court decions, and allows the superferry to operate as a viable business in this state.

#### Aloha:

Like many people in Hawai`l, I've always considered my job to be a pleasant one. But the last few years it's become more and more difficult to be a nurseryman -- more and more of a headache and a worry. With increasing introduction of invasive species -- from coqui frog to fire ants that can painfully blind a pet, to giant, bionic mealy bugs and white fly -- having an IPM plant nursery has become a daunting challenge. (IPM uses principles of integrated pest management which means using the lowest, most judicious use of pesticides and herbicides, focusing on using nontoxic chemicals whenever possible). How much more daunting would it be if invasive species had yet another entry point to Hawai`i Island and my plant nursery?

Of course, that's just my selfish story of how Superferry could pose a serious threat to my personal livelihood. However, I know I'm not alone in my pursuit of a safe, green, low-impact, agricultural lifestyle, and that my worries about what Superferry can do to agriculture and the balance of natural ecosystems are widespread. My contribution to my community through my work is greater than the tax dollars I generate. I live in quiet harmony (usually) with my neighbors who also follow agricultural pursuits for at least part of their living. We make up a rural neighborhood in an increasingly bustling community, and the continuation of the ag lifestyle to us is very important for future generations to follow.

I'm now i'm also not alone in my broader concerns of how our Governor and other leaders could contemplate overriding a unanimous Supreme Court decision that insists that Superferry do a proper environmental assessment before it sets sail in Hawai`i's waters.

By not requiring superferry to follow the law, our State and the waters beyond its shores are at untold risk of being altered in ways that cannot be predicted without a proper environmental review.

The gravity and clarity of the protective law which Superferry must follow is that which led to the unanimous Supreme Court decision.

The proposed legislation which will apparently come before you today or tomorrow undermines environmental law and sets a treacherous precedent regarding the protection of corporate entities over the concerns of communities and their control over

their islands' natural, cultural, and social resources.

Indirectly, those who support this new law also support civil rights abuses by aligning with a corporate enterprise that, in order to be successful, not only requires a major, open-ended infusion of taxpayer money, but also requires the restriction of free speech, freedom of assembly, and public access to the shoreline by those who would disagree -- peacefully and lawfully -- with Superferry disobeying State law.

Mysteriously, Superferry has received more attention from Hawai i's governor and some legislators than homelessness, educational deficits, environmental degradation, widespread infrastructural overload, affordable health care, and foreign relations (a rigorously planned trip to south korea, japan and china canceled!). And yet it remains a mystery why some people seem so hell-bent on having a ferry service that few seem to need and even less had ever asked for.

My name is Steve Arakaki and I strongly support Hawaii Superferry.

Ever since my first trip to Seattle and Vancouver island with my parents, I've longed to be able to drive my car on Kauai, or Maui, or any of the other islands. We drive our car onto the ferry, and drove off to see the Butchart Gardens and the other sights in Victoria. Decades later, I made the same trip with my family, with an extra leg to Port Angeles. Still just as enjoyable.

Picking up a rental car on the neighbor islands is ok, but it's just not **your** car! The familiarity or your own vehicle eliminates the learning curve associated with rentals... Where are the lights, the wipers, etc. The Superferry is the embodiment of my desire to visit friends and relative on the other islands. We would pack a little differently, probably bringing more o-miyage on the way over, and more goodies on the return!

Even though I have friends working for the Superferry, I had the desire to keep up with all of the "goings-on" with the Superferry, but not the time. The only things I have heard and seen, are primarily negative, as one would expect. I guess it's human nature to emphasize the negative.

Based on the limited hearsay, third and fourth hand comments, these are my opinions. The big rub is with the EIS. I do believe that the Superferry should have done due diligence beforehand, and obtained guidance via the EIS. However, I have also heard that the State may have committed to "grease the skids" with this regard. Again, this is only what I have heard, but if this is the case, then fault does not lie solely with the Superferry. If this is true, then the Superferry should definitely be allowed to sail, perhaps with a somewhat reduced schedule, until the EIS is complete.

Traffic nightmares: The vehicular capacity of the Superferry is less than that of the various fleets in the Pacific Northwest. There many companies running multiple vessels in that market. I didn't see even the slightest hint of localized gridlock with the vehicular embarking /

Now because of the ruling by a single rogue judge I am not able to get to work indefinitely. There are no other transportation options for people in wheelchairs on the island of Maui.

To the Hawaii State House of Representatives:

Yes, dear legislators, do the math. If 282 cars show up to sail from Oahu to Kauai, it would take a total of 23.5 hours to perform even a five minute inspection of each vehicle and its contents if one person were doing it. If 23 1/2 persons were doing it ( we must not discriminate for 1/2 Persons who might be employed by HSF), it would still take one hour just to give each potential vehicle a five minute inspection.

As an organic farmer who has a beautiful flock of free-range laying hens and as a Kilauea resident who lives 4 miles from the Kilauea Point National Wildlife Refuge, I do not trust the controls set in place by the HSF in preventing invasive species. I doubt there would be much chance of catching a pregnant mongoose or a potted plant full of fire ant eggs with such poor inspection procedures. These are two of the invasive species which pose a serious threat to our ground nesting endangered birds such as albatross, nene, and shearwater. Not to mention our laying hens. Have you ever seen fire ants attack a newborn gosling?

And one pregnant mongoose can produce upwards of 18 babies per year. Now these female babies will reach sexual maturity in a ten weeks, and then, they, too, can reproduce. Do the math!! Kaua'i has no mongoose.

Taxonomic name: Herpestes javanicus (E. Geoffroy Saint-Hilaire, 1818) Common names: beji (Bengali), Kleiner Mungo (German), mangouste (French), mangus (Hindi), mweyba (Burmese), newla (Hindi-India), small Indian mongoose (English)

**Organism type:** mammal

**General impacts** 

Predator of birds, small mammals and reptiles. Ground nesting birds are at risk especially. Impact on invertebrates not known. Many snakes and iguanas are at risk from mongooses. Also is a vector of rabies, and causes economic loss to game species and poultry industry.

**Notes** 

Mongooses threaten endemic species on tropical cane growing islands. They have caused the population demise or extinction of many endemic vertebrates, continue to cause livestock damage and pose a disease risk.

The small Indian mongoose is gregarious and diurnal, and live in small burrows.

They occupy small home ranges of 0.8-1.6 km in diameter. They breed 2-3 times a year. Their young are usually weaned in 4-5 weeks, and females can breed as early as 10 weeks old. Males can produce sperm at four months old, but usually do not breed until the following spring.
