Dear Chairs Souki and Oshiro:

My name is Peter W. Cannon and I very very strongly support the Hawaii Superferry.

Hawaii desperately needs additional methods for moving people, vehicles and products between the islands of our state. The attached email from Young Brothers will make this point very clear.

My business, Hawaiian Resources Co. Ltd., strongly supports the Superferry and all 15 of our employees agree that they support this alternative method of transportation.

I just within this hour sent earlier personal testimony in support of the Superferry. Since then an email has arrived from Young Brothers that will reinforce the point that business and individuals need alternative methods for moving cargo and automobiles between the islands.

Please read the attached announcement from Young Brothers. It announces that from now on, all cargo going to Kauai will only be received in by Young Brothers on two days of the week (Monday and Thursday) and for only three and a half hours per day. All cargo for Lanai can only be shipped on one different day of the week (Wednesday) and for only three hours of that day.

Have any of you ever sat in line to send interisland cargo out on Young Brothers? Do you realize how many hours of your day is wasted by sitting in these lines? Are you aware of the calibre of "service" that a customer receives when dealing with Young Brothers? By limiting the days and times, these lines will only be longer.


So now if a shipper has cargo for Maui, Lanai and Kauai this means that we must go and sit in these lines on three different days of the week instead of making a drop off and standing in a Young Brothers line only one time for all islands. Look at the time wasted and the number of times a week that a shipper has to send trucks on to the roads and into traffic to sit in lines and deal only with Young Brothers.

Young Brothers desperately needs some competition for cargo between the islands for them to clean up their service act. Businesses in Hawaii desperately need some alternatives to dealing with Young Brothers. Interisland freight competition is desperately needed.

Please. please, please support the Superferry and set the parameters for her to sail profitably between the islands.

Dear Chairs Souki and Oshiro:

My name is Stuart Oda and I am a practicing attorney here in Hilo, Hawaii, and I strongly support Hawaii Superferry.

I have read and listened to almost all of the arguments both pro and con on the superferry issue. Most of the opposition appears to be highly emotional arguments that do not really address the key question of whether the legislature has the authority to pass any legislation to permit the superferry to operate before the environmental assessment is completed. I am not an expert on environmental laws. However, I believe that the legislature does have the authority to pass legislation to permit the sailing while the assessment is ongoing.

The arguments regarding invasive species and harm to marine animals are interesting but not very convincing. Every marine vessel sailing between the islands has the potential of harming marine animals by its very existence and every means of transport between the islands has the same ability or potential of transporting invasive species between the islands. The superferry is no different.

There appears to be a hidden agenda by the opponents to stop the superferry in its tracks. They do state that they are not against the superferry per se, but merely seek compliance with the law. That may not be the true reason for their opposition.

I have visited San Francisco, New York, Seattle and British Columbia, and was impressed with the ferry system in those areas, especially in San Francisco and British Columbia where automobiles are permitted on the ferries together with passengers. I remember asking msyelf why Hawaii doesn't have something like that.

I do hope that the legislature will find just cause to permit the superferry to operate while the assessment is ongoing because I believe it is in the public's best interest to do so.

My testimony is to point out the following 3 separate items.

I. The administration's bill is immoral, unethical and probably illegal.

For those of you intend to vote for the administration's cynical bill to bypass the court system, you should be reminded that your vote would be in violation of the Hawaii State constitution which is modeled after the US constitution. Your vote would, in fact, support the administration's effort to get around the separation of powers between the 3 branches of the Hawaii government and would relegate the court system to an inferior and secondary role to the other two branches. Your vote in favor of the administrations bill would be immoral, unethical and illegal.

I realize that you believe that the majority of Hawaii's citizens - who live in Honolulu - favor the Superferry and could care less about things like the separation of powers and the supposed equality of the 3 branches of government. They are far more interested in temporarily escaping Honolulu, visiting their families on the outer islands, etc.

You may also believe that getting around restrictions on the Superferry would improve the climate for big business investing in Hawaii. You are probably correct in that all big business will have to do is make big payoffs to the right politicians and the laws will be bent in their favor.

You may also believe that the proposed law to get around the court decisions is just plain clever. I agree - but I respectfully ask you to consider that the concept of the separation of powers between the 3 branches is far more important than the small number of jobs gained by your catering to a single corrupt company like HSF -or even to a legitimate company.

Your passing this outrageous and cynical legislation would go a long way into turning Hawaii into a full-fledged banana republic.

And finally, I have been told that, if the administration manages to get this cynical bill passed, there will be all kinds of legal challenges and the accompanying publicity will make Hawaii look more and more like a banana republic - and those of you who vote for this legislation will be held at fault

Superferry is different than any other vessel that has ever sailed in Hawaiian waters

Several people testified at the Kailoa-Kona meeting that it was discriminatory to require the Superfery to do an Environmental assessment and to not require an environmental assessment from cruise ships, vessels run by Young Brothers, etc. These people do not realize that the Superferry is an entirely different type of vessel than any that has ever sailed before in Hawaiian waters and should be treated as such because of its two bows and extremely high speed. The Superferry is a far greater threat to whales and other marine mammals than cruise ships, freighters, etc

III. Fast ferries - like the Superferry - have already killed lots of whales.

A lady testified at the Kailua-Kona meeting that she had done research and could find no evidence that fast ferries had ever killed a whale.

This is totally wrong. Fast ferries have killed lots of whales and there is eye-witness evidence to prove it.

A. From a paper by Panigada, et al. published in 2006 about fin whales killed by fast ferries in the Mediterranean sea:

"High speed ferries were introduced into the area in 1996. In the six years following that period they accounted for almost 50% of the total collisions."

B. From a paper by Weinrich submitted to the International Whaling Comision in 2004.

24 collisions were witnessed during a 10 year period. 11 of these were with fast ferries.

- C. <u>Many collisions were witnessed in the waters between Japan and Korea between Jet-foils and whales.</u> Jet foils are lighter and even faster than the Superferry: Collisions with whales have lead to injuries and death to both whales and passengers and lots of newspaper articles.
- D. After the Introduction of fast ferries to the Canary Islands in 1989, death and strandings of sperm whales went up drastically. There were no witnesses but lots of bloody corpses at the water's edge.

I can provide detailed evidence on the above 4 items.

My name is Kanoa Taylor from Waikapu Maui and I strongly support Hawaii Superferry.

I was born and raised on Maui and started my professional maritime career on the waters surrounding Maui. I left for the mainland partially because of the competition for the small number of quality, decent paying, local maritime jobs. The Hawaii Superferry has provided me with the opportunity to return home after 9 years on the mainland. This job is a good job with advancement possibilities that stay locally in the islands allowing me to be close to friends and family.

I believe the Hawaii Superferry is being held to a standard that has not applied to the other inter-island transportation systems. As a crew member of the on board marine staff I can state that the HSV Alakai is the most environmentally friendly vessel I have served on.

I also would like to remind everybody that the vessel is at all times being navigated by 2 licenced officers. These officers along with their lookouts are professionals. They are charged with safely navigating the Alakai through the water and take this seriously. Although I am not an officer on this ship, I have been on many others including high speed catamarans. Any object animal, vessel, or otherwise detected ahead of any vessel is tracked by all available means including visual and instrument tracking to determine if there is risk of collision. If it is determined that there may be risk of collision the crew will usually slow down and make a course change

until the risk has passed.

Everybody seems to focus on the ferry's speed but its strength is in its maneuverability and ability to quickly change course slow down, stop. You will not find another vessel of comparable size traversing hawaiian waters that can match the ferrys maneuverability.

I am not against the environmental process but to be fair it needs to be applied equally across the board not to just one company. This ferry poses no greater risk than the many other vessels foreign and domestic that sail through hawaiian waters.

Please let the ferry sail while the review process is conducted.

We on crew of the Alakai have and will continue to operate in a safe, environmentally conscious manner.
