#### To Whom It May Concern:

I support the bill that will permit interisland ferry service in Hawai'i while an environmental impact statement is being conducted. Aside from the recreational benefit to be had from being able to travel by sea between islands, I firmly believe that ferry service would be a tremendous benefit for all those in the islands who work or conduct business on more than one island.

My husband and I came to Oahu 23 years ago, bought a home, had 2 daughters and each started our own business. Mine is a sole proprietorship, which I began in 1994, doing child development training for agencies in the State of Hawaii's Healthy Start Program on Oahu, Maui, Molokai and the Big Island. I made a career change several years later and now do graphic design and illustration.

The Hawaii SuperFerry would have been an ideal way for me to travel to the outer islands with my training materials. I was unable to bring heavy or bulky items such as flip charts, overhead projectors, VCR's and items for display due to size and weight limits of air travel. I want to emphasize that many outer island agencies did not have the equipment I needed, or it was not working when I showed up to train their staff. This made conducting a professional training more of an adventure than I would have liked. Furthermore, the Healthy Start program, like others that struggle to operate with funding that changes from year to year, was unable to pay for rental cars for their trainers, so each agency had to transport me to and from the airport. Bringing my own equipment and materials in my own car would have made my job so much easier.

As for the environmental impact of the SuperFerry, I am reminded of a similar situation where I grew up on the mainland on the Rogue River in Southern Oregon. The pristine Rogue River is one of the original eight rivers in the United States designated by Congress as Wild and Scenic, and there was a similar outcry from a minority of residents who believed the new commercial jetboat tours from Grants Pass to the Oregon Coast would harm wildlife due to their speed, and create too much noise for those living along the river. Eventually, the jetboats were allowed to operate, and they do respect the requests of residents along the river who request that the boats slow their speed in front of their properties. There are no whales in the Rogue River, but plenty of salmon, ducks and other wildlife, which have not been harmed by the specially designed jetboats (no propellors), which skim the water and are able to operate in just a few inches of water.

I believe it is important to stop assigning blame to any particular group for the current predicament of the SuperFerry and to focus on working out a win-win situation for all involved. As with most relationships, each side has contributed something to the problem, and one would hope that the two sides can compromise so that the peoples of these islands do not lose this opportunity. I, for one, would be willing to ride the SuperFerry without my vehicle until the environmental impact statement is finalized. I support alternate routes and slower speeds during whale season to ease the fears of those who believe sea creatures would be harmed. I also support inspections of vehicles and their contents to prevent transfer of unwanted critters and things from island to island. Aloha, House Legislators!

Please allow Superferry to operate while you do and environmental review.

It's time to get to work and fix the laws that are in conflict or unclear regarding the issues surrounding the Superferry and other inter-island commercial carriers, including aircraft.

I see no protection for the Big Island to keep infected bees from coming on board aircraft in cargo holds or elsewhere and getting to the Big Island, decimating our honey and Queen Bee production. There should be a new state law and environmental assessments statewide of all carriers which could and have spread invasive species among the islands and from around the world.

Our native Gecko is being pushed out by the invasive Madagascar Green Gecko. The Superferry did not bring it here. Miconia did not get to our island via the Superferry. The fire coral now in Kawaihae Harbor did not come here with the Superferry, in fact the Superferry by design and material will not bring invasive species interisland attached to its hull, as all the slower barges and other vessels do, either attached to their hulls or in their ballast holds. The Crown of Thorns, a powerful, invasive starfish we now see when diving the coral reefs around Kawaihae, was not brought here by the Superferry, nor would it have. The tiny wasp from China that has decimated the Wiliwili trees was not brought here by Superferry.

While on the subject, check out the lax or non-existent rules on cargo or invasive species on anything shipped with Young Brothers, Matson, or the car carriers. There is no cargo inspection of these inter-island containers or ships, as long as the paperwork is in order and the shipment is paid for.

This is my problem with the way Superferry has been singled out. No other carrier even comes close to the inspection level or requirements that Superferry has self imposed. The persons who wanted to take rocks from Maui back to Honolulu, were not able to. Why? Inspection for invasive species and the regulations independently enforced by Superferry. Yet here is no such law on the books. I can go to Maui today and load my van with rocks and plants and ship the van to Oahu with Matson or Young Brothers, no questions asked.

Fix what is broken. Let the Superferry operate while an environmental assessment is done. Then you can run a parallel assessment with the other modes of transportation which have proven over and over, year after year, to cause cross contamination of our environment on these fragile islands.

We need better controls against all invasive species, by all carriers.

Please get to work and do it right this time, and get the Superferry running, to benefit all with additional commerce, and revenue for the state as a whole.

Dear Chairs Rep. Joseph Souki and Rep. Marcus Oshiro:

My name is Gary Li and I strongly support Hawaii Superferry. I want to see the SuperFerry operate as soon as possible, and visit any ports and islands that the company wants.

It is my belief that the SuperFerry is a completely new seafaring technology that will revolutionize inter-island travel. I understand that it is fast, efficient, does not use propellers, and lets ordinary folks and their personal vehicles move from county to county without stressful security screenings and delays. I also strongly believe that small businesses, skilled trades (carpenters, plumbers, contractors), and the military will benefit the most from the service.

I refer to the article "Legislators push for ferry probe" published in the Oct. 14th 2007 edition of the Honolulu Advertiser: "Maui Circuit Judge Joseph Cardoza dismissed the [Sierra Club, Maui Tomorrow and Kahului Harbor Coalition] complaint on July 12, 2005, ruling the groups did not have standing in the case. The state also argued the court should defer to the DOT's judgment since proper procedures were followed in determining the harbor projects qualified for an exemption, and Cardoza agreed the exemption was in compliance with Chapter 343." Later in the same article: "Cardoza heard four

weeks of tesimony during the hearing, which ended Tuesday [Oct. 9] when the judge ruled that Chapter 343 clearly requires an environmental review before a project can proceed." The court transcript of that October 9th ruling does not show why Judge Cardoza ruled differently on the same law. Perhaps it had something to do with the first case dealing only with Kahului Harbor improvements, and the second hearing dealt with the environmental review.

However as far as I am concerned, the flip-flopping by His Honor is due to the fact that the law is vague on ferry operations. Prior to the HSF, I understand that Sea Flite during the mid-1970s was the only Hawaii ferry system. The SuperFerry is not only a new technology, it is also a new and unproven (in Hawaii) vessel. The Segway Human Transporter was a new technology as well, and in 2002 Hawaii law was amended to regulate it. Like the Transporter, I firmly believe that a new section of the law must be crafted to address the SuperFerry's operations and ensure safety of passengers, the crew, vehicles, and persons/objects outside the craft in the environment.

I support the bill as is, as long as there are enough oversight and accountability to protect the environment. A few representatives from environmental groups on the board would be acceptable. Still, I feel that most of those claims that the ship will destroy the environment and harm whales to be alarmist and based on ignorance of the vessel and its technology. I hope that you representatives and elected officials will not allow the uncivilized behavior of a minority stop something that has a huge potential to benefit everyone. Please pass HB1 Relating To Transportation to allow the Hawaii SuperFerry to operate during an environmental impact statement. Also consider allowing it to run while any recommended harbor improvements or changes are constructed.
