When I heard that the Superferry was coming to town, I was literally elated as I knew <u>not only could my</u> <u>son travel by means of his very own wheelchair, but we could also take our wheelchair access van with</u> <u>us</u>. I do not know of any wheel chair accessed van that we can rent on any of the outer islands. I simply want my family to enjoy a family trip just like any other family and for us and other families like us, the Superferry is the ONLY answer for us and it allows us the freedom to travel. I do not want to continue to deny my children the chance to explore outside of Oahu and with Superferry, we can take them somewhere else to experience.

With all the various types of boats and ships that come into our harbors on a daily basis makes me wonder why Superferry is being singled out like this. Yes while it is true that an EIS could have been done long ago if it was 100% required of Superferry, a lot of these naysayers could have spoken up long ago as well and voice their concerns and demanded an EIS long ago. My name is Lynn Keahi and I strongly support Hawaii Superferry.

I support such an endeavor in that I believe alternative transportaion, such as the Super Ferry, could enhance our economy in many ways. The obvious one is that it will provide another option and means of transportation for consumers and perhaps maintain inter-island transportation at more reasonable rates. Providing the consumer options on how they wish to travel is empowering, and is great for inter-island commerce. I'm certain that vendors may be afforded greater options in the transportation of goods and services as well; with fuel expenses and taxes escalting, it is great for businesses to be afforded options on various means of tranportation that will allow commerce to thrive and, ultimately, benefit the consumer. In reference to the environment, I believe it is most necessary to stop invasive species at the borders - the legislature (federal and state) should first consider funding to enhance our ability to search and destroy invasive species at the point of entry. I believe the existing traffic will spread invasive species even over time, and there is no way of putting a halt to this unless funding is allocated to our borders and the current programs to erdicate are maintained. Additionally, why is so much emphasis put on saving the whales, since when did humans come second to animals and the environment? Granted, our natural resources need to be maintained, and legislation for this bill should make every effort to address this; but to terminate Super Ferry services to save whales that are part-time residents in our waters is ridiculous. Which brings me to part-time / "transfer" residents, who I believe have an overwhelming influence on how we "full-timers" operate here in the islands. Bottom line, change happens and we cannot maintain the Hawai`i of yesteryear when the potential for progress for the overall well-being of the majority is at stake. I'm tired of hearing part-time Maui residents from the mainland tell me what is ideal here in Hawai`i - I live here, I raise my family here, I intend to purchase a 2nd home with my husband for our family and increase our leverage in real estate, I intend to educate my children here and raise them to be responsible citizens, I give back to my community and help to teach our family/children to do the same, I am a part of this community full time, I pay taxes and I want the services entitled to its citizens to be distributed fairly. I'm tired of hearing mainlanders dictate how our lifestyles should be set. When they establish themselves here for a few generations (not just their lifetime), then I'll give consideration for their input. These part-timers make statements and shift our economy in so many ways, and yet their real interest here is maintained briefly; whereas, mine and so many other "fulltimers" have been here for generations and even hundreds of years. We're the voices that should be heeded, as we're impacted the greatest. Addressing the issue of kanaka maoli, I am one and I support the sovereignty movement as I see it as a political and moral (and not racial) issue. I believe that this endeavor will serve the population as a whole and will not adversely impact progress for self-determination/etc; rather, it would enhance our endeavors by providing another means to acquaint ourselves with one another and the islands we call home. Further, I don't believe that sacred sites or cultural practices will be inhibited by the operation of the Super Ferry - I fail to see and understand the logic. Finally, the economic impact of the Super Ferry and the time loss during this period is detrimental to our economy with the exhobetant amounts of monies due to investors/etc. I believe legislation should be enacted to afford the Ferry to run to at least meet these obligations. I wish that I had been notified and had personally been sent fliers in support of the Superferry BEFORE the Senate hearing/meeting in Kona tomorrow. I would have gladly contributed to mass marketing and advertising efforts, also with serious effort to get business owners to support the Superferry's progression into regular multiple-island service.

I honestly think that someone in sales needs to do some ground pounding and consider strategic marketing alternatives in efforts to improve community relations and contact local business owners for "commercial discounts", as well as implementing a booklet type series, even for a short term like 3 round trip runs for a set discounted price.

As I am from a very successful corporate family of auto dealerships in CA and my grandfather was Vice President of General Motors in the '30s, I can truly appreciate successful marketing strategies that concern transportation access through more simplified means than the current restraints in the transportation industry, an already heavily monopolized transportation industry that leaves little room for legitimate competitive American spirit of a capitalist democracy, dare I say fascism that I have also adversely experienced with regard to disregard to personal protections by legal professionals in Hawaii County. I believe that certain legal failures of Hawaii County have adversely impacted my life WAY more than any vessel possibly could! Shame on the failures to protect my rights here, as well as my safety! I think the issue of "illegal uses of residential zones as commercial contractor activities continue in my neighborhood" all because of "red tape" has a DRASTICALLY MUCH more adverse impact on my and others' environments and lives than any vessel! I think this issue to be much more important than a means of transportation being debated for "environmental purposes"...and what about barking dogs, noise and light pollution from bad neighbors where local law enforcement has not only "blatantly refused" to address these violations, as much as playing games to downgrade their "adverse environmental DIRECT impacts on our lives"? I'm sorry, but to me these are issues that more directly affect residents' environments than the mere passage of a ship!

Understandably there are those who see things differently, and generally they cry out to others before looking at their own lives...and the negative environmental impact they make, namely the corruption of law that prevents justice and fair opportunity for all, by those existing failures to adherence to the laws that are ALREADY ON THE BOOKS, but STILL FAIL TO BE UPHELD, yes, even in writing from HI County DAs! So tell me where the law HAS to be upheld on this environmental vessel impact??? If the county here cant even uphold their own laws, why should anyone be subjected to ANY legal restraint?!!!

I would be happy to work out some sort of compensation in terms of "sales" if you might consider a short term sales contract. Until Matson can start providing regular passenger service as they once did so many years ago, I don't think that any opposition that they might have should come into play, although I would value some of the experience of previous passenger operators. If cruise ships with deeper drafts obviously have been allowed, then I see no reason why the Superferry should be restrained by law, especially if previous environmental impact studies have already been done recently...what legal restraint prevents "existing studies" to be included?

Facilitating those contacts might be an avenue to be considered, especially if Matson has already done an "Environmental Impact Statement" and especially if the same routes you are considering that are currently in use by Matson have ALREADY HAD an impact statement, and/or something similar that might be used, as it has "already been accepted" in the courts(?). If you want to talk about "environmental impact", ask someone whether or not they think that humans have been adversely impacted as a direct result of the delay! I think many business owners would agree that they have been adversely impacted by the failures in potential business that could have otherwise produced more business already.

Just a few suggestions:

Offer business owners "special rates" if they are conducting business in other counties, namely on Oahu.

Contact hotel/resort sales offices and produce a list of hotels willing to provide special/kama'aina rates to local Superferry travelers, especially if they are frequented more than once/month

Offer one free ticket to every business owner who sells 10 tickets locally...don't just make tickets available in strict locations...get the communities and even schools involved! Candy sales at schools?

And how about credit for the school children who directly participate in the industry, either through entertainment or other means of support...for every 10 tickets they sell, a free ticket or two for parents/relatives?

Host free social/informational events on all 3 islands where a lucky winner or two wins a ticket, t-shirts and other advertising paraphernalia...mugs, photos, special on-board appearances by big names...another contract potential! I think my family still has contacts for professional football players...I would have to contact my brother or one of our managers...Brent Jones, Steve Young...just a few names from the past...I suggest a call to Alex Spanos (Stockton, CA) and get some Republican support! You might even considering include service routes for private parties on special occasion...I would also try tapping into the CA travel industry..."3 islands in 3 days with rental car/camper van"???
