Dear Representatives Souki and Oshiro:

I am writing in support of legislation that would permit the Superferry to operate while the State prepares an Environmental Impact Statement. I have read the proposed Bill and support it.

I have also read the 29 conditions proposed by Isaac Hall. I find them reprehensible and arrogant. Many of the conditions violate personal privacy rights. Many suggest that the right of free movement by individuals should be restricted. I support none of the conditions.

What I find worst of all is that Hall has singled out one business for "super screening" while other businesses that have created problems of invasive species go totally unchecked and have for years. The coqui frog and the stinging caterpillar did not arrive on Maui via the Superferry. Neither did the many alien species plants. Those arrived by the uninspected containers brought to Maui by Young Brothers. Which brings to mind a huge question as to the real motivation of Maui Tomorrow, Sierra Club,etal.

The whale issue has been blow out of proportion. We all want to protect the whales. However, the impact of whale watching boats to the whales is a greater threat than the Superferry. I have read several scientific studies by NOA and those reveal a high incident of damage to whales by whale watching craft. Coast Guard records in Alaska show no whale strikes by ferries and over a period of four years only one whale strike and that was by a cruise ship! Our whales reside in this area of Alaska most of the year!

Superferry already has a reasonable plan for protecting the whales.

For your information, I have prepared a chart, which makes a comparison between Superferry and other Maui harbor users. While simple, it does address many of the issues. I did this research on my own and spoke directly with various departments.

The Superferry organization did what it was directed to do. It was told that no EIS was necessary. Now, a legitimate business providing a legitimate service to the people of Hawaii has been stopped, for no fault of their own. The Court has seen fit to make a different interpretation of the law and now, the Legislature, exercising its power of checks and balances, has an opportunity to right that wrong.

Superferry has made good rules to protect the environment. I urge you to support good corporate

behavior and allow the Superferry to start this much-needed service.

By the way, I did not attend the local hearing held on Maui. I have attended many of the hearings and found that the behavior of the Superferry opponents to be rude and intimidating to any speaker expressing support. The last meeting held here by Senator English and Tsutsui was the worst.

I urge you to pass this proposed legislation without modification. Allow the Superferry to begin operation while the EIS proceeds. To do anything less, or to place burdensome conditions, would be unfair.

### Whale Strikes

Investigating whale strikes in Alaska in Juneau area, where there are a large number of ferries operating, I spoke with Lt. Jensen (808) 873-3104/873-3105 of the US Coast Guard Station Maui. Lt Jensen spent four years (2001-2005) based with Coast Guard in Juneau, Alaska. Humpback whales feed in this area most of the year. He inspected ferries including the high-speed ferry. Ferries used prudent navigation, which included an observer on the bridge watching for debris and marine mammals. Lt Jensen reported that during those four years there was <u>no report</u> of marine mammal strikes by ferries. There was one report of a cruise ship striking a whale.

### **More Alien Species Stuff**

Carol Okata at Dept of Agriculture advised that vehicles arriving in Kahului Harbor on Matson and CSX are inspected as time permits. Young Brothers vehicle cargo is not subject to any inspection. DOA is currently preparing a risk assessment study for all the harbors in the state including Kahului.

In spite of the testimony against the Superferry at the special hearings, it is clear that the majority of us in Hawaii are in favor of giving the Ferry a chance to operate successfully. The groups opposed to the Ferry that you have heard from are generally anti any progress and change. That is a sure path to disaster for us. We must innovate and change or be left behind as a second or third class community. A good point is made by Angela Chinen in the Oct. 24 morning Advertiser, Island Voices commentary. The State and the Super Ferry management went ahead after two judges had agreed that an EIS was not needed. Then the Supreme Court than took two years to decide to disagree. We simply can't function with these types of delays in government and judicial decision making. The Hawaii Environmental law, HRS C. 343 permits government agencies to specify exemptions to the requirement for an EIS. It is my understanding that the exemption previously granted for harbor improvements covered the kind of improvements made for the Superferry, and two judges apparently agreed. For rational individuals that should be enough assurance to proceed.

Another point. In spite of its size, the Ferry would most likely be seriously damaged if it hit a whale going at high speed. I am sure that this will further motivate the Ferry owners to operate carefully in the presence of whales, and I believe that is all we can ask.

I find it interesting, that almost all of the people testifying against the the Superferry are asking the State to deny only the Superferry operation in the state of Hawaii, and not the other shipping and airline companies that have introduced 99% of all the invasive species, etc. to all of the islands in the past. Concerning traffic, it will certainly increase at the harbors, but it will also alleviate a substantial amount of traffic at the airports. Wouldn't that be nice! Whales, not a problem. The ferry has stated that it would travel at a reduced speed when in whale calving areas. Today 360 degree sonar and radar systems would almost eliminate any chance of a whale collision. My name is Frederic Berg and I strongly support Hawaii Superferry.

I find it unfortunate that our Supreme Court had to support the Environmentalists position by creating a new precedent rather than ruling in line with previous precedent, however that is how our democracy works, therefore we now need to make the necessary changes in the Legislature to allow the will of the people to prevail. (My understanding is that 60 - 90% of the people of the State of Hawaii want to see the Superferry operate and most of those do not want to wait for an EIS process either for philosophical reasons or for fear of loosing the Superferry because of its debt service.)
