Our 3rd child is severely mentally and physically handicapped and is wheelchair bound. He cannot sit unassisted in a regular airplane chair, his muscles don't allow him to sit up. He needs his wheelchair. A trip to the mainland or anywhere else is out of the question for our son and therefore, we have not gone anywhere from the time he outgrew his car seat 3 years ago.

When I heard that the Superferry was coming to town, I was literally elated as I knew <u>not only could</u> <u>my son travel by means of his very own wheelchair, but we could also take our wheelchair access van with us.</u> I do not know of any wheel chair accessed van that we can rent on any of the outer islands. I simply want my family to enjoy a family trip just like any other family and for us and other families like us, the Superferry is the ONLY answer for us and it allows us the freedom to travel. I do not want to continue to deny my children the chance to explore outside of Oahu and with Superferry, we can take them somewhere else to experience.

With all the various types of boats and ships that come into our harbors on a daily basis makes me wonder why Superferry is being singled out like this. Yes while it is true that an EIS could have been done long ago if it was 100% required of Superferry, a lot of these naysayers could have spoken up long ago as well and voice their concerns and demanded an EIS long ago. We all saw when the ferry was being built, we saw it nearly done, we saw it when it was leaving Alabama, we saw it as it passed through the Panama Canal and as it sailed through the Pacific Ocean. All the while I did not hear of one single protester calling out for an EIS.

I love these islands just as much as the naysayers. I was born and raised here and have lived here all my 41 years. If I thought something was not good for this state and the land and the ocean, I would be hesitant. I lived at Honolulu Tower for 5 years and looked out at the Honolulu Harbor every day. I saw huge ships, sailing boats and vehicles of all sizes come and go. Why the Superferry is being singled out like this is beyond me. It frustrates me that the minority of the state is getting so much attention and voice while the rest of us, the majority, seem to have had no say at all.

Give the Superferry a chance!

## **PROPONENT OF THE HAWAII**

# **SUPERFERRY**

Submitted for October 29, 2007 House public hearing. Was personally read October 24, 2007 Wednesday as testimony before the Hawaii State Senate and personally read October 25, 2007, Thursday as testimony before House of Representatives at the State Capitol.

Good morning, honorable members of the legislature and of the audience. My name is Christie Wagner: C-H-R-I-S-T-I-E W-A-G-N-E-R. I'm a proponent of the Hawaii Superferry.

There are several objections that opponents to the Superferry have voiced. I'd like to address just a few objections and do so briefly.

# **#1 WHALES**

They want to ban the Superferry because it might run over humpback whales. Sound travels faster in the water than it does through air and it travels faster in sea water than it does in fresh water or distilled water. And the warmer the water, and the greater the salinity, the faster the sound travels. For example, in a 77-degree Fahrenheit ocean, sound travels at approximately 1,531 meters per second, which is 5,023 feet per second which is 3,425 miles per hour. Believe me, the whales in most cases would hear the ferry long before it reached them.

Will the ferry ever run over a whale? Probably. But ban the ferry because it

**might**. But please also have PASHA HAWAII TRANSPORT LINES cease immediate operation, as well as MATSON, YOUNG, HORIZON and CSX. Also ban all cruise lines, large fishing boats, and all vessels of the the United States Navy and the United States Coast Guard. While you're at it, ban all automobile traffic forever throughout the state of Hawaii because sometimes cars strike and kill dogs, cats, rare birds--and, oh, yes, our greatest Hawaiian natural resource: people.

# **#2 INVASIVE SPECIES**

Among the invasive predators opponents mention that they're afraid the SuperFerry is going to bring, is the MONGOOSE. Now mongeese are not marine animals. They live in burrows in habitats of high grassland and bush thickets. The poor things are deathly afraid of people and run from people. How on earth are mongeese going to get to Kauai and other islands? Will they stow away surreptitiously and

undetected in someone's luggage or will they stand in line to buy Superferry tickets?

Opponents mention the coqui frog. The cocqui frog was introduced into Hawaii from Puerto Rico in 1986. But, if you're going to ban the Superferry for fear of exporting the coqui, then please let's also get to the root of the problem and ban all Puerto Ricanos forevermore from visiting Hawaii.

As for plant invasive species, if you're going to ban the Superferry, please ban from interisland travel all children who have been playing outside and people like plant pathologists, farmers, botanists, and agriculture inspection officials because they might have plant seed or spore residue on their shoe soles and/or clothing.

# **#3: CRIME AND DRUGS**

The opponents of the Superferry, especially our neighbors on Kauai, cite that Superferry will bring crime and drugs to them. One ludicrous posting on an anti-Superferry website states that people could load stolen goods onto the Superferry faster than the homeowner would realize it's lost. This implies 2 things. One, it implies that passengers from Oahu are all potential criminals. It also implies that the neighbor islands have no crime. Well, on August 31st of this year \$5.9 million dollars of marijuana were seized on Kauai in the largest eradication ever done on public land in the history of the United States. As of September 6th, also in 2007, Kauai police were still looking for a serial killer murdering women on the North Shore of Kauai. With only about 60,000 people living on the Garden Isle, I'd say they contribute per capital more than their fair share of crime. And that's not including the number of Kauaians arrested and incarcerated on Oahu. My point is that some people are inciting interisland hostility and that's not nice.

If you're going to ban the Superferry then please pass a one-way ban of travel from Kauai to Oahu, because with more population to victimize and more material goods, maybe the people of Oahu should fear the people of Kauai.

# #4: TRAFFIC

The neighbor islands, especially Kauai, complain that they already have traffic jams and that Superferry passengers are going to create more congestion. Well, some of the passengers might be Kaui residents coming to Oahu to visit family and friends. Should they never be allowed to return home? As for traffic congestion on neighbor islands, I have two words: one is "carpool" and the other is "bicycle".

**#5: MARINE DIESEL FUEL** 

And last, we get to the problem of fuel from the ferry polluting the ocean because it's unavoidable for fuel to get released into the ocean when any ship travels. Accordingly let's ban the Superferry. But also ban all other sources of fuel emission into the ocean.

If you're going to ban the Superferry please ban all of the following which also use fuel to power them and ban them permanently:

- (1) NOAA's--the National Oceanic and Atmospheric Administration's-- ships and airplanes, including both manned and unmanned vessels, which they use to track hurricanes and tsunamis with.
- (2) ALL COMMERCIAL CRUISE LINES because their fuel pollutes the ocean;
- (3) ALL COMMERCIAL AIRLINE FLIGHTS--especially the inter-island Aloha and Hawaiian Airlines-because, among other things, they sometimes need to dump fuel into the ocean to decrease their weight before landing; Also their "con trails"-- i.e., condensation vapors--liquefy and dump Skydrol jet fuel into the ocean. Furthermore they drop their toilet facility deposits into the air.
- (4) ALL MILITARY FLIGHTS-and that includes the Navy's Blue Angels and the Air Force's Thunderbirds.
- (5) ANGEL FLIGHT and all hospital airlifts, whether civilian or military, into Oahu
- (6) ALL PLEASURE BOATS and FISHING BOATS because they leak fuel and oil into the ocean plus they empty their toilet facilities into the ocean.
- (7) SWIMMERS AND DIVERS, BOTH RECREATIONAL AND PROFESSIONAL. Especially ban all of the 7 million annual visitors to Oahu from swimming in our oceans because they will tinkle--that is, chi chi--into the ocean and that will deposit ammonia and other toxic chemicals into our waters.

Seriously, full speed ahead and godspeed to the Hawaii Super Ferry. I respectfully conclude my testimony.

Marine operations
